## PROPOSED AMENDMENTS TO HOUSE BILL 2800

- On page 1 of the printed bill, delete lines 24 and 25.
- On page 2, delete lines 1 through 16 and insert:
- 3 "(3) For the purpose of financing the Interstate 5 bridge replacement
- 4 project, the State Treasurer may not have outstanding, at any one time,
- 5 bonds in an amount exceeding \$450 million of net proceeds, plus an amount
- 6 determined by the State Treasurer to pay estimated bond-related costs of is-
- 7 suance, for the purpose of funding Oregon's share of the aggregated contri-
- 8 bution to the project from Oregon and the State of Washington as described
- 9 in the Final Environmental Impact Statement submitted to the United States
- Government for the project. It is the intent of the Legislative Assembly that
- moneys from the United States Government or toll revenues be used to di-

- 21 for a proposed full funding grant agreement application; and

- 1 project's Final Environmental Impact Statement published on September 11,
- 2 2011 and endorsed by the Federal Transit Administration and the Federal
- 3 Highway Administration in the record of decision dated December 7, 2011;
- 4 "(b) The United States Department of Transportation has submitted a full
- 5 funding grant agreement application, in an amount of at least \$850 million
- of Federal Transit Administration funds, for congressional review;
- 7 "(c) The State Treasurer has participated in and approved the findings
- 8 of an investment grade analysis of toll revenues associated with the project's
- 9 application for a loan from the Federal Highway Administration's Transpor-
- tation Infrastructure Finance and Innovation Act program, and provided for
- ongoing financial analysis of the project;
- "(d) The State Treasurer has reviewed and approved a comprehensive fi-
- 13 nancing plan for the project, after making written findings that there are
- sources of funds committed by contract or law or otherwise obligated that
- are reasonably expected to be available and that will provide sufficient cash
- 16 flows to pay the estimated costs of the initial phase of the project described
- in the full funding grant agreement without revenues from borrowings in
- addition to those described in subsection (3) of this section; and".

- On pag 5, line 34, after "purposes" insert ", except that moneys otherwise
- 23 pledged or dedicated may be used for a subordinate lien if allowed by law

- On page 9, line 35, after "more" insert ", that steel, iron, coatings for
- 26 steel and iron or manufactured products are not produced in the United
- 27 States in sufficient and reasonable quantities and with satisfactory quality
- 28 to meet the requirement".

- In line 11, after the period delete the rest of the line and line 12 and in-

- 19 "(2) The Oregon Transportation Commission shall conduct studies
- 20 and develop recommendations on each of the following:

- 22 or other public health concerns that may impact the communities
- 23 along the Interstate 5 corridor from the Fremont Bridge to the
- 24 Columbia River.
