

**PROPOSED AMENDMENTS TO  
HOUSE BILL 2828**

1 On page 1 of the printed bill, line 2, after the first semicolon delete the  
2 rest of the line and line 3 and insert “and declaring an emergency.”.

3 Delete lines 5 through 30 and delete pages 2 through 11 and insert:

4 **“SECTION 1. (1) The Department of State Police shall convene a**  
5 **work group to develop recommendations for the retention of finger-**  
6 **print information by the department, for the purpose of notifying au-**  
7 **thorized agencies or other entities that conduct criminal records**  
8 **checks under ORS 181.533, 181.534, 181.537 or 267.237 when the depart-**  
9 **ment receives forms containing a person’s fingerprints or other iden-**  
10 **tifying information under ORS 181.511 or for any other purpose related**  
11 **to the administration of criminal justice.**

12 **“(2) The work group must include representatives of:**

13 **“(a) The Department of Corrections;**

14 **“(b) The Department of Education;**

15 **“(c) The Department of Human Services;**

16 **“(d) The Department of Public Safety Standards and Training;**

17 **“(e) The Department of State Police;**

18 **“(f) The Employment Department;**

19 **“(g) The Oregon Department of Administrative Services;**

20 **“(h) The Oregon State Board of Nursing;**

21 **“(i) An agency that licenses individuals;**

22 **“(j) A human services organization;**

1       “(k) An association of school employees;

2       “(L) A local government; and

3       “(m) An organization that advocates for the privacy rights of indi-  
4       viduals.

5       “(3) The Department of State Police may include additional mem-  
6       bers in the work group at its discretion.

7       “(4) In developing its recommendations, the work group shall con-  
8       sider:

9       “(a) Protecting the public;

10       “(b) Maintaining high standards of safety and accuracy;

11       “(c) Ensuring a timely process;

12       “(d) The feasibility of transferring criminal records checks among  
13       agencies and entities;

14       “(e) The feasibility of updating criminal records checks when cer-  
15       tain events occur; and

16       “(f) Mandating agency and entity participation or providing for  
17       subscription to the services described in subsection (1) of this section.

18       “(5) The Department of State Police shall report the work group’s  
19       recommendations to an interim committee of the Legislative Assembly  
20       related to consumer protection and government efficiency on or before  
21       November 1, 2013.

22       “SECTION 2. Section 1 of this 2013 Act is repealed on the date of  
23       the convening of the 2014 regular session of the Legislative Assembly  
24       as specified in ORS 171.010.

25       “SECTION 3. This 2013 Act being necessary for the immediate  
26       preservation of the public peace, health and safety, an emergency is  
27       declared to exist, and this 2013 Act takes effect on its passage.”.
