

**PROPOSED AMENDMENTS TO
HOUSE BILL 2121**

1 On page 1 of the printed bill, line 2, delete “and”.

2 In line 3, delete “809.210” and insert “807.060 and section 2, chapter 9,
3 Oregon Laws 2012; repealing sections 3 and 6, chapter 9, Oregon Laws 2012;
4 and declaring an emergency”.

5 Delete lines 5 through 31 and delete page 2 and insert:

6 **“SECTION 1.** Section 2, chapter 9, Oregon Laws 2012, is amended to read:

7 **“Sec. 2.** (1) A person who has been convicted of driving while under the
8 influence of intoxicants under ORS 813.010 shall provide proof to the De-
9 partment of Transportation that the person completed a treatment program
10 to which the person was referred under ORS 813.021.

11 *“(2) [Except as provided in subsection (3) of this section,] The department*
12 *may not reinstate a person’s driving privileges unless:*

13 **“(a)** The person has provided proof of completing a treatment program
14 as required under subsection (1) of this section[.];

15 **“(b) The person has an order from the circuit court of the county**
16 **in which the person was convicted that the person has taken sufficient**
17 **steps to satisfy the requirement under ORS 813.021 to complete a**
18 **treatment program; or**

19 **“(c) Fifteen years have elapsed since the date of the person’s con-**
20 **viction for driving while under the influence of intoxicants.**

21 *“[(3) The department may waive the requirement for a person described in*
22 *subsection (1) of this section to provide proof upon a showing of good cause.*

1 *The department shall by rule prescribe the criteria for determining what con-*
2 *stitutes good cause.]*

3 **“(3)(a) If the person is unable to provide proof of completing a**
4 **treatment program as required under subsection (1) of this section, the**
5 **person may file a motion with the circuit court of the county in which**
6 **the person was convicted to show proof that the person has taken**
7 **sufficient steps to satisfy the requirement under ORS 813.021 to com-**
8 **plete a treatment program. The person shall provide a copy of the**
9 **motion and any supporting documentation to the district attorney of**
10 **the county. The district attorney may file, within 45 days from the**
11 **date the person files the motion with the court, an objection to the**
12 **motion.**

13 **“(b) If the district attorney does not file an objection to the motion,**
14 **the court shall, without hearing, enter an order that the person has**
15 **taken sufficient steps to satisfy the requirement under ORS 813.021 to**
16 **complete a treatment program or, on its own motion, conduct a**
17 **hearing as described in subsection (4) of this section.**

18 **“(c) Upon timely receipt of an objection from the district attorney,**
19 **the court shall conduct a hearing.**

20 **“(4) At a hearing under subsection (3) of this section, the court**
21 **shall determine whether, considering the totality of the circum-**
22 **stances, the person has taken sufficient steps such that in the court’s**
23 **view the person has satisfied the requirement under ORS 813.021 to**
24 **complete a treatment program.**

25 **“(5) If the court determines that the person has taken sufficient**
26 **steps to satisfy the requirement under ORS 813.021 to complete a**
27 **treatment program, the court shall enter an order that the person has**
28 **taken sufficient steps to satisfy the requirement under ORS 813.021 to**
29 **complete a treatment program.**

30 **“(6) When the court enters an order under this section, the court**

1 **shall provide a copy of the order to the district attorney.**

2 **“(7) A court may not enter an order that the person has taken**
3 **sufficient steps to satisfy the requirement under ORS 813.021 to com-**
4 **plete a treatment program if the person has not started a treatment**
5 **program.**

6 **“SECTION 2.** ORS 807.060, as amended by section 4, chapter 9, Oregon
7 Laws 2012, is amended to read:

8 “807.060. The Department of Transportation may not grant driving privi-
9 leges to a person under a license if the person is not eligible under this
10 section. The following are not eligible for a license:

11 “(1) A person under 16 years of age.

12 “(2)(a) A person under 18 years of age who is not an emancipated minor
13 unless the application of the person is signed by the person’s mother, father
14 or legal guardian. A person who signs an application under this paragraph
15 may have the driving privileges canceled as provided under ORS 809.320.

16 “(b) A person under 18 years of age who does not meet the requirements
17 of ORS 807.065.

18 “(3) Notwithstanding subsection (2) of this section, a person under 18
19 years of age is not eligible for a commercial driver license.

20 “(4) A person that the department determines has a problem condition
21 involving alcohol, inhalants or controlled substances as described under ORS
22 813.040.

23 “(5) A person the department reasonably believes has a mental or physical
24 condition or impairment that affects the person’s ability to safely operate a
25 motor vehicle upon the highways.

26 “(6) A person the department reasonably believes is unable to understand
27 highway signs that warn, regulate or direct traffic.

28 “(7) A person who is required to make future responsibility filings but
29 has not made filings as required.

30 “(8) A person who cannot be issued a license under the Driver License

1 Compact under ORS 802.540.

2 “(9) A person who is not subject to the Driver License Compact under
3 ORS 802.540 but whose driving privileges are currently under suspension or
4 revocation in any other state upon grounds which, if committed in this state,
5 would be grounds for the suspension or revocation of the driving privileges
6 of the person.

7 “(10) A person who has been declared a habitual offender under ORS
8 809.640. A person declared not eligible to be licensed under this subsection
9 may become eligible by having eligibility restored under ORS 809.640.

10 “(11) A person whose driving privileges are canceled in this state under
11 ORS 809.310 until the person is eligible under ORS 809.310.

12 “(12) A person while the person’s driving privileges are revoked in this
13 state.

14 “(13) A person during a period when the person’s driving privileges are
15 suspended in this state.

16 “(14) A person who holds a current out-of-state license or driver permit
17 or a valid Oregon license or driver permit. A person who is not eligible un-
18 der this subsection may become eligible by surrendering the license, driver
19 permit or out-of-state license or driver permit to the department before is-
20 suance of the license. Nothing in this subsection authorizes a person to
21 continue to operate a motor vehicle on the basis of an out-of-state license
22 or permit if the person is required by ORS 807.062 to obtain an Oregon li-
23 cense or permit.

24 “(15) A person who has not complied with the requirements and respon-
25 sibilities created by citation for or conviction of a traffic offense in another
26 jurisdiction if an agreement under ORS 802.530 authorizes the department to
27 withhold issuance of a license.

28 “(16) A person who has not complied with the [*requirements*] **require-**
29 **ment** of section 2 (1), chapter 9, Oregon Laws 2012.

30 “**SECTION 3.** ORS 807.060, as amended by sections 4 and 5, chapter 9,

1 Oregon Laws 2012, is amended to read:

2 “807.060. The Department of Transportation may not grant driving privi-
3 leges to a person under a license if the person is not eligible under this
4 section. The following are not eligible for a license:

5 “(1) A person under 16 years of age.

6 “(2)(a) A person under 18 years of age who is not an emancipated minor
7 unless the application of the person is signed by the person’s mother, father
8 or legal guardian. A person who signs an application under this paragraph
9 may have the driving privileges canceled as provided under ORS 809.320.

10 “(b) A person under 18 years of age who does not meet the requirements
11 of ORS 807.065.

12 “(3) Notwithstanding subsection (2) of this section, a person under 18
13 years of age is not eligible for a commercial driver license.

14 “(4) A person that the department determines has a problem condition
15 involving alcohol, inhalants or controlled substances as described under ORS
16 813.040.

17 “(5) A person the department reasonably believes has a mental or physical
18 condition or impairment that affects the person’s ability to safely operate a
19 motor vehicle upon the highways.

20 “(6) A person the department reasonably believes is unable to understand
21 highway signs that warn, regulate or direct traffic.

22 “(7) A person who is required to make future responsibility filings but

4 “(11) A person whose driving privileges are canceled in this state under
5 ORS 809.310 until the person is eligible under ORS 809.310.

6 “(12) A person while the person’s driving privileges are revoked in this
7 state.

8 “(13) A person during a period when the person’s driving privileges are
9 suspended in this state.

10 “(14) A person who holds a current out-of-state license or driver permit
11 or a valid Oregon license or driver permit. A person who is not eligible un-
12 der this subsection may become eligible by surrendering the license, driver
13 permit or out-of-state license or driver permit to the department before is-
14 suance of the license. Nothing in this subsection authorizes a person to
15 continue to operate a motor vehicle on the basis of an out-of-state license
16 or permit if the person is required by ORS 807.062 to obtain an Oregon li-
17 cense or permit.

18 “(15) A person who has not complied with the requirements and respon-
19 sibilities created by citation for or conviction of a traffic offense in another
20 jurisdiction if an agreement under ORS 802.530 authorizes the department to
21 withhold issuance of a license.

22 **“(16) A person who has not complied with the requirement of sec-**
23 **tion 2 (1), chapter 9, Oregon Laws 2012.**

24 **“SECTION 4. Sections 3 and 6, chapter 9, Oregon Laws 2012, are**
25 **repealed.**

26 **“SECTION 5. The amendments to ORS 807.060 and section 2, chapter**
27 **9, Oregon Laws 2012, by sections 1 to 3 of this 2013 Act and the repeal**
28 **of sections 3 and 6, chapter 9, Oregon Laws 2012, by section 4 of this**
29 **2013 Act apply to convictions occurring before, on or after the effective**
30 **date of this 2013 Act.**

1 **SECTION 6. This 2013 Act being necessary for the immediate**
2 **preservation of the public peace, health and safety, an emergency is**
3 **declared to exist, and this 2013 Act takes effect on its passage.”.**
