

**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2501**

1 In line 2 of the printed A-engrossed bill, delete “amending” and insert
2 “creating new provisions; amending ORS 327.355 and”.

3 In line 3, delete the first “and” and after “2011’ insert “, and section 21,
4 chapter 718, Oregon Laws 2011”.

5 After line 13, insert:

6 **“SECTION 3.** ORS 327.355 is amended to read:

7 “327.355. As used in this section and ORS 327.357:

8 **“(1) ‘Adjusted average daily membership’ means the average daily**
9 **membership of a high school plus the average daily membership of**
10 **nonresident students attending the high school as a result of:**

11 **“(a) Receiving consent from district school boards, as described in**
12 **ORS 339.133 (5)(a);**

13 **“(b) Being admitted under a contract entered into between district**
14 **school boards, as provided by ORS 339.125;**

15 **“(c) Paying tuition as a nonresident person, as allowed by ORS**
16 **339.115; or**

17 **“(d) Receiving consent from the district school board for the school**
18 **district in which the high school is located, as provided by section 9,**
19 **chapter 718, Oregon Laws 2011.**

20 **“[(1)(a)] (2)(a) ‘Small high school’ means a public school that is operated**
21 **by a small school district and that has students in:**

22 **“(A) Grades 9 through 12, with an ADM of less than 350 in grades 9**

1 through 12; or

2 “(B) Grades 10 through 12 only, with an ADM of less than 267.

3 “(b) ‘Small high school’ does not include:

4 “(A) An alternative education program or a public charter school[.]; **or**

5 “(B) **A high school that is within eight miles by the nearest traveled**
6 **road from another high school unless:**

7 “(i) **There are physiographic conditions that make transportation**
8 **to the other high school not feasible; or**

9 “(ii) **The high school has an adjusted average daily membership of**
10 **less than 175.**

11 “[2)] (3) ‘Small school district’ means a school district with a weighted
12 average daily membership (ADMw) of less than 8,500.

13 **“SECTION 4. The amendments to ORS 327.355 by section 3 of this**
14 **2013 Act apply to State School Fund distributions commencing with**
15 **the 2013-2014 school year distributions.**

16 **“SECTION 5.** ORS 327.355, as amended by section 3 of this 2013 Act, is
17 amended to read:

18 “327.355. As used in this section and ORS 327.357:

19 “(1) ‘Adjusted average daily membership’ means the average daily mem-
20 bership of a high school plus the average daily membership of nonresident
21 students attending the high school as a result of:

22 “(a) Receiving consent from district school boards, as described in ORS
23 339.133 (5)(a);

24 “(b) Being admitted under a contract entered into between district school
25 boards, as provided by ORS 339.125; **or**

26 “(c) Paying tuition as a nonresident person, as allowed by ORS
27 339.115.[; or]

28 “[d) *Receiving consent from the district school board for the school district*
29 *in which the high school is located, as provided by section 9, chapter 718,*
30 *Oregon Laws 2011.*]

1 “(2)(a) ‘Small high school’ means a public school that is operated by a
2 small school district and that has students in:

3 “(A) Grades 9 through 12, with an ADM of less than 350 in grades 9
4 through 12; or

5 “(B) Grades 10 through 12 only, with an ADM of less than 267.

6 “(b) ‘Small high school’ does not include:

7 “(A) An alternative education program or a public charter school; or

8 “(B) A high school that is within eight miles by the nearest traveled road
9 from another high school unless:

10 “(i) There are physiographic conditions that make transportation to the
11 other high school not feasible; or

12 “(ii) The high school has an adjusted average daily membership of less
13 than 175.

14 “(3) ‘Small school district’ means a school district with a weighted aver-
15 age daily membership (ADMw) of less than 8,500.

16 “**SECTION 6.** Section 21, chapter 718, Oregon Laws 2011, is amended to
17 read:

18 “**Sec. 21. (1)** Section 9 [*of this 2011 Act*], **chapter 718, Oregon Laws**
19 **2011**, is repealed on July 1, 2017.

20 “**(2) The amendments to ORS 327.355 by section 5 of this 2013 Act**
21 **become operative on July 1, 2017.**”.

22 In line 14, delete “3” and insert “7”.
