- "(g) Represents that real estate, goods or services are of a particular 3 standard, quality, or grade, or that real estate or goods are of a particular 4 style or model, if [they] the real estate, goods or services are of another. 5
- "(h) Disparages the real estate, goods, services, property or business of a 6 customer or another by false or misleading representations of fact. 7
- "(i) Advertises real estate, goods or services with intent not to provide 8 [them] the real estate, goods or services as advertised, or with intent not to supply reasonably expectable public demand, unless the advertisement discloses a limitation of quantity.
- "(j) Makes false or misleading representations of fact concerning the 12 reasons for, existence of, or amounts of price reductions. 13
  - "(k) Makes false or misleading representations concerning credit availability or the nature of the transaction or obligation incurred.
  - "(L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demonstration purposes or in exchange for submitting names of potential customers.
  - "(m) Performs service on or dismantles any goods or real estate [when not authorized by] if the owner or apparent owner [thereof] of the goods or real estate does not authorize the service or dismantling.
  - "(n) Solicits potential customers by telephone or door to door as a seller unless the person provides the information required under ORS 646.611.
  - "(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, discount or other value is contingent upon [occurrence

- of] an event [subsequent to] occurring after the time the customer enters into the transaction.
- "(p) Makes any false or misleading statement about a prize, contest or promotion used to publicize a product, business or service.
- "(q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver [them] the real estate, goods or services as promised.
- 8 "(r) Organizes or induces or attempts to induce membership in a pyramid 9 club.
