PROPOSED AMENDMENTS TO A-ENGROSSED HOUSE BILL 3159

1 On page 2 of the printed A-engrossed bill, delete lines 34 through 45.

2 On page 3, delete lines 1 through 26 and insert:

"SECTION 3. (1) Each county may establish the maximum rates 3 that a tower may charge for towing a motor vehicle, and all related 4 services for towing a motor vehicle, in response to a request for towing $\mathbf{5}$ of a vehicle parked within the county that is made by a person other 6 than the owner or operator of the motor vehicle. The rates for related 7 services include charges for hookup, storage, gas mileage, pictures, 8 unlocking the motor vehicle and any other services reasonably related 9 to towing as determined by the county. Rates established by a county 10 under this subsection apply in all portions of the county except within 11 the boundaries of cities with a population of 15,000 or more located 12within the county. 13

"(2) If a county does not establish the maximum rates that a tower 14 may charge for towing a motor vehicle under subsection (1) of this 15section, a city that is within the county and that has a population of 16 less than 15,000 may establish the maximum rates that a tower may 17 charge for towing a motor vehicle, and all related services for towing 18 a motor vehicle, in response to a request for towing of a vehicle parked 19 within the boundaries of the city that is made by a person other than 20the owner or operator of the motor vehicle. The rates for related ser-21vices include charges for hookup, storage, gas mileage, pictures, un-22

locking the motor vehicle and any other services reasonably related
 to towing as determined by the city.

"(3) Each city with a population of 15,000 or more shall establish the 3 maximum rates that a tower may charge for towing a motor vehicle, 4 and all related services for towing a motor vehicle, in response to a $\mathbf{5}$ request for towing of a vehicle parked within the boundaries of the 6 city that is made by a person other than the owner or operator of the 7 motor vehicle. The rates for related services include charges for 8 hookup, storage, gas mileage, pictures, unlocking the motor vehicle 9 and any other services reasonably related to towing as determined by 10 the city. 11

"(4) When establishing the maximum rates under this section, the city or county shall take into consideration the size of the motor vehicle towed and the distance traveled by the tower from the location of the motor vehicle to a storage facility.

"(5) Each city or county that establishes maximum rates under this
 section shall also establish a process by which the city or county will
 receive and respond to complaints relating to violations of this section.
 "SECTION 4. (1) Subject to subsection (5) of this section:

"(a) A tower may not tow vehicles parked within the boundaries of
a city without a license issued by the city, if the city has established
the maximum rates that a tower may charge under section 3 of this
2013 Act.

"(b) A tower may not tow vehicles parked within the boundaries of a county, outside of a city with a population of 15,000 or more, without a license issued by the county, if the county has established the maximum rates that a tower may charge under section 3 of this 2013 Act. "(2) Application for a license under this section must be made in writing in the form prescribed by the city or county, and must contain the name and address of the applicant and any other information that 1 the city or county may require.

"(3) The fee for issuing a license under this section shall be established by the city or county, but may not exceed the cost of administering the licensing program and administering section 3 of this 2013
Act.

6 "(4) A license issued under this section expires annually on De-7 cember 31 or on a date that may be specified by the city or county by 8 ordinance.

9 "(5) The requirement to get a license under this section applies only
10 to towers that tow a motor vehicle without the prior consent or au11 thorization of the owner or operator of the motor vehicle.

"(6) A city or county may suspend or revoke a license issued under
this section for violation of section 3 of this 2013 Act or ORS 98.854.".
