# PROPOSED AMENDMENTS TO RESOLVE CONFLICTS TO A-ENGROSSED HOUSE BILL 3070

1 On <u>page 1</u> of the printed A-engrossed bill, delete lines 18 through 28.

2 Delete <u>pages 2 through 4</u> and insert:

3 "SECTION 2. ORS 646.608, as amended by section 6, chapter 52, Oregon
4 Laws 2012, is amended to read:

"646.608. (1) A person engages in an unlawful practice [*when*] if in the
course of the person's business, vocation or occupation the person does any
of the following:

"(a) Passes off real estate, goods or services as [those] the real estate,
goods or services of another.

"(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, approval, or certification of real estate, goods or services.

"(c) Causes likelihood of confusion or of misunderstanding as to affil iation, connection, or association with, or certification by, another.

"(d) Uses deceptive representations or designations of geographic origin
 in connection with real estate, goods or services.

"(e) Represents that real estate, goods or services have sponsorship, approval, characteristics, ingredients, uses, benefits, quantities or qualities that [*they*] **the real estate, goods or services** do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.

"(f) Represents that real estate or goods are original or new if [they] the

real estate or goods are deteriorated, altered, reconditioned, reclaimed,
used or secondhand.

"(g) Represents that real estate, goods or services are of a particular standard, quality, or grade, or that real estate or goods are of a particular style or model, if [*they*] **the real estate, goods or services** are of another.

"(h) Disparages the real estate, goods, services, property or business of a
customer or another by false or misleading representations of fact.

8 "(i) Advertises real estate, goods or services with intent not to provide 9 [*them*] **the real estate, goods or services** as advertised, or with intent not 10 to supply reasonably expectable public demand, unless the advertisement 11 discloses a limitation of quantity.

"(j) Makes false or misleading representations of fact concerning the reasons for, existence of, or amounts of price reductions.

"(k) Makes false or misleading representations concerning credit avail ability or the nature of the transaction or obligation incurred.

"(L) Makes false or misleading representations relating to commissions
 or other compensation to be paid in exchange for permitting real estate,
 goods or services to be used for model or demonstration purposes or in ex change for submitting names of potential customers.

"(m) Performs service on or dismantles any goods or real estate [when not
authorized by] if the owner or apparent owner [thereof] of the goods or real
estate does not authorize the service or dismantling.

"(n) Solicits potential customers by telephone or door to door as a seller
unless the person provides the information required under ORS 646.611.

"(u) Engages in any other unfair or deceptive conduct in trade or com-merce.

"(v) Violates any of the provisions relating to auction sales, auctioneers
 or auction marts under ORS 698.640, whether in a commercial or noncom mercial situation.

19 "(w) Manufactures mercury fever thermometers.

20 "(x) Sells or supplies mercury fever thermometers unless the thermometer 21 is required by federal law, or is:

sense and, through electrical communication with heating, cooling or ventilation equipment, control room temperature.

"(k) Makes false or misleading representations concerning credit availability or the nature of the transaction or obligation incurred.

"(L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demonstration purposes or in exchange for submitting names of potential customers.

"(m) Performs service on or dismantles any goods or real estate [*when*]
if the owner or apparent owner of the goods or real estate does not authorize
the service or dismantling.

1 "(n) Solicits potential customers by telephone or door to door as a seller 2 unless the person provides the information required under ORS 646.611.

"(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, discount or other value is contingent upon an event occurring after the time the customer enters into the transaction.

"(p) Makes any false or misleading statement about a prize, contest or
 promotion used to publicize a product, business or service.

"(q) Promises to deliver real estate, goods or services within a certain period of time with intent not to deliver the real estate, goods or services as promised.

"(r) Organizes or induces or attempts to induce membership in a pyramidclub.

"(s) Makes false or misleading representations of fact concerning the offering price of, or the person's cost for real estate, goods or services.

"(t) Concurrent with tender or delivery of any real estate, goods or ser vices fails to disclose any known material defect or material nonconformity.
 "(u) Engages in any other unfair or deceptive conduct in trade or com merce.

"(5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.

"SECTION 4. Section 1 of this 2013 Act and the amendments to ORS
646.608 by section 2 of this 2013 Act apply to a sale or advertisement
of consumer goods that occurs on or after the effective date of this
2013 Act.

"<u>SECTION 5.</u> If House Bill 2573 becomes law, section 4 of this 2013 Act is amended to read:

"Sec. 4. Section 1 of this 2013 Act and the amendments to ORS 646.608
by section [2] 3 of this 2013 Act apply to a sale or advertisement of consumer
goods that occurs on or after the effective date of this 2013 Act.

"SECTION 6. If House Bill 3160 becomes law, sections 3 (amending
ORS 646.608) and 5 (amending section 4 of this 2013 Act) of this 2013
Act are repealed.".
