

**PROPOSED AMENDMENTS TO  
HOUSE BILL 2668  
(INCLUDING AMENDMENTS TO RESOLVE CONFLICTS)**

1 In line 2 of the printed bill, delete “amending ORS” and insert “creating  
2 new provisions; and amending ORS 346.680 and”.

3 In line 5, delete “exclusion” and insert “exclusions”.

4 Delete lines 13 and 14 and insert:

5 “(2) A place of public accommodation does not include:

6 “(a) A Department of Corrections institution as defined in ORS 421.005.

7 “(b) A state hospital as defined in ORS 162.135.

8 “(c) A youth correction facility as defined in ORS 420.005.

9 “(d) A local correction facility or lockup as defined in ORS 169.005.

10 “(e) An institution, bona fide club or place of accommodation that is in  
11 its nature distinctly private.

12 **“SECTION 2.** ORS 346.680 is amended to read:

13 “346.680. As used in ORS 346.680 to 346.690:

14 “(1) ‘Assistance animal’ means any animal trained to assist a person with  
15 a physical impairment in one or more daily life activities, including but not  
16 limited to:

17 “(a) Dog guides, as defined in ORS 346.610;

18 “(b) Hearing ear dogs, as defined in ORS 346.640;

19 “(c) An animal trained to pull a wheelchair;

20 “(d) An animal trained to fetch dropped items; and

21 “(e) An animal trained to perform balance work.

1       “(2) ‘Assistance animal trainee’ means any animal undergoing training to  
2 assist a person with a physical impairment.

3       “(3) ‘Daily life activity’ includes but is not limited to:

4       “(a) Self-care;

5       “(b) Ambulation;

6       “(c) Communication; or

7       “(d) Transportation.

8       “(4) ‘Mode of transportation’ means any mode of transportation operating  
9 within this state.

10       “(5) ‘Person with a physical impairment’ means any person who has a  
11 permanent physical impairment, whose physical impairment limits one or  
12 more of daily life activities and who has a record of impairment and is re-  
13 garded by health care practitioners as having such an impairment, requiring  
14 the use of an assistance animal including but not limited to blindness,  
15 deafness and complete or partial paralysis.

16       “(6) ‘Public accommodation’ means a place of public accommodation as  
17 defined in ORS 659A.400 including but not limited to educational insti-  
18 tutions, airlines and restaurants. The [*exception*] **exclusions** stated in ORS  
19 659A.400 (2) [*is not an exception*] **are not exclusions** under ORS 90.390 and  
20 346.680 to 346.690.

21       **“SECTION 3. If Senate Bill 610 becomes law, section 2 of this 2013**  
22 **Act (amending ORS 346.680) is repealed.”.**
