

**PROPOSED AMENDMENTS TO  
SENATE BILL 300**

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the  
2 line and delete lines 3 through 17 and insert “197.085, 390.127, 406.020,  
3 468.040, 469.040, 471.720, 496.112 and 830.135; and declaring an emergency.”.

4 Delete lines 19 through 31 and delete pages 2 through 78 and insert:

5 **“SECTION 1. ORS 197.085 is amended to read:**

6 “197.085. (1) The Land Conservation and Development Commission shall  
7 appoint a person to serve as the Director of the Department of Land Con-  
8 servation and Development. The director shall hold the office of the director  
9 at the pleasure of the commission and **of the Governor, and may be dis-**  
10 **missed by either.** The salary of the director shall be fixed by the commis-  
11 sion unless otherwise provided by law.

12 “(2) In addition to salary, the director shall be reimbursed, subject to any  
13 applicable law regulating travel and other expenses of state officers and  
14 employees, for actual and necessary expenses incurred by the director in the  
15 performance of official duties.

16 **“SECTION 2. ORS 390.127 is amended to read:**

17 “390.127. (1) The State Parks and Recreation Commission shall appoint  
18 as State Parks and Recreation Director an individual well qualified by  
19 training and experience to serve for a term of four years unless sooner re-  
20 moved by the commission **or the Governor.**

21 **“(2) The director serves at the pleasure of the commission and the**  
22 **Governor, and may be dismissed by either.**

1        “[2] (3) The director shall receive such salary as may be prescribed by  
2 law. In addition to salary, subject to applicable law regulating travel and  
3 expenses of state officers, the director shall be reimbursed for actual and  
4 necessary travel and other expenses incurred in the performance of official  
5 duties.

6        **“SECTION 3.** ORS 406.020 is amended to read:

7        “406.020. The Department of Veterans’ Affairs shall be under the super-  
8 vision and control of the Director of Veterans’ Affairs. The Governor shall  
9 appoint the director subject to confirmation by the Senate in the manner  
10 provided in ORS 171.562 and 171.565. **The director shall serve at the**  
11 **pleasure of the Governor.** The appointment may not be made without the  
12 written approval of the Advisory Committee provided for in ORS 406.210. The  
13 director shall be a veteran, chosen on the basis of executive and adminis-  
14 trative ability.

15        **“SECTION 4.** ORS 468.040 is amended to read:

16        “468.040. The Environmental Quality Commission shall appoint a director  
17 who shall hold office at the pleasure of the commission **and of the Govern-**  
18 **nor, and may be dismissed by either.** The salary of the Director of the  
19 Department of Environmental Quality shall be fixed by the commission un-  
20 less otherwise provided by law.

21        **“SECTION 5.** ORS 469.040 is amended to read:

22        “469.040. (1) The State Department of Energy shall be under the super-  
23 vision of the Director of the State Department of Energy, who shall:

24        “(a) Supervise the day-to-day functions of the State Department of Energy;

25        “(b) Supervise and facilitate the work and research on energy facility  
26 siting applications at the direction of the Energy Facility Siting Council;

27        “(c) Hire, assign, reassign and coordinate personnel of the State Depart-  
28 ment of Energy, prescribe their duties and fix their compensation, subject to  
29 the State Personnel Relations Law; and

30        “(d) Adopt rules and issue orders to carry out the duties of the director

1 and the State Department of Energy in accordance with ORS chapter 183 and  
2 the policy stated in ORS 469.010.

3 “(2) The director may delegate to any officer or employee the exercise and  
4 discharge in the director’s name of any power, duty or function of whatever  
5 character vested in the director by law. The official act of any person acting  
6 in the director’s name and by the director’s authority shall be considered an  
7 official act of the director.

8 “(3) The director shall be appointed by **and serve at the pleasure of the**  
9 Governor.

10 **“SECTION 6.** ORS 471.720 is amended to read:

11 “471.720. The Oregon Liquor Control Commission shall appoint an ad-  
12 ministrator who shall serve at *[its discretion]* **the pleasure of the com-**  
13 **mission and of the Governor, and may be dismissed by either.** The  
14 administrator shall be subject to policy direction by the commissioners, and  
15 shall be the secretary of the commission and custodian of commission re-  
16 cords. The administrator shall manage the commission, administer the laws,  
17 and appoint, assign and coordinate personnel of the commission within  
18 budget limitations and the State Personnel Relations Law.

19 **“SECTION 7.** ORS 496.112 is amended to read:

20 “496.112. (1) The State Fish and Wildlife Commission shall appoint a State  
21 Fish and Wildlife Director to serve for a term not to exceed four years *[un-*  
22 *less sooner removed by the commission]*. **The director shall serve at the**  
23 **pleasure of the commission and of the Governor, and may be dismissed**  
24 **by either.**

25 “(2) The director shall receive such salary as may be fixed by the com-  
26 mission. In addition to salary, subject to applicable law regulating travel and  
27 other expenses of state officers, the director shall be reimbursed for actual  
28 and necessary travel and other expenses incurred in the performance of of-  
29 ficial duties.

30 “(3) The commission may delegate to the director any of the powers and

1 duties granted to or imposed upon it by law, except to revoke or refuse to  
2 issue licenses issued pursuant to the commercial fishing laws.

3 “(4) The commission may reappoint the director to additional terms.

4 **“SECTION 8.** ORS 830.135 is amended to read:

5 “830.135. (1) The State Marine Board shall appoint a State Marine Di-  
6 rector who shall serve at the pleasure of the board **and of the Governor,**  
7 **and may be dismissed by either.**

8 “(2) The director shall devote full time to the duties of the office. With  
9 the approval of the board, the director shall:

10 “(a) Administer the numbering, certificating, recording and licensing du-  
11 ties of the board.

12 “(b) Perform any other duties assigned by the board.

13 “(c) Hire subordinate employees and fix their compensation.

14 **“SECTION 9. This 2013 Act being necessary for the immediate**  
15 **preservation of the public peace, health and safety, an emergency is**  
16 **declared to exist, and this 2013 Act takes effect on its passage.”.**
