On page 1 of the printed minority report A-engrossed bill, line 2, after "ORS" delete the rest of the line and line 3 and insert "316.085, 316.695, 317.061, 317.853, 318.074, 323.030, 323.455, 323.505 and 323.625; prescribing an effective date; and providing for revenue raising that requires approval by a three-fifths majority.".

"SECTION 1. The intent of the Legislative Assembly in enacting sections 2, 6 and 11 to 14 of this 2013 Act and the amendments to statutes by sections 3 to 5 and 7 to 10 of this 2013 Act is that the increased revenues that result from the changes in tax law contained in those sections and that are received during the 2013-2015 biennium shall provide funding, through appropriation or otherwise, as follows: "(1) \$100 million for the State School Fund.

"(2) \$40 million for the funding of community colleges and higher
 education.

16 **"(3) \$40 million for services to senior citizens.**

17 "(4) \$20 million for mental health services.

"SECTION 1a. Section 2 of this 2013 Act is added to and made a part

The Department of Revenue shall recompute the rates for 14 each biennium by adding to the rates in subsection (2)(b) of this section the 15product obtained by multiplying the rates in subsection (2)(b) of this section 16 by a factor that is equal to 0.25 multiplied by the percentage (if any) by 17 which the monthly averaged U.S. City Average Consumer Price Index for the 18 12 consecutive months ending August 31 of the prior calendar year exceeds 19 the monthly averaged U.S. City Average Consumer Price Index for the 12 20consecutive months ending August 31, 2017. 21

"(4) If the tax imposed under this section does not equal an amount calculable to a whole cent, the tax shall be equal to the next higher whole cent. However, the amount remitted to the Department of Revenue by the taxpayer for each quarter shall be equal only to 98.5 percent of the total taxes due and payable by the taxpayer for the quarter.

"(5) No tobacco product shall be subject to the tax if the base product or other intermediate form thereof has previously been taxed under this section.

30 **"SECTION 9.** ORS 323.455 is amended to read:

"323.455. (1) All moneys received by the Department of Revenue from the 1 tax imposed by ORS 323.030 (1) shall be paid over to the State Treasurer to $\mathbf{2}$ be held in a suspense account established under ORS 293.445. The department 3 may pay expenses for administration of ORS 323.005 to 323.482 out of moneys 4 received from the tax imposed under ORS 323.030 (1). Amounts necessary to $\mathbf{5}$ pay administrative expenses are continuously appropriated to the department 6 from the suspense account. Each city shall 16 receive such share of the money appropriated to all cities as its population, 17 as determined under ORS 190.510 to 190.590 last preceding such apportion-18 ment, bears to the total population of the cities of the state, and each county 19 shall receive such share of the money as its population, determined under 20ORS 190.510 to 190.590 last preceding such apportionment, bears to the total 21population of the state. 22

"(3) The moneys appropriated to the Department of Transportation under subsection (1) of this section shall be distributed and transferred to the Elderly and Disabled Special Transportation Fund established by ORS 391.800 at the same time as the cigarette tax moneys are distributed to cities and counties under this section.
