

**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 3367**

1 On page 1 of the printed A-engrossed bill, line 2, after “173.025,” delete
2 the rest of the line.

3 In line 3, after “315.172,” delete the rest of the line and insert “315.521,
4 315.613, 315.616, 316.102, 316.502, 316.695, 317.147, 317.154, 455.380.”.

5 Delete line 4.

6 On page 2, delete lines 3 through 45 and delete pages 3 through 32 and
7 insert:

8 **“SECTION 1. Section 6, chapter 880, Oregon Laws 2007, is amended to**
9 **read:**

10 **“Sec. 6. [*The repeal of ORS 315.266 by section 5 of this 2007 Act applies***
11 ***to tax years beginning on or after January 1, 2014.*] **ORS 315.266 applies to****
12 ****tax years beginning before January 1, 2020.****

13 **“SECTION 2. Section 5, chapter 880, Oregon Laws 2007, and section**
14 **28, chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492), are re-**
15 **pealed.**

16 **“SECTION 3. Section 29, chapter 377, Oregon Laws 2013 (Enrolled House**
17 **Bill 2492), is amended to read:**

18 **“Sec. 29. (1) Except as provided in subsections (2) and (3) of this section,**
19 **[*section 28 of this 2013 Act and*] the amendments to statutes by sections 1 to**
20 **27 [*of this 2013 Act*], **chapter 377, Oregon Laws 2013 (Enrolled House Bill**
21 **2492), apply to transactions or activities occurring on or after January 1,**
22 **2013, in tax years beginning on or after January 1, 2013.****

1 “(2) The effective and applicable dates, and the exceptions, special rules
2 and coordination with the Internal Revenue Code, as amended, relative to
3 those dates, contained in the Middle Class Tax Relief and Job Creation Act
4 of 2012 (P.L. 112-96), the American Taxpayer Relief Act of 2012 (P.L. 112-240)
5 and other federal law amending the Internal Revenue Code and enacted be-
6 fore January 3, 2013, apply for Oregon personal income and corporate excise
7 and income tax purposes, to the extent they can be made applicable, in the
8 same manner as they are applied under the Internal Revenue Code and re-
9 lated federal law.

10 “(3)(a) If a deficiency is assessed against any taxpayer for a tax year be-
11 ginning before January 1, 2013, and the deficiency or any portion thereof is
12 attributable to any retroactive treatment under the amendments to ORS
13 305.230, 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800,
14 314.011, 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [*of*
15 *this 2013 Act*], **chapter 377, Oregon Laws 2013 (Enrolled House Bill**
16 **2492)**, then any interest or penalty assessed under ORS chapter 305, 314, 315,
17 316, 317 or 318 with respect to the deficiency or portion thereof shall be
18 canceled.

19 “(b) If a refund is due any taxpayer for a tax year beginning before Jan-
20 uary 1, 2013, and the refund or any portion thereof is due the taxpayer on
21 account of any retroactive treatment under the amendments to ORS 305.230,
22 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011,
23 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [*of this 2013*
24 *Act*], **chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492)**, then
25 notwithstanding ORS 305.270 or 314.415 or other law, the refund or portion
26 thereof shall be paid without interest.

27 “(c) Any changes required because of the amendments to ORS 305.230,
28 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011,
29 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [*of this 2013*
30 *Act*], **chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492)**, for a tax

1 year beginning before January 1, 2013, shall be made by filing an amended
2 return within the time prescribed by law.

3 “(d) If a taxpayer fails to file an amended return under paragraph (c) of
4 this subsection, the Department of Revenue shall make any changes under
5 paragraph (c) of this subsection on the return to which the changes relate
6 within the period specified for issuing a notice of deficiency or claiming a
7 refund as otherwise provided by law with respect to that return, or within
8 one year after a return for a tax year beginning on or after January 1, 2013,
9 and before January 1, 2014, is filed, whichever period expires later.

10 **“SECTION 4.** ORS 316.695 is amended to read:

11 “316.695. (1) In addition to the modifications to federal taxable income
12 contained in this chapter, there shall be added to or subtracted from federal
13 taxable income:

14 “(a) If, in computing federal income tax for a [*taxable*] **tax** year, the tax-
15 payer deducted itemized deductions, as defined in section 63(d) of the Inter-
16 nal Revenue Code, the taxpayer shall add the amount of itemized deductions
17 deducted (the itemized deductions less an amount, if any, by which the
18 itemized deductions are reduced under section 68 of the Internal Revenue
19 Code).

20 “(b) If, in computing federal income tax for a [*taxable*] **tax** year, the tax-
21 payer deducted the standard deduction, as defined in section 63(c) of the
22 Internal Revenue Code, the taxpayer shall add the amount of the standard
23 deduction deducted.

24 “(c)(A) From federal taxable income there shall be subtracted the larger
25 of (i) the taxpayer’s itemized deductions or (ii) a standard deduction. Except
26 as provided in subsection (8) of this section, for purposes of this subpara-
27 graph, ‘standard deduction’ means the sum of the basic standard deduction
28 and the additional standard deduction.

29 “(B) For purposes of subparagraph (A) of this paragraph, the basic
30 standard deduction is:

1 “(i) \$3,280, in the case of joint return filers or a surviving spouse;

2 “(ii) \$1,640, in the case of an individual who is not a married individual
3 and is not a surviving spouse;

4 “(iii) \$1,640, in the case of a married individual who files a separate re-
5 turn; or

6 “(iv) \$2,640, in the case of a head of household.

7 “(C)(i) For purposes of subparagraph (A) of this paragraph for tax years
8 beginning on or after January 1, 2003, the Department of Revenue shall an-
9 nually recompute the basic standard deduction for each category of return
10 filer listed under subparagraph (B) of this paragraph. The basic standard
11 deduction shall be computed by dividing the monthly averaged U.S. City
12 Average Consumer Price Index for the 12 consecutive months ending August
13 31 of the prior calendar year by the average U.S. City Average Consumer
14 Price Index for the second quarter of 2002, then multiplying that quotient
15 by the amount listed under subparagraph (B) of this paragraph for each
16 category of return filer.

17 “(ii) If any change in the maximum household income determined under
18 this subparagraph is not a multiple of \$5, the increase shall be rounded to
19 the next lower multiple of \$5.

20 “(iii) As used in this subparagraph, ‘U.S. City Average Consumer Price
21 Index’ means the U.S. City Average Consumer Price Index for All Urban
22 Consumers (All Items) as published by the Bureau of Labor Statistics of the
23 United States Department of Labor.

24 “(D) For purposes of subparagraph (A) of this paragraph, the additional
25 standard deduction is the sum of each additional amount to which the tax-
26 payer is entitled under subsection (7) of this section.

27 “(E) As used in subparagraph (B) of this paragraph, ‘surviving spouse’ and
28 ‘head of household’ have the meaning given those terms in section 2 of the
29 Internal Revenue Code.

30 “(F) In the case of the following, the standard deduction referred to in

1 subparagraph (A) of this paragraph shall be zero:

2 “(i) A husband or wife filing a separate return where the other spouse
3 has claimed itemized deductions under subparagraph (A) of this paragraph;

4 “(ii) A nonresident alien individual;

5 “(iii) An individual making a return for a period of less than 12 months
6 on account of a change in the individual’s annual accounting period;

7 “(iv) An estate or trust;

8 “(v) A common trust fund; or

9 “(vi) A partnership.

10 “(d) For the purposes of paragraph (c)(A) of this subsection, the taxpayer’s
11 itemized deductions are the sum of:

12 “(A) The taxpayer’s itemized deductions as defined in section 63(d) of the
13 Internal Revenue Code (reduced, if applicable, as described under section 68
14 of the Internal Revenue Code) minus the deduction for Oregon income tax
15 (reduced, if applicable, by the proportion that the reduction in federal item-
16 ized deductions resulting from section 68 of the Internal Revenue Code bears
17 to the amount of federal itemized deductions as defined for purposes of sec-
18 tion 68 of the Internal Revenue Code); and

19 “(B) The amount [*that may be taken into account under section 213(a) of*
20 *the Internal Revenue Code,*] **paid for medical care of the taxpayer during**
21 **the tax year and not compensated for by insurance or otherwise, as**
22 **described in section 213(a) of the Internal Revenue Code,** not to exceed
23 seven and one-half percent of the federal adjusted gross income of the tax-
24 payer, if **the taxpayer or the taxpayer’s spouse has attained 62 years**
25 **of age before the close of the tax year and if the amount is attributable**
26 **to medical care of a taxpayer who has attained 62 years of age before**
27 **the close of the tax year.** [*the taxpayer has attained the following age before*
28 *the close of the taxable year, or, in the case of a joint return, if either taxpayer*
29 *has attained the following age before the close of the taxable year:*]

30 “[*i*] For taxable years beginning on or after January 1, 1991, and before

1 *January 1, 1993, a taxpayer must attain 58 years of age before the close of the*
2 *taxable year.]*

3 “[*ii*] *For taxable years beginning on or after January 1, 1993, and before*
4 *January 1, 1995, a taxpayer must attain 59 years of age before the close of the*
5 *taxable year.]*

6 “[*iii*] *For taxable years beginning on or after January 1, 1995, and before*
7 *January 1, 1997, a taxpayer must attain 60 years of age before the close of the*
8 *taxable year.]*

9 “[*iv*] *For taxable years beginning on or after January 1, 1997, and before*
10 *January 1, 1999, a taxpayer must attain 61 years of age before the close of the*
11 *taxable year.]*

12 “[*v*] *For taxable years beginning on or after January 1, 1999, a taxpayer*
13 *must attain 62 years of age before the close of the taxable year.]*

14 “(2)(a) There shall be subtracted from federal taxable income any portion
15 of the distribution of a pension, profit-sharing, stock bonus or other retire-
16 ment plan, representing that portion of contributions which were taxed by
17 the State of Oregon but not taxed by the federal government under laws in
18 effect for tax years beginning prior to January 1, 1969, or for any subsequent
19 year in which the amount that was contributed to the plan under the Inter-
20 nal Revenue Code was greater than the amount allowed under this chapter.

21 “(b) Interest or other earnings on any excess contributions of a pension,
22 profit-sharing, stock bonus or other retirement plan not permitted to be de-
23 ducted under paragraph (a) of this subsection [*shall*] **may** not be added to
24 federal taxable income in the year earned by the plan and [*shall*] **may** not
25 be subtracted from federal taxable income in the year received by the tax-
26 payer.

27 “(3)(a) Except as provided in subsection (4) of this section, there shall be
28 added to federal taxable income the amount of any federal income taxes in
29 excess of the amount provided in paragraphs (b) to (d) of this subsection,
30 accrued by the taxpayer during the [*taxable*] **tax** year as described in ORS

1 316.685, less the amount of any refund of federal taxes previously accrued for
2 which a tax benefit was received.

3 “(b) The limits applicable to this subsection are:

4 “(A) \$5,500, if the federal adjusted gross income of the taxpayer for the
5 tax year is less than \$125,000, or, if reported on a joint return, less than
6 \$250,000.

7 “(B) \$4,400, if the federal adjusted gross income of the taxpayer for the
8 tax year is \$125,000 or more and less than \$130,000, or, if reported on a joint
9 return, \$250,000 or more and less than \$260,000.

10 “(C) \$3,300, if the federal adjusted gross income of the taxpayer for the
11 tax year is \$130,000 or more and less than \$135,000, or, if reported on a joint
12 return, \$260,000 or more and less than \$270,000.

13 “(D) \$2,200, if the federal adjusted gross income of the taxpayer for the
14 tax year is \$135,000 or more and less than \$140,000, or, if reported on a joint
15 return, \$270,000 or more and less than \$280,000.

16 “(E) \$1,100, if the federal adjusted gross income of the taxpayer for the
17 tax year is \$140,000 or more and less than \$145,000, or, if reported on a joint
18 return, \$280,000 or more and less than \$290,000.

19 “(c) If the federal adjusted gross income of the taxpayer is \$145,000 or
20 more for the tax year, or, if reported on a joint return, \$290,000 or more, the
21 limit is zero and the taxpayer is not allowed a subtraction for federal income
22 taxes under ORS 316.680 (1) for the tax year.

23 “(d) In the case of a husband and wife filing separate tax returns, the
24 amount added shall be in the amount of any federal income taxes in excess
25 of **50 percent** of the amount provided for individual taxpayers under para-
26 graphs (a) to (c) of this subsection, less the amount of any refund of federal
27 taxes previously accrued for which a tax benefit was received.

28 “(e) For purposes of this subsection, the limits applicable to a joint return
29 shall apply to a head of household or a surviving spouse, as defined in sec-
30 tion 2(a) and (b) of the Internal Revenue Code.

1 “(f)(A) For a calendar year beginning on or after January 1, 2008, the
2 Department of Revenue shall make a cost-of-living adjustment to the federal
3 income tax threshold amounts described in paragraphs (b) and (d) of this
4 subsection.

5 “(B) The cost-of-living adjustment for a calendar year is the percentage
6 by which the monthly averaged U.S. City Average Consumer Price Index for
7 the 12 consecutive months ending August 31 of the prior calendar year ex-
8 ceeds the monthly averaged index for the period beginning September 1, 2005,
9 and ending August 31, 2006.

10 “(C) As used in this paragraph, ‘U.S. City Average Consumer Price
11 Index’ means the U.S. City Average Consumer Price Index for All Urban
12 Consumers (All Items) as published by the Bureau of Labor Statistics of the
13 United States Department of Labor.

14 “(D) If any adjustment determined under subparagraph (B) of this para-
15 graph is not a multiple of \$50, the adjustment shall be rounded to the next
16 lower multiple of \$50.

17 “(E) The adjustment shall apply to all tax years beginning in the calendar
18 year for which the adjustment is made.

19 “(4)(a) In addition to the adjustments required by ORS 316.130, a full-year
20 nonresident individual shall add to taxable income a proportion of any ac-
21 crued federal income taxes as computed under ORS 316.685 in excess of the
22 amount provided in subsection (3) of this section in the proportion provided
23 in ORS 316.117.

24 “(b) In the case of a husband and wife filing separate tax returns, the
25 amount added under this subsection shall be computed in a manner consist-
26 ent with the computation of the amount to be added in the case of a husband
27 and wife filing separate returns under subsection (3) of this section. The
28 method of computation shall be determined by the Department of Revenue
29 by rule.

30 “(5) Subsections (3)(d) and (4)(b) of this section shall not apply to married

1 individuals living apart as defined in section 7703(b) of the Internal Revenue
2 Code.

3 “(6)(a) For tax years beginning on or after January 1, 1981, and prior to
4 January 1, 1983, income or loss taken into account in determining federal
5 taxable income by a shareholder of an S corporation pursuant to sections
6 1373 to 1375 of the Internal Revenue Code shall be adjusted for purposes of
7 determining Oregon taxable income, to the extent that as income or loss of
8 the S corporation, they were required to be adjusted under the provisions
9 of ORS chapter 317.

10 “(b) For tax years beginning on or after January 1, 1983, items of income,
11 loss or deduction taken into account in determining federal taxable income
12 by a shareholder of an S corporation pursuant to sections 1366 to 1368 of the
13 Internal Revenue Code shall be adjusted for purposes of determining Oregon
14 taxable income, to the extent that as items of income, loss or deduction of
15 the shareholder the items are required to be adjusted under the provisions
16 of this chapter.

17 “(c) The tax years referred to in paragraphs (a) and (b) of this subsection
18 are those of the S corporation.

19 “(d) As used in paragraph (a) of this subsection, an S corporation refers
20 to an electing small business corporation.

21 “(7)(a) The taxpayer shall be entitled to an additional amount, as referred
22 to in subsection (1)(c)(A) and (D) of this section, of \$1,000:

23 “(A) For the taxpayer if the taxpayer has attained age 65 before the close
24 of the taxpayer’s [*taxable*] **tax** year; and

25 “(B) For the spouse of the taxpayer if the spouse has attained age 65 be-
26 fore the close of the [*taxable*] **tax** year and an additional exemption is al-
27 lowable to the taxpayer for such spouse for federal income tax purposes
28 under section 151(b) of the Internal Revenue Code.

29 “(b) The taxpayer shall be entitled to an additional amount, as referred
30 to in subsection (1)(c)(A) and (D) of this section, of \$1,000:

1 “(A) For the taxpayer if the taxpayer is blind at the close of the
2 [taxable] tax year; and

3 “(B) For the spouse of the taxpayer if the spouse is blind as of the close
4 of the [taxable] tax year and an additional exemption is allowable to the
5 taxpayer for such spouse for federal income tax purposes under section 151(b)
6 of the Internal Revenue Code. For purposes of this subparagraph, if the
7 spouse dies during the [taxable] tax year, the determination of whether such
8 spouse is blind shall be made immediately prior to death.

9 “(c) In the case of an individual who is not married and is not a surviving
10 spouse, paragraphs (a) and (b) of this subsection shall be applied by substi-
11 tuting ‘\$1,200’ for ‘\$1,000.’

12 “(d) For purposes of this subsection, an individual is blind only if the
13 individual’s central visual acuity does not exceed 20/200 in the better eye
14 with correcting lenses, or if the individual’s visual acuity is greater than
15 20/200 but is accompanied by a limitation in the fields of vision such that
16 the widest diameter of the visual field subtends an angle no greater than 20
17 degrees.

18 “(8) In the case of an individual with respect to whom a deduction under
19 section 151 of the Internal Revenue Code is allowable for federal income tax
20 purposes to another taxpayer for a [taxable] tax year beginning in the cal-
21 endar year in which the individual’s [taxable] tax year begins, the basic
22 standard deduction (referred to in subsection (1)(c)(B) of this section) appli-
23 cable to such individual for such individual’s [taxable] tax year shall equal
24 the lesser of:

25 “(a) The amount allowed to the individual under section 63(c)(5) of the
26 Internal Revenue Code for federal income tax purposes for the tax year for
27 which the deduction is being claimed; or

28 “(b) The amount determined under subsection (1)(c)(B) of this section.

29 **“SECTION 5. The amendments to ORS 316.695 by section 4 of this**
30 **2013 Act apply to tax years beginning on or after January 1, 2013.**

1 **“SECTION 6.** ORS 316.102 is amended to read:

2 “316.102. (1) A credit against taxes shall be allowed for voluntary contri-
3 butions in money made in the taxable year:

4 “(a) To a major political party qualified under ORS 248.006 or to a com-
5 mittee thereof or to a minor political party qualified under ORS 248.008 or
6 to a committee thereof.

7 “(b) To or for the use of a person who must be a candidate for nomination
8 or election to a federal, state or local elective office in any primary election,
9 general election or special election in this state. The person must, in the
10 calendar year in which the contribution is made, either be listed on a pri-
11 mary election, general election or special election ballot in this state or have
12 filed in this state one of the following:

13 “(A) A prospective petition;

14 “(B) A declaration of candidacy;

15 “(C) A certificate of nomination; or

16 “(D) A designation of a principal campaign committee.

17 “(c) To a political committee, as defined in ORS 260.005, if the political
18 committee has certified the name of its treasurer to the filing officer, as de-
19 fined in ORS 260.005, in the manner provided in ORS chapter 260.

20 “(2) The credit allowed by subsection (1) of this section shall be the lesser
21 of:

22 “(a) The total contribution, [*not to exceed \$50 on a separate return; the*
23 *total contribution,*] not to exceed \$100 on a joint return **or \$50 on any other**
24 **type of return;** or

25 “(b) The tax liability of the taxpayer.

26 **“(3) A taxpayer may not claim the credit allowed under this section**
27 **if the taxpayer has federal adjusted gross income in excess of \$200,000**
28 **on a joint return or \$100,000 on any other type of return.**

29 “[(3)] (4) The claim for tax credit shall be substantiated by submission,
30 with the tax return, of official receipts of the candidate, agent, political

1 party or committee thereof or political committee to whom contribution was
2 made.

3 **“SECTION 6a. The amendments to ORS 316.102 by section 6 of this**
4 **2013 Act apply to tax years beginning on or after January 1, 2014.**

5 **“SECTION 7.** Section 34, chapter 913, Oregon Laws 2009, is amended to
6 read:

7 **“Sec. 34.** A credit may not be claimed under ORS 316.102 for tax years
8 beginning on or after January 1, [2014] **2020.**

9 **“SECTION 8.** Section 19, chapter 954, Oregon Laws 2001, as amended by
10 section 35, chapter 913, Oregon Laws 2009, is amended to read:

11 **“Sec. 19.** ORS 315.675 applies to tax years beginning on or after January
12 1, 2002, and before January 1, [2014] **2020.**

13 **“SECTION 9.** Section 36, chapter 913, Oregon Laws 2009, is amended to
14 read:

15 **“Sec. 36.** A credit may not be claimed under ORS 316.157 for tax years
16 beginning on or after January 1, [2014] **2020.**

17 **“SECTION 10.** Section 25, chapter 913, Oregon Laws 2009, is amended to
18 read:

19 **“Sec. 25.** (1) Except as provided in subsection (2) of this section, a credit
20 may not be claimed under ORS 315.613 for tax years beginning on or after
21 January 1, [2014] **2016.**

22 **“(2)** A taxpayer who meets the eligibility requirements in ORS 315.613 for
23 the tax year beginning on or after January 1, 2013, and before January 1,
24 2014, shall be allowed the credit under ORS 315.613 for any tax year:

25 **“(a)** That begins on or before January 1, 2023; and

26 **“(b)** For which the taxpayer meets the eligibility requirements of ORS
27 315.613.

28 **“SECTION 11.** ORS 315.613 is amended to read:

29 **“315.613.** (1) A resident or nonresident individual certified as eligible un-
30 der ORS 442.563, licensed under ORS chapter 677, who is engaged in the

1 practice of medicine, and who [*has a rural practice that amounts to 60 percent*
2 *of the individual's practice,*] **is engaged for at least 20 hours per week,**
3 **averaged over the month, during the tax year in a rural practice,** shall
4 be allowed an annual credit against taxes otherwise due under [*this*
5 *chapter*] **ORS chapter 316** in the sum of \$5,000 during the time in which the
6 individual retains such practice and membership if the individual is actively
7 practicing in and is a member of the medical staff of one of the following
8 hospitals:

9 “(a) A type A hospital designated as such by the Office of Rural Health;

10 “(b) A type B hospital designated as such by the Office of Rural Health
11 if the hospital is:

12 “(A) Not within the boundaries of a metropolitan statistical area;

13 “(B) Located 30 or more highway miles from the closest hospital within
14 the major population center in a metropolitan statistical area; or

15 “(C) Located in a county with a population of less than 75,000;

16 “(c) A type C rural hospital, if the Office of Rural Health makes the
17 findings required by ORS 315.619; [*or*]

18 “(d) **A rural hospital that was designated a rural referral center by**
19 **the federal government before January 1, 1989, and that serves a**
20 **community with a population of at least 14,000 but not more than**
21 **19,000; or**

22 “[*d*] (e) A rural critical access hospital.

23 “(2) **In order to claim the credit allowed under this section, the in-**
24 **dividual must remain willing during the tax year to serve patients with**
25 **Medicare coverage and patients receiving medical assistance in at least**
26 **the same proportion to the individual's total number of patients as the**
27 **Medicare and medical assistance populations represent of the total**
28 **number of persons determined by the Office of Rural Health to be in**
29 **need of care in the county served by the practice, not to exceed 20**
30 **percent Medicare patients or 15 percent medical assistance patients.**

1 “[2] (3) A nonresident **individual** shall be allowed the credit under this
2 section in the proportion provided in ORS 316.117. If a change in the status
3 of a taxpayer from resident to nonresident or from nonresident to resident
4 occurs, the credit allowed by this section shall be determined in a manner
5 consistent with ORS 316.117.

6 “[3] (4) For purposes of this section, an ‘individual’s practice’ shall be
7 determined on the basis of actual time spent in practice each week in hours
8 or days, whichever is considered by the Office of Rural Health to be more
9 appropriate. In the case of a shareholder of a corporation or a member of a
10 partnership, only the time of the individual shareholder or partner shall be
11 considered and the full amount of the credit shall be allowed to each share-
12 holder or partner who qualifies in an individual capacity.

25 **“SECTION 42. ORS 315.521 is amended to read:**

26 “315.521. (1) There shall be allowed a credit against the taxes that are
27 otherwise due under ORS chapter 316 or, if the taxpayer is a corporation,
28 under ORS chapter 317 or 318, for amounts contributed to a university ven-
29 ture development fund established under ORS 351.697, to the extent the uni-
30 versity that established the fund issued a tax credit certificate to the

1 taxpayer.

2 “(2) The total amount of the credit allowed to a taxpayer shall equal 60
3 percent of the amount stated on the tax credit certificate. Except as provided
4 in subsection (3) of this section, the amount of the credit allowed in any one
5 tax year shall equal 20 percent of the amount actually contributed to the
6 fund. **The credit shall be claimed in three consecutive tax years begin-**
7 **ning with the year in which the credit is initially allowed.**

8 “(3) The credit allowed under this section may not exceed \$50,000 or the
9 tax liability of the taxpayer for the tax year.

10 “(4) In the case of a credit allowed under this section for purposes of ORS
11 chapter 316:

12 “(a) A nonresident shall be allowed the credit in the same manner and
13 subject to the same limitations as a resident. However, the credit shall be
14 prorated using the proportion provided in ORS 316.117.

15 “(b) If a change in the tax year of a taxpayer occurs as described in ORS
16 314.085 or if the Department of Revenue terminates the taxpayer’s tax year
17 under ORS 314.440, the credit shall be prorated or computed in a manner
18 consistent with ORS 314.085.

19 “(c) If a change in the status of a taxpayer from resident to nonresident
20 or from nonresident to resident occurs, the credit shall be determined in a
21 manner consistent with ORS 316.117.

22 “(5) A taxpayer claiming a credit under this section shall add to federal
23 taxable income for Oregon tax purposes any amount that is deducted for
24 federal tax purposes and that also serves as the basis for the credit allowed
25 under this section.

26 “**SECTION 43.** Section 27, chapter 913, Oregon Laws 2009, is amended to
27 read:

28 “**Sec. 27.** A credit may not be claimed under ORS 315.521 [*for tax years*
29 *beginning*] **if the initial tax year in which the credit would otherwise**
30 **be allowed begins** on or after January 1, 2016.

1 **“SECTION 44.** ORS 173.025 is amended to read:

2 “173.025. (1) The Legislative Fiscal Officer, with the aid of the Oregon
3 Department of Administrative Services, Legislative Revenue Officer, state
4 agencies and affected local governmental units, including school districts,
5 shall prepare a fiscal impact statement on each measure reported out of a
6 committee of the Legislative Assembly that could have an effect on expend-
7 itures of local governmental units, including school districts.

8 “(2) The Legislative Revenue Officer, with aid of the Legislative Fiscal
9 Officer, the Department of Revenue, state agencies and affected local gov-
10 ernmental units, including school districts, shall prepare a revenue impact
11 statement on each measure reported out of a committee of the Legislative
12 Assembly that could have any effect on revenues of local governmental units,
13 including school districts.

14 **“(3)(a) As used in this subsection, ‘tax expenditure’ has the meaning
15 given that term in ORS 291.201.**

16 **“(b) If a revenue impact statement is prepared pursuant to sub-
17 section (2) of this section on a measure that creates a tax expenditure,
18 the revenue impact statement must include the revenue impact of the
19 measure for at least three consecutive biennia, beginning with the
20 current biennium.**

21 **“(c) If a revenue impact statement is prepared pursuant to sub-
22 section (2) of this section on a measure that creates or extends a tax
23 expenditure, the revenue impact statement must include a statement
24 describing the public policy purpose of the tax expenditure. The public
25 policy purpose statement is subject to review by the committee re-
26 commending passage of the measure.**

27 **“SECTION 45.** ORS 315.050 is amended to read:

28 “315.050. (1) **As used in this section, ‘tax expenditure’ has the
29 meaning given that term in ORS 291.201.**

30 “(2) Any tax credit enacted by the Legislative Assembly on or after Jan-

1 uary 1, 2010, shall apply for a maximum of six tax years beginning with the
2 initial tax year for which the credit is applicable, unless the Legislative
3 Assembly expressly provides for another period of applicability.

4 **“(3) Any tax expenditure enacted by the Legislative Assembly on**
5 **or after January 1, 2014, shall apply for a maximum of six tax years**
6 **beginning with the initial tax year for which the tax expenditure is**
7 **applicable, unless the Legislative Assembly expressly provides for an-**
8 **other period of applicability.**

9 **“SECTION 46.** Section 20, chapter 913, Oregon Laws 2009, as amended
10 by section 4, chapter 730, Oregon Laws 2011, is amended to read:

11 **“Sec. 20. (1)** A credit may not be claimed under ORS 317.122 (1) for tax
12 years beginning on or after January 1, 2018.

13 **“(2) A credit may not be claimed under ORS 317.122 (2) for tax years**
14 **beginning on or after January 1, 2014.**

15 **“SECTION 47.** ORS 316.502 is amended to read:

16 “316.502. (1) The net revenue from the tax imposed by this chapter, after
17 deducting refunds, shall be paid over to the State Treasurer and held in the
18 General Fund as miscellaneous receipts available generally to meet any ex-
19 pense or obligation of the State of Oregon lawfully incurred.

20 “(2) A working balance of unreceipted revenue from the tax imposed by
21 this chapter may be retained for the payment of refunds, but such working
22 balance shall not at the close of any fiscal year exceed the sum of \$1 million.

23 “(3) Moneys are continuously appropriated to the Department of Revenue
24 to make:

25 “(a) The refunds authorized under subsection (2) of this section; and

26 “(b) The refund payments in excess of tax liability authorized under ORS
27 315.262 and 315.266 and section 17, chapter 906, Oregon Laws 2007, **and**
28 **section 2, chapter 65, Oregon Laws 2012.**

29 **“SECTION 48. This 2013 Act takes effect on the 91st day after the**
30 **date on which the 2013 regular session of the Seventy-seventh Legis-**

1 **lative Assembly adjourns sine die.”.**
