

**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2505**

1 On page 1 of the printed A-engrossed bill, line 2, after “expenditures;”
2 delete the rest of the line and insert “creating new provisions; amending ORS
3 173.025, 284.367, 284.368, 314.752, 315.050, 315.141, 315.163, 315.164, 315.167,
4 315.169, 315.172, 315.266, 315.336, 315.514, 315.521, 315.613, 315.616, 315.622,
5 316.102, 316.502, 317.147, 317.152, 317.154, 455.380, 456.508, 456.510, 456.585 and
6 566.340 and section 19, chapter 954, Oregon Laws 2001, section 66, chapter
7 832, Oregon Laws 2005, section 6, chapter 880, Oregon Laws 2007, sections
8 2b, 7b and 18, chapter 906, Oregon Laws 2007, sections 5, 20, 24, 25, 27, 28,
9 34 and 36, chapter 913, Oregon Laws 2009, and section 29, chapter 377,
10 Oregon Laws 2013 (Enrolled House Bill 2492); repealing section 5, chapter
11 880, Oregon Laws 2007, and section 28, chapter 377, Oregon Laws 2013 (En-
12 rolled House Bill 2492); and prescribing an effective date.”.

14 **“SECTION 1.** Section 6, chapter 880, Oregon Laws 2007, is amended to
15 read:

16 **“Sec. 6.** *[The repeal of ORS 315.266 by section 5 of this 2007 Act applies*
17 *to tax years beginning on or after January 1, 2014.]* **ORS 315.266 applies to**
18 **tax years beginning before January 1, 2020.**

19 **“SECTION 2.** **Section 5, chapter 880, Oregon Laws 2007, and section**
20 **28, chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492), are re-**
21 **pealed.**

22 **“SECTION 3.** Section 29, chapter 377, Oregon Laws 2013 (Enrolled House

1 Bill 2492), is amended to read:

2 “**Sec. 29.** (1) Except as provided in subsections (2) and (3) of this section,
3 [section 28 of this 2013 Act and] the amendments to statutes by sections 1 to
4 27 [of this 2013 Act], **chapter 377, Oregon Laws 2013 (Enrolled House Bill**
5 **2492)**, apply to transactions or activities occurring on or after January 1,
6 2013, in tax years beginning on or after January 1, 2013.

7 “(2) The effective and applicable dates, and the exceptions, special rules
8 and coordination with the Internal Revenue Code, as amended, relative to
9 those dates, contained in the Middle Class Tax Relief and Job Creation Act
10 of 2012 (P.L. 112-96), the American Taxpayer Relief Act of 2012 (P.L. 112-240)
11 and other federal law amending the Internal Revenue Code and enacted be-
12 fore January 3, 2013, apply for Oregon personal income and corporate excise
13 and income tax purposes, to the extent they can be made applicable, in the
14 same manner as they are applied under the Internal Revenue Code and re-
15 lated federal law.

16 “(3)(a) If a deficiency is assessed against any taxpayer for a tax year be-
17 ginning before January 1, 2013, and the deficiency or any portion thereof is
18 attributable to any retroactive treatment under the amendments to ORS
19 305.230, 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800,
20 314.011, 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [of
21 this 2013 Act], **chapter 377, Oregon Laws 2013 (Enrolled House Bill**
22 **2492)**, then any interest or penalty assessed under ORS chapter 305, 314, 315,
23 316, 317 or 318 with respect to the deficiency or portion thereof shall be
24 canceled.

25 “(b) If a refund is due any taxpayer for a tax year beginning before Jan-
26 uary 1, 2013, and the refund or any portion thereof is due the taxpayer on
27 account of any retroactive treatment under the amendments to ORS 305.230,
28 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011,
29 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [of this 2013
30 Act], **chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492)**, then

1 notwithstanding ORS 305.270 or 314.415 or other law, the refund or portion
2 thereof shall be paid without interest.

3 “(c) Any changes required because of the amendments to ORS 305.230,
4 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011,
5 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 [*of this 2013*
6 *Act*], **chapter 377, Oregon Laws 2013 (Enrolled House Bill 2492)**, for a tax
7 year beginning before January 1, 2013, shall be made by filing an amended
8 return within the time prescribed by law.

9 “(d) If a taxpayer fails to file an amended return under paragraph (c) of
10 this subsection, the Department of Revenue shall make any changes under
11 paragraph (c) of this subsection on the return to which the changes relate
12 within the period specified for issuing a notice of deficiency or claiming a
13 refund as otherwise provided by law with respect to that return, or within
14 one year after a return for a tax year beginning on or after January 1, 2013,
15 and before January 1, 2014, is filed, whichever period expires later.

16 **“SECTION 4.** ORS 315.266 is amended to read:

17 “315.266. (1) In addition to any other credit available for purposes of ORS
18 chapter 316, an eligible resident individual shall be allowed a credit against
19 the tax otherwise due under ORS chapter 316 for the tax year in an amount
20 equal to [*six*] **eight** percent of the earned income credit allowable to the
21 individual for the same tax year under section 32 of the Internal Revenue
22 Code.

23 “(2) An eligible nonresident individual shall be allowed the credit com-
24 puted in the same manner and subject to the same limitations as the credit
25 allowed a resident by subsection (1) of this section. However, the credit shall
26 be prorated using the proportion provided in ORS 316.117.

27 “(3) If a change in the taxable year of a taxpayer occurs as described in
28 ORS 314.085, or if the Department of Revenue terminates the taxpayer’s
29 taxable year under ORS 314.440, the credit allowed by this section shall be
30 prorated or computed in a manner consistent with ORS 314.085.

1 “(4) If a change in the status of a taxpayer from resident to nonresident
2 or from nonresident to resident occurs, the credit allowed by this section
3 shall be determined in a manner consistent with ORS 316.117.

4 “(5) If the amount allowable as a credit under this section, when added
5 to the sum of the amounts allowable as payment of tax under ORS 316.187
6 or 316.583, other tax prepayment amounts and other refundable credit
7 amounts, exceeds the taxes imposed by ORS chapters 314 and 316 for the tax
8 year after application of any nonrefundable credits allowable for purposes
9 of ORS chapter 316 for the tax year, the amount of the excess shall be re-
10 funded to the taxpayer as provided in ORS 316.502.

11 “(6) The Department of Revenue may adopt rules for purposes of this
12 section, including but not limited to rules relating to proof of eligibility and
13 the furnishing of information regarding the federal earned income credit
14 claimed by the taxpayer for the tax year.

15 “(7) Refunds attributable to the earned income credit allowed under this
16 section shall not bear interest.

17 **“SECTION 5. The amendments to ORS 315.266 by section 4 of this**
18 **2013 Act apply to tax years beginning on or after January 1, 2014, and**
19 **before January 1, 2020.**

20 **“SECTION 6.** ORS 316.102 is amended to read:

21 “316.102. (1) A credit against taxes shall be allowed for voluntary contri-
22 butions in money made in the taxable year:

23 “(a) To a major political party qualified under ORS 248.006 or to a com-
24 mittee thereof or to a minor political party qualified under ORS 248.008 or
25 to a committee thereof.

26 “(b) To or for the use of a person who must be a candidate for nomination
27 or election to a federal, state or local elective office in any primary election,
28 general election or special election in this state. The person must, in the
29 calendar year in which the contribution is made, either be listed on a pri-
30 mary election, general election or special election ballot in this state or have

1 filed in this state one of the following:

2 “(A) A prospective petition;

3 “(B) A declaration of candidacy;

4 “(C) A certificate of nomination; or

5 “(D) A designation of a principal campaign committee.

6 “(c) To a political committee, as defined in ORS 260.005, if the political
7 committee has certified the name of its treasurer to the filing officer, as de-
8 fined in ORS 260.005, in the manner provided in ORS chapter 260.

9 “(2) The credit allowed by subsection (1) of this section shall be the lesser
10 of:

11 “(a) The total contribution, [*not to exceed \$50 on a separate return; the*
12 *total contribution,*] not to exceed \$100 on a joint return **or \$50 on any other**
13 **type of return;** or

14 “(b) The tax liability of the taxpayer.

15 “**(3) A taxpayer may not claim the credit allowed under this section**
16 **if the taxpayer has federal adjusted gross income in excess of \$200,000**
17 **on a joint return or \$100,000 on any other type of return.**

18 “[~~(3)~~] (4) The claim for tax credit shall be substantiated by submission,
19 with the tax return, of official receipts of the candidate, agent, political
20 party or committee thereof or political committee to whom contribution was
21 made.

22 “**SECTION 6a. The amendments to ORS 316.102 by section 6 of this**
23 **2013 Act apply to tax years beginning on or after January 1, 2014.**

24 “**SECTION 7.** Section 34, chapter 913, Oregon Laws 2009, is amended to
25 read:

26 “**Sec. 34.** A credit may not be claimed under ORS 316.102 for tax years
27 beginning on or after January 1, [~~2014~~] **2020.**

28 “**SECTION 8.** Section 19, chapter 954, Oregon Laws 2001, as amended by
29 section 35, chapter 913, Oregon Laws 2009, is amended to read:

30 “**Sec. 19.** ORS 315.675 applies to tax years beginning on or after January

1 1, 2002, and before January 1, [2014] **2020**.

2 **“SECTION 9.** Section 36, chapter 913, Oregon Laws 2009, is amended to
3 read:

4 **“Sec. 36.** A credit may not be claimed under ORS 316.157 for tax years
5 beginning on or after January 1, [2014] **2020**.

6 **“SECTION 10.** Section 25, chapter 913, Oregon Laws 2009, is amended to
7 read:

8 **“Sec. 25.** (1) Except as provided in subsection (2) of this section, a credit
9 may not be claimed under ORS 315.613 for tax years beginning on or after
10 January 1, [2014] **2016**.

11 **“(2)** A taxpayer who meets the eligibility requirements in ORS 315.613 for
12 the tax year beginning on or after January 1, 2013, and before January 1,
13 2014, shall be allowed the credit under ORS 315.613 for any tax year:

14 **“(a)** That begins on or before January 1, 2023; and

15 **“(b)** For which the taxpayer meets the eligibility requirements of ORS
16 315.613.

17 **“SECTION 11.** ORS 315.613 is amended to read:

18 **“315.613.** (1) A resident or nonresident individual certified as eligible un-
19 der ORS 442.563, licensed under ORS chapter 677, who is engaged in the
20 practice of medicine, and who [*has a rural practice that amounts to 60 percent*
21 *of the individual’s practice,*] **is engaged for at least 20 hours per week,**
22 **averaged over the month, during the tax year in a rural practice,** shall
23 be allowed an annual credit against taxes otherwise due under [*this*
24 *chapter*] **ORS chapter 316** in the sum of \$5,000 during the time in which the
25 individual retains such practice and membership if the individual is actively
26 practicing in and is a member of the medical staff of one of the following
27 hospitals:

28 **“(a)** A type A hospital designated as such by the Office of Rural Health;

29 **“(b)** A type B hospital designated as such by the Office of Rural Health
30 if the hospital is:

1 “(A) Not within the boundaries of a metropolitan statistical area;

2 “(B) Located 30 or more highway miles from the closest hospital within
3 the major population center in a metropolitan statistical area; or

4 “(C) Located in a county with a population of less than 75,000;

5 “(c) A type C rural hospital, if the Office of Rural Health makes the
6 findings required by ORS 315.619; [*or*]

7 “(d) **A rural hospital that was designated a rural referral center by**
8 **the federal government before January 1, 1989, and that serves the**
9 **community of Coos Bay; or**

10 “[(d)] (e) A rural critical access hospital.

11 “(2) **In order to claim the credit allowed under this section, the in-**
12 **dividual must remain willing during the tax year to serve patients with**
13 **Medicare coverage and patients receiving medical assistance in at least**
14 **the same proportion to the individual’s total number of patients as the**
15 **Medicare and medical assistance populations represent of the total**
16 **number of persons determined by the Office of Rural Health to be in**
17 **need of care in the county served by the practice, not to exceed 20**
18 **percent Medicare patients or 15 percent medical assistance patients.**

19 “[(2)] (3) A nonresident **individual** shall be allowed the credit under this
20 section in the proportion provided in ORS 316.117. If a change in the status
21 of a taxpayer from resident to nonresident or from nonresident to resident
22 occurs, the credit allowed by this section shall be determined in a manner
23 consistent with ORS 316.117.

24 “[(3)] (4) For purposes of this section, an ‘individual’s practice’ shall be
25 determined on the basis of actual time spent in practice each week in hours
26 or days, whichever is considered by the Office of Rural Health to be more
27 appropriate. In the case of a shareholder of a corporation or a member of a
28 partnership, only the time of the individual shareholder or partner shall be
29 considered and the full amount of the credit shall be allowed to each share-
30 holder or partner who qualifies in an individual capacity.

1 “[~~4~~] (5) As used in this section:

2 “(a) ‘Type A hospital,’ ‘type B hospital’ and ‘type C hospital’ have the
3 meaning for those terms provided in ORS 442.470.

4 “(b) ‘Rural critical access hospital’ means a facility that meets the crite-
5 ria set forth in 42 U.S.C. 1395i-4 (c)(2)(B) and that has been designated a
6 critical access hospital by the Office of Rural Health and the Oregon Health
7 Authority.

8 **“SECTION 12.** ORS 315.616 is amended to read:

9 “315.616. A resident or nonresident individual who is certified as eligible
10 under ORS 442.561, 442.562, 442.563 or 442.564, and is licensed as a physician
11 or podiatric physician and surgeon under ORS chapter 677, licensed as a
12 physician assistant under ORS chapter 677, licensed as a nurse practitioner
13 under ORS chapter 678, licensed as a certified registered nurse anesthetist
14 under ORS chapter 678, licensed as a dentist under ORS chapter 679 or li-
15 censed as an optometrist under ORS 683.010 to 683.340 is entitled to the tax
16 credit described in ORS 315.613 even if not a member of the hospital medical
17 staff if the Office of Rural Health certifies that the individual:

18 “[~~1~~] *Has a rural practice that amounts to 60 percent of the individual’s*
19 *practice; and]*

20 **“(1) Is engaged for at least 20 hours per week, averaged over the**
21 **month, during the tax year in a rural practice; and**

22 “(2)(a) If a physician or a physician assistant, can cause a patient to be
23 admitted to the hospital;

24 “(b) If a certified registered nurse anesthetist, is employed by or has a
25 contractual relationship with one of the hospitals described in ORS 315.613
26 (1); or

27 “(c) If an optometrist, has consulting privileges with a hospital listed in
28 ORS 315.613 (1). This paragraph does not apply to an optometrist who qual-
29 ifies as a ‘frontier rural practitioner,’ as defined by the Office of Rural
30 Health.

1 **“SECTION 13. The amendments to ORS 315.613 and 315.616 by**
2 **sections 11 and 12 of this 2013 Act apply to tax years beginning on or**
3 **after January 1, 2014.**

4 **“SECTION 14.** ORS 315.622 is amended to read:

5 “315.622. (1) A resident or nonresident individual who is certified as eli-
6 gible under ORS 442.550 to 442.570 and who is licensed as an emergency
7 medical services provider under ORS chapter 682 shall be allowed a credit
8 against the taxes that are otherwise due under ORS chapter 316 if the Office
9 of Rural Health certifies that the individual provides volunteer emergency
10 medical services in a rural area that comprise at least 20 percent of the total
11 emergency medical services provided by the individual in the tax year.

12 “(2) The amount of the credit shall equal [~~\$250~~] **the lesser of the tax**
13 **liability of the taxpayer or \$500.**

14 “(3) A nonresident shall be allowed the credit under this section in the
15 proportion provided in ORS 316.117. If a change in the status of a taxpayer
16 from resident to nonresident or from nonresident to resident occurs, the
17 credit allowed by this section shall be determined in a manner consistent
18 with ORS 316.117.

19 “(4) As used in this section, ‘rural area’ means a geographic area that is
20 located at least 25 miles from any city with a population of 30,000 or more.

21 **“SECTION 15. The amendments to ORS 315.622 by section 14 of this**
22 **2013 Act apply to tax years beginning on or after January 1, 2014.**

23 **“SECTION 16.** Section 66, chapter 832, Oregon Laws 2005, as amended
24 by section 26, chapter 913, Oregon Laws 2009, is amended to read:

25 **“Sec. 66.** ORS 315.622 applies to tax credit certifications issued by the
26 Office of Rural Health on or after January 1, 2006, and before January 1,
27 [~~2014~~] **2020.**

28 **“SECTION 17.** Section 24, chapter 913, Oregon Laws 2009, is amended to
29 read:

30 **“Sec. 24.** Except as provided in ORS 315.237 (6), a credit may not be

1 claimed under ORS 315.237 for tax years beginning on or after January 1,
2 [2014] 2020.

3 **“SECTION 18.** Section 28, chapter 913, Oregon Laws 2009, is amended to
4 read:

5 **“Sec. 28.** Except as provided in ORS 315.164 (8), a credit may not be
6 claimed under ORS 315.164 for tax years beginning on or after January 1,
7 [2014] 2020.

8 **“SECTION 19.** ORS 315.163 is amended to read:

9 “315.163. As used in ORS 315.163 to 315.172:

10 “(1)(a) ‘Acquisition costs’ means the cost of acquiring buildings, struc-
11 tures and improvements that constitute or will constitute [farmworker] ag-
12 riculture workforce housing.

13 “(b) ‘Acquisition costs’ does not include the cost of acquiring land on
14 which [farmworker] agriculture workforce housing is or will be located.

15 “(2) ‘Agricultural worker’ means any person who, for an agreed
16 remuneration or rate of pay, performs temporary or permanent labor
17 for another in the:

18 “(a) Production of agricultural or aquacultural crops or products;

19 “(b) Handling of agricultural or aquacultural crops or products in
20 an unprocessed stage;

21 “(c) Processing of agricultural or aquacultural crops or products;

22 “(d) Planting, cultivating or harvesting of seasonal agricultural
23 crops; or

24 “(e) Forestation or reforestation of lands, including but not limited
25 to the planting, transplanting, tubing, precommercial thinning and
26 thinning of trees and seedlings, the clearing, piling and disposal of
27 brush and slash and other related activities.

28 “(3) ‘Agriculture workforce housing’ means housing:

29 “(a) Limited to occupancy by agricultural workers, including agri-
30 cultural workers who are retired or disabled, and their immediate

1 **families; and**

2 **“(b) No dwelling unit of which is occupied by a relative of the owner**
3 **or operator of the agriculture workforce housing, except in the case**
4 **of a manufactured dwelling in a manufactured dwelling park nonprofit**
5 **cooperative as defined in ORS 62.803.**

6 **“(4) ‘Agriculture workforce housing project’ means the acquisition,**
7 **construction, installation or rehabilitation of agriculture workforce**
8 **housing.**

9 **“[(2)] (5) ‘Condition of habitability’ means a condition that is in compli-**
10 **ance with:**

11 **“(a) The applicable provisions of the state building code under ORS**
12 **chapter 455 and the rules adopted thereunder; or**

13 **“(b) If determined on or before December 31, 1995, sections 12 and 13,**
14 **chapter 964, Oregon Laws 1989.**

15 **“[(3)] (6) ‘Contributor’ means a person:**

16 **“(a) That acquired, constructed, manufactured or installed [*farmworker*]**
17 **agriculture workforce housing or contributed money to finance [*a***
18 ***farmworker*] an agriculture workforce housing project; or**

19 **“(b) That has purchased or otherwise received via transfer a credit as**
20 **provided in ORS 315.169 (2).**

21 **“[(4)] (7) ‘Eligible costs’ includes acquisition costs, finance costs, con-**
22 **struction costs, excavation costs, installation costs and permit costs and ex-**
23 **cludes land costs.**

24 **“[(5) ‘Farmworker’ means any person who, for an agreed remuneration or**
25 **rate of pay, performs temporary or permanent labor for another in the:]**

26 **“[(a) Production of agricultural or aquacultural crops or products;]**

27 **“[(b) Handling of agricultural or aquacultural crops or products in an un-**
28 **processed stage;]**

29 **“[(c) Processing of agricultural or aquacultural crops or products;]**

30 **“[(d) Planting, cultivating or harvesting of seasonal agricultural crops;**

1 or]

2 “[e] *Forestation or reforestation of lands, including but not limited to the*
3 *planting, transplanting, tubing, precommercial thinning and thinning of trees*
4 *and seedlings, the clearing, piling and disposal of brush and slash and other*
5 *related activities.*]

6 “[6] *‘Farmworker housing’ means housing:*]

7 “[a] *Limited to occupancy by farmworkers, including farmworkers who are*
8 *retired or disabled, and their immediate families; and]*

9 “[b] *No dwelling unit of which is occupied by a relative of the owner or*
10 *operator of the farmworker housing, except in the case of a manufactured*
11 *dwelling in a manufactured dwelling park nonprofit cooperative as that term*
12 *is defined in ORS 62.803.*]

13 “[7] *‘Farmworker housing project’ means the acquisition, construction, in-*
14 *stallation or rehabilitation of farmworker housing.*]

15 “(8)(a) **‘Owner’** means a person that owns [farmworker] **agriculture**
16 **workforce** housing.

17 “(b) **‘Owner’** does not include a person that only has an interest in the
18 **agriculture workforce** housing as a holder of a security interest.

19 “(9) **‘Rehabilitation’** means to make repairs or improvements to a building
20 that improve its livability and are consistent with applicable building codes.

21 “(10) **‘Relative’** means a brother or sister (whether by the whole or by half
22 blood), spouse, ancestor (whether by law or by blood), or lineal descendant
23 of an individual.

24 “(11) **‘Taxpayer’** includes a nonprofit corporation, a tax-exempt entity or
25 any other person not subject to tax under ORS chapter 316, 317 or 318.

26 “**SECTION 20.** ORS 315.164 is amended to read:

27 “315.164. (1) A taxpayer who is the owner or operator of [farmworker]
28 **agriculture workforce** housing is allowed a credit against the taxes other-
29 wise due under ORS chapter 316, if the taxpayer is a resident individual, or
30 against the taxes otherwise due under ORS chapter 317, if the taxpayer is a

1 corporation. The total amount of the credit shall be equal to 50 percent of
2 the eligible costs actually paid or incurred by the taxpayer to complete [*a*
3 *farmworker*] **an agriculture workforce** housing project, to the extent the
4 eligible costs actually paid or incurred by the taxpayer do not exceed the
5 estimate of eligible costs approved by the Housing and Community Services
6 Department under ORS 315.167.

7 “(2) A taxpayer who is otherwise eligible to claim a credit under this
8 section may elect to transfer all or a portion of the credit to a contributor
9 in the manner provided in ORS 315.169.

10 “(3)(a) The credit allowed under this section may be taken for the tax
11 year in which the [*farmworker*] **agriculture workforce** housing project is
12 completed or in any of the nine tax years succeeding the tax year in which
13 the project is completed.

14 “(b) The credit allowed in any one tax year may not exceed 20 percent
15 of the amount determined under subsection (1) of this section.

16 “(4)(a) To claim a credit under this section, a taxpayer must show in each
17 year following the completion of [*a farmworker*] **an agriculture workforce**
18 housing project that the housing continues to be operated as [*farmworker*]
19 **agriculture workforce** housing.

20 “(b) A taxpayer need not make the showing required in paragraph (a) of
21 this subsection if the Housing and Community Services Department waives
22 the requirement after the taxpayer has successfully met the requirement for
23 the first five years after completion of the **agriculture workforce** housing
24 project.

25 “(c) The Housing and Community Services Department shall determine
26 by rule the factors necessary to grant a waiver. Such factors may include a
27 documented decline in a particular area for [*farmworker*] **agriculture**
28 **workforce** housing.

29 “(5) The credit shall apply only to [*a farmworker*] **an agriculture**
30 **workforce** housing project that is located within this state and physically

1 begun on or after January 1, 1990.

2 “(6)(a) A credit may not be allowed under this section unless the taxpayer
3 claiming credit under this section:

4 “(A) Obtains a letter of credit approval from the Housing and Community
5 Services Department pursuant to ORS 315.167; and

6 “(B) Files with the Department of Revenue an annual certification pro-
7 viding that all occupied units for which credit is being claimed are occupied
8 by [*farmworkers, including farmworkers*] **agricultural workers, including**
9 **agricultural workers** who are retired or disabled, and their immediate
10 families.

11 “(b) The certification described under this subsection shall be made on the
12 form and in the time and manner prescribed by the Department of Revenue.

13 “(7) Except as provided under subsection (8) of this section, the credit
14 allowed in any one year may not exceed the tax liability of the taxpayer.

15 “(8) Any tax credit otherwise allowable under this section that is not used
16 by the taxpayer in a particular tax year may be carried forward and offset
17 against the taxpayer’s tax liability for the next succeeding tax year. Any
18 credit remaining unused in the next succeeding tax year may be carried
19 forward and used in the second succeeding tax year, and likewise any credit
20 not used in that second succeeding tax year may be carried forward and used
21 in the third succeeding tax year, and any credit not used in that third suc-
22 ceeding tax year may be carried forward and used in the fourth succeeding
23 tax year, and any credit not used in that fourth succeeding tax year may be

5 project to which the taxpayer otherwise may be entitled under ORS chapter
6 316 or 317 for the year.

7 “(b) The taxpayer’s adjusted basis for determining gain or loss may not
8 be further decreased by any tax credits allowed under this section.

9 “(10) For a taxpayer to receive a credit under this section, the
10 [*farmworker*] **agriculture workforce** housing must:

11 “(a) Comply with all occupational safety or health laws, rules, regulations
12 and standards;

13 “(b) If registration is required, be registered as a farmworker camp with
14 the Department of Consumer and Business Services under ORS 658.750;

15 “(c) Upon occupancy and if an indorsement is required, be operated by a
16 person who holds a valid indorsement as a farmworker camp operator under
17 ORS 658.730; and

18 “(d) Continue to be operated as [*farmworker*] **agriculture workforce**
19 housing for a period of at least 10 years after the completion of the
20 [*farmworker*] **agriculture workforce** housing project, unless a waiver has
21 been granted under subsection (4) of this section.

22 “(11)(a) Pursuant to the procedures for a contested case under ORS
23 chapter 183, the Department of Revenue may order the disallowance of the

14 Department of Revenue immediately shall collect any taxes due by reason
15 of the disallowance and shall have the benefit of all the laws of this state
16 pertaining to the collection of income and excise taxes. An assessment of the

28 “(E) Food wastes collected as provided under ORS chapter 459 or 459A;

29 “(F) Wood debris collected as provided under ORS chapter 459 or 459A;

30 “(G) Wastewater solids; or

1 “(H) Crops grown solely to be used for energy.

2 “(e) ‘Biomass’ does not mean wood that has been treated with creosote,
3 pentachlorophenol, inorganic arsenic or other inorganic chemical compounds
4 or waste, other than matter described in paragraph (d) of this subsection.

5 “(f) ‘Biomass collector’ means a person that collects biomass in Oregon
6 to be used, in Oregon, as biofuel or to produce biofuel.

7 “(g) ‘Canola’ means plants of the genus **Brassica:**

8 “(A) **In which seeds having a high oil content are the primary eco-**
9 **nomically valuable product; and**

10 “(B) **That have a high erucic acid content suitable for industrial**
11 **uses or a low erucic acid content suitable for edible oils.**

12 “[~~(g)~~] (h) ‘Oilseed processor’ means a person that receives agricultural
13 oilseeds and separates them into meal and oil by mechanical or chemical
14 means.

15 “(i) ‘**Willamette Valley**’ means **Clackamas, Linn, Marion,**
16 **Multnomah, Polk, Washington and Yamhill Counties and the portion**
17 **of Benton and Lane Counties lying east of the summit of the Coast**
18 **Range.**

19 “(2) The Director of the State Department of Energy may adopt rules to
20 define criteria, only as the criteria apply to organic biomass, to determine
21 additional characteristics of biomass for purposes of this section.

22 “(3)(a) An agricultural producer or biomass collector shall be allowed a
23 credit against the taxes that would otherwise be due under ORS chapter 316
24 or, if the taxpayer is a corporation, under ORS chapter 317 or 318 for:

25 “(A) The production of biomass in Oregon that is used, in Oregon, as
26 biofuel or to produce biofuel; or

27 “(B) The collection of biomass in Oregon that is used, in Oregon, as
28 biofuel or to produce biofuel.

29 “(b) A credit under this section may be claimed in the tax year in which
30 the credit is certified under subsection (5) of this section.

1 “(c) A taxpayer may be allowed a credit under this section for more than
2 one of the roles defined in subsection (1) of this section, but a biofuel pro-
3 ducer that is not also an agricultural producer or a biomass collector may
4 not claim a credit under this section.

5 “(d) A credit under this section may be claimed only once for each unit
6 of biomass.

7 “(e) Notwithstanding paragraph (a) of this subsection, a tax credit:

8 **“(A) Is not allowed for canola grown, collected or produced in the**
9 **Willamette Valley; and**

10 **“(B) Is not allowed for grain corn, but a tax credit shall be allowed for**
11 **other corn material.**

12 “(4) The amount of the credit shall equal the amount certified under
13 subsection (5) of this section.

14 “(5)(a) The State Department of Energy may establish by rule procedures
15 and criteria for determining the amount of the tax credit to be certified un-
16 der this section, consistent with ORS 469B.403. The department shall provide
17 written certification to taxpayers that are eligible to claim the credit under

19 “(b) The State Department of Energy may charge and collect a fee from
20 taxpayers for certification of credits under this section. The fee may not ex-
21 ceed the cost to the department of determining the amount of certified cost.

22 “(c) The State Department of Energy shall provide to the Department of
23 Revenue a list, by tax year, of taxpayers for which a credit is certified under
24 this section, upon request of the Department of Revenue.

25 “(6) The amount of the credit claimed under this section for any tax year
26 may not exceed the tax liability of the taxpayer.

27 “(7) Each agricultural producer or biomass collector shall maintain the
28 written documentation of the amount certified for tax credit under this sec-
29 tion in its records for a period of at least five years after the tax year in
30 which the credit is claimed and provide the written documentation to the

1 Department of Revenue upon request.

2 “(8) The credit shall be claimed on a form prescribed by the Department
3 of Revenue that contains the information required by the department.

4 “(9) Any tax credit otherwise allowable under this section that is not used
5 by the taxpayer in a particular tax year may be carried forward and offset
6 against the taxpayer’s tax liability for the next succeeding tax year. Any
7 credit remaining unused in the next succeeding tax year may be carried
8 forward and used in the second succeeding tax year, and likewise any credit
9 not used in that second succeeding tax year may be carried forward and used
10 in the third succeeding tax year, and any credit not used in that third suc-
11 ceeding tax year may be carried forward and used in the fourth succeeding
12 tax year, but may not be carried forward for any tax year thereafter.

13 “(10) In the case of a credit allowed under this section:

14 “(a) A nonresident shall be allowed the credit under this section in the
15 proportion provided in ORS 316.117.

16 “(b) If a change in the status of the taxpayer from resident to nonresident
17 or from nonresident to resident occurs, the credit allowed by this section
18 shall be determined in a manner consistent with ORS 316.117.

19 “(c) If a change in the taxable year of the taxpayer occurs as described
20 in ORS 314.085, or if the department terminates the taxpayer’s taxable year
21 under ORS 314.440, the credit allowed under this section shall be prorated
22 or computed in a manner consistent with ORS 314.085.

23 **“SECTION 54. The amendments to ORS 315.141 by section 53 of this**
24 **2013 Act apply to tax years beginning on or after January 1, 2014.**

25 **“SECTION 55. ORS 315.521 is amended to read:**

26 “315.521. (1) There shall be allowed a credit against the taxes that are
27 otherwise due under ORS chapter 316 or, if the taxpayer is a corporation,
28 under ORS chapter 317 or 318, for amounts contributed to a university ven-
29 ture development fund established under ORS 351.697, to the extent the uni-
