

**PROPOSED AMENDMENTS TO  
SENATE BILL 125**

1 On page 1 of the printed bill, line 2, delete the first “and”.

2 In line 3, before the period insert “; and declaring an emergency”.

3 On page 2, delete lines 21 and 22 and insert:

4 **“(p) A statement that active duty servicemembers have a right to**  
5 **stay proceedings under the federal Servicemembers Civil Relief Act**  
6 **and may contact the Oregon State Bar or the Oregon Military De-**  
7 **partment for more information. The statement must include the toll-**  
8 **free telephone numbers for the Oregon State Bar and the Oregon**  
9 **Military Department and the Internet address for the United States**  
10 **Armed Forces Legal Assistance Legal Services Locator website.”.**

11 After line 28, insert:

12 **“SECTION 2. (1) An agency that, prior to the effective date of this**  
13 **2013 Act, provided notice of rights under the federal Servicemembers**  
14 **Civil Relief Act to each party to a contested case under ORS 183.413**  
15 **is not required to provide the specific information described in ORS**  
16 **183.413 (2)(p) in the notice so long as the agency continues to provide**  
17 **notice in the same manner as it was previously provided.**

18 **“(2) An agency that, prior to the effective date of this 2013 Act, had**  
19 **preprinted forms used for providing notice under ORS 183.413 (2) is not**  
20 **required to provide the specific information required in ORS 183.413**  
21 **(2)(p) until the supply of preprinted forms has been exhausted.”.**

22 In line 29, delete “2” and insert “3”.

1 Delete lines 42 and 43 and insert:

2 **“(f) A statement that active duty servicemembers have a right to**  
3 **stay proceedings under the federal Servicemembers Civil Relief Act**  
4 **and may contact the Oregon State Bar or the Oregon Military De-**  
5 **partment for more information. The statement must include the toll-**  
6 **free telephone numbers for the Oregon State Bar and the Oregon**  
7 **Military Department and the Internet address for the United States**  
8 **Armed Forces Legal Assistance Legal Services Locator website.**

9 **“SECTION 4. (1) An agency that, prior to the effective date of this**  
10 **2013 Act, provided notice of rights under the federal Servicemembers**

12 **is not required to provide the specific information described in ORS**

19 In line 44, delete “3” and insert “5”.

20 After line 45, insert:

21 **“SECTION 6. This 2013 Act being necessary for the immediate**  
22 **preservation of the public peace, health and safety, an emergency is**  
23 **declared to exist, and this 2013 Act takes effect on its passage.”.**

24
