

**PROPOSED AMENDMENTS TO
HOUSE BILL 2529**

1 On page 1 of the printed bill, delete lines 5 through 30.

2 On page 2, delete lines 1 through 5 and insert:

3 **SECTION 1.** Section 2, chapter 109, Oregon Laws 2012, is amended to
4 read:

5 **“Sec. 2.** (1) As used in this chapter, ‘employment’ does not include service
6 performed in the operation of [*a passenger motor vehicle that is operated as*
7 *a taxicab or*] a passenger motor vehicle that is operated for nonemergency
8 medical transportation, by a person who has an ownership [*or leasehold*] in-
9 terest in the passenger motor vehicle, for an entity that is operated by a
10 board of owner-operators elected by the members of the entity.

11 “(2) As used in this section[:],

12 “[*(a) ‘Leasehold’ has the meaning given that term in ORS 656.027 (28).*]

13 “[*(b) ‘Passenger motor vehicle that is operated as a taxicab’ means a vehicle*
14 *that:*]

15 “[*(A) Has a passenger seating capacity of at least three persons and not*
16 *more than seven persons;*]

17 “[*(B) On a route that begins or ends in Oregon, is used primarily to*
18 *transport persons;*]

19 “[*(C)(i) Carries passengers for hire when the destination and route traveled*
20 *may be controlled by a passenger and the fare is calculated on the basis of any*
21 *combination of an initial fee, distance traveled or waiting time; or*]

22 “[*(ii) Is in use under a contract to provide specific service to a third party*]

1 *to transport designated passengers to locations selected by the third party;*
2 *and]*

3 “[*D*] *Is not used more than secondarily or incidentally for errand services*
4 *or to transport property, instead of or in addition to transporting passengers.]*

5 “[*c*] ‘passenger motor vehicle that is operated for nonemergency medical
6 transportation’ means a vehicle that:

7 “[*A*] **(a)** Has a passenger seating capacity of at least three persons and
8 not more than seven persons;

9 “[*B*] **(b)** On a route that begins or ends in Oregon, is used primarily to
10 transport persons;

11 “[*C*] **(c)** Provides medical transportation services under contract with
12 or on behalf of a mass transit or transportation district; and

13 “[*D*] **(d)** Is not used more than secondarily or incidentally for errand
14 services or to transport property, instead of or in addition to transporting
15 passengers.

16 “(3) The provisions of this section do not apply to service performed for:

17 “(a) A nonprofit employing unit;

18 “(b) This state;

19 “(c) A political subdivision of this state; or

20 “(d) An Indian tribe.”
