

**PROPOSED AMENDMENTS TO
HOUSE BILL 2896**

1 In line 2 of the printed bill, before the period insert “; and declaring an
2 emergency”.

3 After line 19, insert:

4 **“SECTION 3. (1) The Task Force on Tanning Facilities is estab-
5 lished, consisting of five members appointed as follows:**

6 **“(a) The President of the Senate shall appoint:**

7 **“(A) One member who represents the tanning industry;**

8 **“(B) One member who represents the health care industry; and**

9 **“(C) One member who represents the general public.**

10 **“(b) The Speaker of the House of Representatives shall appoint:**

11 **“(A) One member who represents the tanning industry; and**

12 **“(B) One member who represents the health care industry.**

13 **“(2) The task force shall review and study the regulation of entities
14 doing business in this state as tanning facilities under ORS 453.726 to
15 453.732 and rules adopted by the Oregon Health Authority under ORS
16 453.726 to 453.732.**

17 **“(3) A majority of the members of the task force constitutes a
18 quorum for the transaction of business.**

19 **“(4) Official action by the task force requires the approval of a
20 majority of the members of the task force.**

21 **“(5) The task force shall elect one of its members to serve as
22 chairperson.**

1 **“(6) If there is a vacancy for any cause, the appointing authority**
2 **shall make an appointment to become immediately effective.**

3 **“(7) The task force shall meet at times and places specified by the**
4 **call of the chairperson or of a majority of the members of the task**
5 **force.**

6 **“(8) The task force may adopt rules necessary for the operation of**
7 **the task force.**

8 **“(9) The task force shall report to the Legislative Assembly in the**
9 **manner provided in ORS 192.245 on or before February 1, 2015. As part**
10 **of the report, the task force may make recommendations for legis-**
11 **lation.**

12 **“(10) The Legislative Administrator may employ persons necessary**
13 **for the performance of the functions of the task force. The Legislative**
14 **Administrator shall fix the duties and amounts of compensation of**
15 **these employees. The task force shall use the services of continuing**
16 **legislative staff, without employing additional persons, to the greatest**
17 **extent practicable.**

18 **“(11) All agencies of state government, as defined in ORS 174.111,**
19 **are directed to assist the task force in the performance of its duties**
20 **and, to the extent permitted by laws relating to confidentiality, to**
21 **furnish such information and advice as the members of the task force**
22 **consider necessary to perform their duties.**

23 **“SECTION 4. Section 3 of this 2013 Act is repealed on the date of**
24 **the convening of the 2015 regular session of the Legislative Assembly**
25 **as specified in ORS 171.010.**

26 **“SECTION 5. This 2013 Act being necessary for the immediate**
27 **preservation of the public peace, health and safety, an emergency is**
28 **declared to exist, and this 2013 Act takes effect on its passage.”.**
