SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Excludes certain increases in salary made by employer to pay for insurance coverage from calculation of final average salary for members of Oregon Public Service Retirement Plan.

Provides that retirement allowance or other distribution payable to member of Public Employees Retirement System who is convicted of felony is subject to execution, garnishment, attachment or other process to collect **portion of** money award included in judgment in criminal action.

Modifies options available to members of Legislative Assembly under Public Employees Retirement System.

Provides for expedited review by Supreme Court upon petition by adversely affected party. Declares emergency, effective on passage.

6	EXCLUSION OF PAYMENTS FOR INSURANCE FROM
7	FINAL AVERAGE SALARY

9	SECTION 1. ORS 238A.130 is amended to read:
10	238A.130. (1) Except as provided in subsection (3) of this section, for purposes of the computa-
11	tion of pension program benefits under ORS 238A.125, "final average salary" means whichever of the
12	following is greater:
13	(a) The average salary per calendar year paid to an active member in the three consecutive
14	calendar years of membership that produce the highest average salary, including calendar years in
15	which the member was employed for less than a full calendar year. If the number of consecutive
16	calendar years of active membership before the effective date of retirement of the member is three
17	or less, the final average salary for the member is the average salary per calendar year paid to the
18	member in all of those years, without regard to whether the member was employed for full calendar
19	years.
20	(b) One-third of the total salary paid to an active member in the last 36 calendar months of
21	membership before the effective date of retirement of the member.
22	(2) For the purposes of calculating the final average salary of a member under subsection (1)
23	of this section, the Public Employees Retirement Board shall:
24	(a) Include any salary paid in or for the calendar month of separation from employment;

1 (b) Exclude any salary for any pay period before the first full pay period that is included in the 2 three consecutive calendar years of membership under subsection (1)(a) of this section; and

3 (c) Exclude any salary for any pay period before the first full pay period that is included in the
4 last 36 calendar months of membership under subsection (1)(b) of this section.

5 (3) For purposes of the computation of pension program benefits under ORS 238A.125 of a person 6 employed by a local government as defined in ORS 174.116, "final average salary" means whichever 7 of the following is greater:

8 (a) The average salary per calendar year earned by an active member in the three consecutive 9 calendar years of membership that produce the highest average salary, including calendar years in 10 which the member was employed for less than a full calendar year. If the number of consecutive 11 calendar years of active membership before the effective date of retirement of the member is three 12 or less, the final average salary for the member is the average salary per calendar year earned by 13 the member in all of those years, without regard to whether the member was employed for full cal-14 endar years.

(b) One-third of the total salary earned by an active member in the last 36 calendar months of membership before the effective date of retirement of the member.

17 (4) For the purposes of calculating the final average salary of a member under this section, the 18 salary of the member does not include:

(a) Any amounts attributable to hours of overtime that exceed the average number of hours of
overtime for the same class of employees as established by rule of the Public Employees Retirement
Board. The Oregon Department of Administrative Services shall establish by rule more than one
overtime average for a class of state employees based on the geographic placement of the employees.

(b) Any increases in salary during the last 36 calendar months of membership before the
 effective date of retirement of the member that:

(A) Are made by an employer to pay for insurance coverage previously paid for by the
 employer; and

(B) Are not offered to all employees in the same class of employees as established by rule
of the board under paragraph (a) of this subsection.

29 <u>SECTION 2.</u> The amendments to ORS 238A.130 by section 1 of this 2013 special session 30 Act apply only to increases in salary paid to a member of the pension program of the Oregon 31 Public Service Retirement Plan on or after the effective date of this 2013 special session Act. 32

36 <u>SECTION 3.</u> Section 4 of this 2013 special session Act is added to and made a part of ORS
 37 chapter 238.

<u>SECTION 4.</u> (1) Notwithstanding ORS 238.445, any retirement allowance, pension payment, lump sum payment or other distribution payable under this chapter or ORS chapter 238A to a person convicted of a felony is subject to execution, garnishment, attachment or other process to collect, and may be assigned to satisfy, the portion of a money award described in subsection (2) of this section that is included in a judgment entered in the criminal action as provided in ORS 18.048.

(b) Notwithstanding paragraph (a) of this subsection, contributions made to the plan by
the Legislative Assembly under this subsection may not exceed the maximum allowed by

SECTION 11. Notwithstanding any other provision of this chapter:

23(1) A retired member who has retired as other than a member of the Legislative Assembly and who is thereafter appointed or elected as a member of the Legislative Assembly 24 may elect, by giving the Public Employees Retirement Board written notice, to receive the 25pension provided by this chapter for service as other than a member of the Legislative As-2627sembly, and be an active member as a member of the Legislative Assembly for the purpose of service in the Legislative Assembly. The adjustments described in this 20 subsection shall continue until the account is distributed to the member or forfeited.

(2)(a) The board shall establish an employee account, which shall consist of the employee con tributions made by or on behalf of the member as adjusted under subsection (1) of this section.

(b) The board shall create a separate employee account for a member who becomes an
active member for the purpose of service in the Legislative Assembly under ORS 237.650,
which shall consist of the employee contributions made by or on behalf of the member that
are attributable to the member's legislative service, as adjusted under subsection (1) of this
section.

(3) If the public employer agrees to make employer contributions under ORS 238A.340, the board
shall establish an employer account, which shall consist of the employer contributions made on behalf of the member as adjusted under subsection (1) of this section.

(4) If the board accepts rollover contributions on behalf of the member, the board shall establish
a rollover account, which shall consist of the rollover contributions made by the member as adjusted
under subsection (1) of this section. Contributions and the earnings attributable to the contributions
must be accounted for separately.

(5) The board shall provide an annual statement to each active and inactive member of the program that reflects the amount credited to the accounts established under this section. The statement shall reflect whether the member is vested in the employer account under the provisions of ORS 238A.320.

A member of the Legislative Assembly who is receiving a pension or annuity under ORS 41 238.092 (1)(a) or section 11 (1) of this 2013 special session Act shall be eligible to participate as 42 a retired state officer in one of the group benefit plans described in ORS 243.135 after the member 43 ceases to be a member of the Legislative Assembly if the member applies to the Public Employees' 44 Benefit Board within 60 days after the member ceases to be a member of the Legislative Assembly. 45

1	JUDICIAL REVIEW
2	
3	SECTION 15. (1) Jurisdiction is conferred on the Supreme Court to determine in the
4	manner provided by this section whether this 2013 special session Act breaches any contract
5	between members of the Public Employees Retirement System and their employers, violates
6	any constitutional provision, including but not limited to impairment of contract rights of
7	members of the Public Employees Retirement System under Article I, section 21, of the
8	Oregon Constitution, or Article I, section 10, clause 1, of the United States Constitution, or
9	is invalid for any other reason.
10	(2) A person who is adversely affected by this 2013 special session Act or who will be
11	adversely affected by this 2013 special session Act may institute a proceeding for review by
12	filing with the Supreme Court a petition that meets the following requirements:
13	(a) The petition must be filed within 60 days after the effective date of this 2013 special
14	session Act.
15	(b) The petition must include the following:
16	(A) A statement of the basis of the challenge; and
17	(B) A statement and supporting affidavit showing how the petitioner is adversely af-
18	fected.
19	(3) The petitioner shall serve a copy of the petition by registered or certified mail upon
20	the Public Employees Retirement Board, the Attorney General and the Governor.
21	(4) Proceedings for review under this section shall be given priority over all other mat-
22	ters before the Supreme Court.
23	(5) The Supreme Court shall allow public employers participating in the Public Employees
24	Retirement System to intervene in any proceeding under this section.
25	(6) In the event the Supreme Court determines that there are factual issues in the peti-
26	tion, the Supreme Court may appoint a special master to hear evidence and to prepare re-
27	commended findings of fact.

31	SECTION 16. The unit captions used in this 2013 special session Act are provided only for
32	the convenience of the reader and do not become part of the statutory law of this state or
33	express any legislative intent in the enactment of this 2013 special session Act.

35	EMERGENCY CLAUSE
36	
37	SECTION 17. This 2013 special session Act being necessary for the immediate preserva-
38	tion of the public peace, health and safety, an emergency is declared to exist, and this 2013
39	special session Act takes effect on its passage.
