HB 4084 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 2/10/2014: Directs Department of Community Colleges and Workforce Development to administer grant program for purpose of distributing funds to community colleges to make child care services available to community college students.

HB 4121 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 2/10/2014: Appropriates moneys from General Fund to Department of Community Colleges and Workforce Development for child care expenses of community college students.

HB 4147  
CARRIED OVER FROM 2/10/2014: Requires Governor to appoint to Higher Education Coordinating Commission as voting members one student from community college, one student from Eastern Oregon University, Oregon Institute of Technology, Southern Oregon University or Western Oregon University and one student from University of Oregon, Oregon State University or Portland State University.
