FIRST PUBLIC HEARING: Establishes Task Force on Transportation and Customer Service Efficiency to study customer service performance in Department of Transportation field offices that provide driver and motor vehicle services.

FIRST PUBLIC HEARING: Allows Department of State Lands to make loans from Common School Fund for brownfield redevelopment.

FIRST PUBLIC HEARING: Allows person that uses natural gas or propane in motor vehicle to pay annual special use fuel license fee in lieu of per-gallon tax.
