- HB 4021 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING - Directs public universities to charge nonresident veteran who is graduate student tuition and fees no greater than resident rate if nonresident veteran received either honorable discharge or general discharge under honorable conditions and provides proof of physical presence in Oregon within 12 months of enrollment.
- HB 4022
FIRST PUBLIC HEARING - Requires providers and resellers of cellular service to provide, at request of law enforcement agency, call location information of cellular device for purpose of responding to 9-1-1 emergency call or emergency involving risk of death or serious physical harm.
- HB 4023 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING - Directs Oregon State Lottery Commission to establish lottery game to benefit veterans' education and economic development.
- HB 4031 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING - Transfers State Interoperability Executive Council from Department of Transportation to Oregon Department of Administrative Services.
- HB 4087 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING - Establishes Task Force on School Safety.
