AOCMHP Testimony to House Human Services and Housing
Committee

Regarding HB 4124 - Youth Suicide Intervention and Prevention 2-3-2014

Dear Chair Tomei and Members of the House Human Services and Housing Committee,

I am providing this testimony to support the concept of HB 4124, which focuses on youth who are at risk for attempting suicide due to mental health or substance use problems. I am speaking on behalf of the Association of Oregon Community Mental Health Programs (AOCMHP), which represents directors of county-based Community Mental Health Programs and County Health and Human Services departments.

This is a great opportunity for the Divisions of Public Health and Addictions/Mental Health (AMH) to coordinate efforts on suicide prevention, both at the state and community level, and to target more attention on youth who are likely to be at risk for suicide or self harm. As your local system of care partners, counties and CCOs are committed to working with the Oregon Health Authority on suicide prevention. We would like to recommend that AOCMHP and Coalition of Local Health Officials work with the Oregon Health Authority to implement a collaborative plan coordinated at a State level (AMH and PH) for youth suicide intervention and prevention during the interim.

Additionally, we recommend allocating resources for evidence-based suicide prevention and mental health awareness training and implementation. As an example, thanks to support from AMH, AOCMHP has embarked on a statewide rollout of Youth Mental Health First Aid (MHFA) trainings for instructors and support for the courses they conduct in their communities for adults who work with youth ages 12-18. Attached is the list of 63 Oregon instructors trained in Youth MHFA since November of 2013 through the AOCMHP/AMH training initiative. Our goal is for the instructors to certify 5,000 Mental Health First Aiders across the state by the end of the 13-15 biennium. They will be important agents of change in decreasing stigma in their communities and in preventing suicide by knowing how to help young people who are experiencing mental health

challenges or crises, and by initiating early intervention through trusted adults, peers, and appropriate health care professionals.
