The Oregon Hunger Task Force supports HB 4090, which will allow existing state-allocated grant funds to support new after school meal sites to also be used to support the creation of new summer meal sites across Oregon. This bill also increases the allowable grant amount to \$20,000.

We can all agree that good nutrition is essential for Oregon's children to be healthy, ready to learn and succeed in school and life. Unfortunately, over half of all Oregon students must rely on free or reduced price meals at school get the food they need. School meals fill a big need during the day and for children whose families are struggling to put food on the table, the federally funded At-Risk Afterschool Meals Program (known as the After School Meal and Snack Program in Oregon) and the Summer Food Service Program provide meals in after school enrichment settings during the school year, and in parks, community centers and libraries during summer breaks.

Unfortunately, not all Oregon children and youth have access to meal programs. School districts and community organizations often need help with an initial investment to begin offering meals. In most cases, the federal reimbursement is sufficient to cover the price of food once a program is up and running, but the upfront cost of necessary equipment, staffing and outreach can be prohibitive.

We know that providing support for these programs in the form of grants increases the number of meal sites for children. For several years Partners for a Hunger-Free Oregon has made grants to support summer food programs around the state. In 2013, through private funds, 22 new summer meal sites were started that served 2,142 more children each day. This leveraged nearly \$225,000 in federal funds and supported the creation of 28 new jobs.

HB 4090 will help address childhood hunger and supports our economy by ensuring that our children and youth are getting nutritious food when school is out, which supports their health and keeps them ready to learn. On behalf of the Oregon Hunger Task Force, I urge your support for this bill.

## HB 4090: Summer meal program start-up and expansion grants

The addition of summer food program to existing start-up and expansion grants will provide good nutrition to more children and youth over summer breaks.



Summer meals help our students and our state. We all want Oregon's students to be healthy, active and ready to learn when they return to school. Good nutrition is essential to achieving that.

**The federally funded Summer Food Service Program provides meals to children and youth in low-income areas.**

- **Summer meals help reduce hunger** and increases availability of healthy meals during summer breaks.
- Programs only operate in school areas where 50 percent or more children are eligible for free or reduced price meals at school.
- **In 2013, nearly two million summer meals were served to children** and youth in high need areas.
- Summer meals **generate millions of dollars in economic activity and hundreds of jobs** for school districts and Oregon business.
- Lack of funding limits programs from starting and expanding.

### HB 4090

- Allows the Oregon Department of Education to increase grant level to \$20,000 to for sponsor grantees and adds summer program sponsors to allowable grantee list.
- Increases the availability of nutritious meals to more kids during the summer.
- Supports job growth in Oregon communities.
- The grant program is currently funded through an existing appropriation.
