## **Jurisdictions that amended smokefree air laws to include electronic smoking devices (ESD), outdoor areas noted:**

### **I. U.S. States and other nations with smokefree laws that include ESD:**

- **New Jersey**, 2010 (includes outdoor sf buffer zone by doors, windows, all outdoor school grounds, outdoor school sponsored activities off of school premises, e.g. parks and rec areas).
- **North Dakota**, 2012 (includes outdoor sports arenas: "Sports arena" means an indoor or outdoor place where members of the public assemble to engage in physical exercise, participate in athletic competition, or witness sports or other events. Some examples of sports arenas include sports pavilions, stadiums, gymnasiums, health spas, boxing arenas, swimming pools, roller and ice rinks, and bowling centers.), and 20' smokefree buffer zone by doors, etc.
- **Utah** - 2012
- **Saint-Lo, France**, November 2013 (La Manche region of Normandy)
- **Malta**, 2010

### **II. U.S. Cities, Counties with smokefree laws that include ESD:**

- New York Counties:
  - Cattaraugus, 2012
  - Suffolk, 2009
- California cities:
  - Concord, 2011 (includes 17 block downtown business district, includes outdoors downtown)
  - Petaluma, 2013
- Savannah, GA, 2010 (includes playgrounds, by bleachers, outdoor stadiums, outdoor restaurant seating and 10' therefrom, outdoor service lines, transport platforms and shelters, 10' smokefree buffer zone by entrances, vents, windows)
- Evanston, IL, 2013
- Indianapolis, IN, 2012
- Kentucky cities:
  - Bardstown, 2011
  - Glasgow, 2011
  - Madison County, 2011
- Massachusetts cities:
  - Boston, 2011 ("Smoking shall be prohibited in the workplace. This includes .... patios, decks, yards and loading docks.") 2013 law passed unanimously by City Council to make all city parks smokefree, including a ban on using electronic smoking devices; needs City Parks Commission approval, expected in December 2013)
  - Easthampton, 2014
  - Lowell, 2014
  - Great Barrington, 2012 (includes parks)
  - North Adams, 2012

- North Addleboro, 2010
- Saugus, 2012
- 
- Duluth, MN, 2013
- New Jersey: 37 municipalities and 4 counties ban ESD use in parks/rec areas, including Hudson and Passaic Counties, Clifton, Madison, Maplewood, and Irvington.
- Seattle-King County, Washington State, 2010 (includes 25' smokefree buffer zone by entrances, vents)
- San Francisco Airport Commission - no ecig use in SFA airport – 2010

Chicago's Mayor Emanuel supports amending the city's smokefree law to include a ban on the use of electronic smoking devices. Introduced on 11/26/ 13.

**III. International jurisdictions that ban the sale, importation, and/or use of all ESD:**

- Argentina - bans import, distribution, commercialization, advertising
- Singapore - bans sales, import, distribution
- Brazil - bans sale, import, advertising
- Israel - bans sale, import
- Panama - bans sale, import, distribution
- Jordan - bans importation
- Victoria, Australia - bans sale, use and advertising
- Turkey - bans sale and use
- Hong Kong bans use and sale, unless a pharmaceutical product
- Canada - bans sale, import, advertising if ecigs contain nicotine

11/27/13 – Holland's Ministry of Health calls for studies on health concerns with e-cigarettes.

11/28/13 - European Commission proposes to overturn a vote that rejected outlawing electronic smoking devices in their present form, due to the devices normalizing the action of smoking.
