To Salem Area Legislative Delegation:

The Salem Area Chamber of Commerce continues to be in support of the Columbia River Crossing project despite the latest developments regarding the lack of funding from the State of Washington. Our transportation infrastructure to the north continues to play a vital role in the movement of commerce from and through the Mid-Willamette Valley.

Businesses of all shapes and sizes throughout Oregon rely on a transportation system that allows them to stay competitive in a global marketplace. The health of small businesses throughout Oregon directly correlates with the health of our state. If businesses have a transportation system they can rely upon that allows them to access markets in a competitive fashion, we strengthen our position in the global marketplace and provide more opportunity for Oregonians to find work and support their families.

Traffic forecasting models clearly illustrate the costs of Columbia River Crossing congestion. 15 hours of congestion per day and \$34 million per year in added freight costs by the year 2030 is unacceptable. That is Oregon's reality if we do not move forward with reasonable and practical solutions to address the needs of Oregon's small businesses.

A bottleneck of this significance within Oregon's transportation infrastructure is worth investing in for local economies that rely upon the steady movement of goods and services. As the number one region for agricultural production, the Mid-Willamette valley has a great deal to gain from these improvements.
