Attempt to Locate



The ring shown above was recently stolen in a residential burglary. It is a woman's cocktail ring. It is 14kt yellow gold with a 2 ct Sapphire surrounded by twelve $\frac{1}{4}$ ct diamonds.

NOTE: several other very expensive pieces of jewelry were taken in the burglary including a wedding ring with a 1.5ct diamond center stone and six $\frac{1}{2}$ ct diamonds on each side of the center one. It's soldered to a 12 diamond wedding band. All yellow gold.

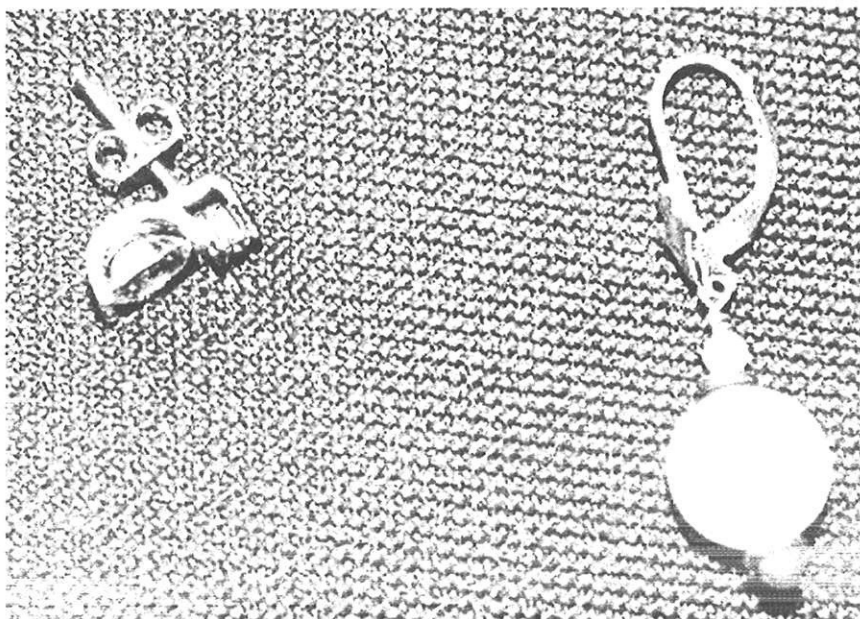

This message is being sent to all Portland Dealers,

This concerns a residential burglary in SE Portland. The attached photo is of two earrings that were left behind by the thieves. The victim provided the following information

The Aquamarine is about $\frac{3}{4}$ carat in a gold setting. There are three small diamonds with a total weight of .06 carats. The necklace looks identical to the earrings, but is on a gold chain.



The photo also shows a fresh water pearl earring set in sterling silver.

The rest of the items taken include:

1. Approximately 12 old silver dollars dated from 1882 to 1906
2. 75 gold \$1 coins
3. A three piece sterling silver salt & pepper set that sits on a silver tray (the 3rd piece)
4. A fresh water pearl necklace that is made up of three strands of pearls that are woven around each other. The clasp is about 1" in diameter.

The items were taken sometime between 6:00 pm Friday, April 26 and 10:30 am April 29th.

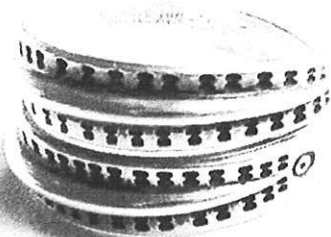
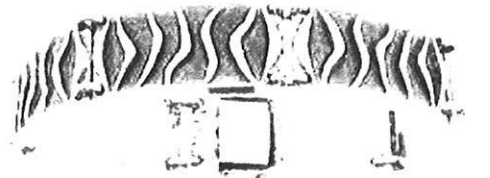
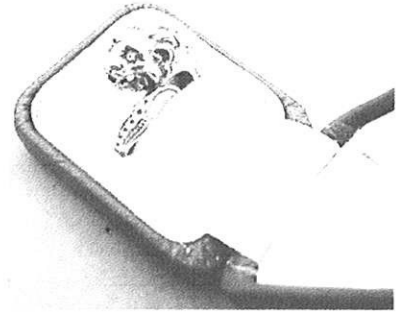
