Revenue Summary

House Bill 4116-B is funded with General Fund.

Summary of Subcommittee Action

House Bill 4116-B directs the Department of Community Colleges and Workforce Development (CCWD) and the Higher Education Coordinating Commission (HECC) to jointly establish a pilot program for distribution of grants to community colleges to increase the number of underserved, low-income and first-generation college-bound students who enroll in community college and make progress toward degree or certificate. The bill appropriates \$750,000 to fund the program.

House Bill 3232 (2013) funded a number of strategic investments designed to target specific programs to improve K-12 education and increase access to post-secondary opportunities, under the direction of the Oregon Education Investment Board. Provisions related to improving community college access and success for first-generation and otherwise underserved students were amended out of the measure before its passage. House Bill 4116-B provides funding to establish a pilot program for these efforts.

CCWD and HECC anticipate additional expenses associated with administering and developing the program and may need to return to the Legislative Assembly to request additional resources depending upon the number of measures passed during the current session that affect their respective budgets.
