APPOINTMENT/CONFIRMATION AUTHORITY: **ORS 680.556**

TERM: Three-year term; March 1, 2014 – February 28, 2017

ECONOMIC INTEREST FILING (ORS 244.050): Not required.

STATUTORY QUALIFICATIONS: **ORS 680.556**

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members
 - Four members who are active licensed denturists (DAHL, HOLDEN, HVASS, MURRAY)
 - One member who is a practicing Oregon licensed dentist (BERG)
 - Two members of the public (COLLVER, CUNNINGHAM)
- Members shall serve three-year terms, may serve two consecutive terms, but a period of three years must pass before a person may be appointed again
- Members are entitled to compensation and expenses

DUTIES AND AUTHORITY: **ORS 680.550**

- Establishes policies and criteria for the assessment and practice of denture technology
