APPOINTMENT/CONFIRMATION AUTHORITY: **ORS 688.160**

TERM: Four-year terms: March 1, 2014 – February 28, 2018

ECONOMIC INTEREST FILING (ORS 244.050): Not required.

STATUTORY QUALIFICATIONS: **ORS 688.160**

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Eight members, who serve four-year terms
 - Five licensed physical therapists, practicing in state for minimum of two years and practicing in field for minimum of five years, active in practice during membership (ALSTOT, **BENSON, CANIZARES, RUTT, SELBST**)
 - One physical therapy assistant (WOOD)
 - Two public members (**COSTALES, SUTTON**)
- All members must be residents of the state, be geographically and ethnically diverse
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement

DUTIES AND AUTHORITY: **ORS 688.160- 688.230**

- Establish matters of policy affecting administration of ORS 688.010 – 688.230 through the Physical Therapy Licensing Board, a semi-independent state agency.
- Enforcement and general supervision over the practice of physical therapy in Oregon.
- Establish policy relating to licensing, examination of physical therapists, standards and tests.
- Keep a register of all licensed physical therapists and assistants and persons holding temporary permits.
- Rulemaking.
- Meet as determined by the board or chairperson.
- Elect chairperson
- Appoint and fix salary of administrator
- Investigate complaints and alleged violations.
