



PLEASE VOTE "YES" ON SB 1541
Reinstates tax credit for crop donations

Fresh food is critical to a healthy diet. We all need it. Without fresh food, our health, quality of life, and productivity could be compromised. Oregon Food Bank wants to increase the amount of fresh food distributed to Oregonians facing hunger, especially for vulnerable populations like seniors and children. Many farmers and producers want to donate crops but the cost of harvesting, transportation, and storage can make a donation cost prohibitive. Many farmers use cash accounting and thus are not eligible for a federal deduction. A state tax credit can fill that gap. It can make the difference for a farmer choosing between donating more and donating at all.

Donating crops and livestock to charities is not free...

It costs just about the same to harvest crops for donations as it does for wholesale. The same inputs are required. Harvesting and transporting large quantities of food, whether its line crops or tree fruit, requires labor, equipment, processing such as cleaning, cold storage, and fuel. The state tax credit for donating crops, created in 1977, expired in 2011.

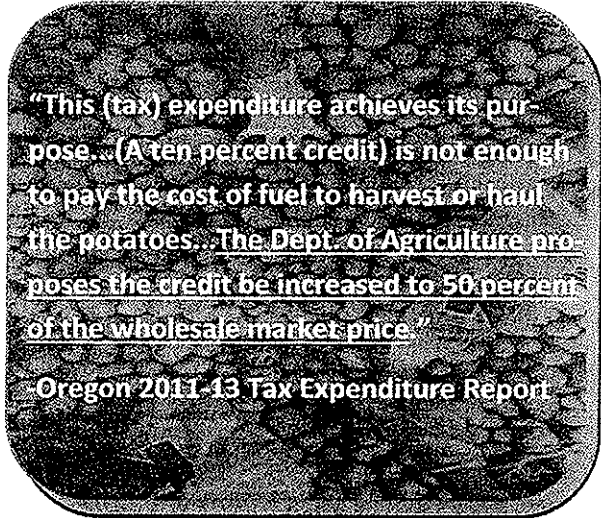
A reinstated and improved tax credit would help Oregon producers partially cover the cost of donating crops and livestock, enabling some to donate more and others to donate for the first time.

Key details of SB 1541

- Oregon farmers and producers would be able to receive a tax credit valued at 15 percent of the wholesale price of the food product to help cover some of the cost of donation.
- Cap: total credit claimed can not exceed total liability and is non-refundable.
- An unused tax credit can be carried forward up to three years.

"Crop" is defined "but is not limited to, bedding plants that produce food, orchard stock intended for the production of food and livestock that may be processed into food for human consumption." (ORS 315-154)

A sample calculation: a farmer donates 5 tons of potatoes (10,000lbs.). If the market price is \$6.50/100 lbs. or \$0.065/lb., then 15 percent of the price of these potatoes is \$0.00975/lb. x 10,000 lbs or \$97.50 in tax credit from a wholesale value of \$650.
