

## HOUSE AMENDMENTS TO HOUSE BILL 4139

By COMMITTEE ON AGRICULTURE AND NATURAL RESOURCES

1 On page 1 of the printed bill, delete lines 4 through 27 and delete page 2 and insert:

2 **“SECTION 1. Oregon State University, in consultation with the State Department of**  
3 **Agriculture, shall develop educational materials regarding the best practices for avoiding**  
4 **adverse effects from pesticides on populations of bees and other pollinating insects. The ed-**  
5 **ucational materials must include, but need not be limited to, measures that pesticide**  
6 **applicators and pesticide trainees can take to protect honeybees and bumblebees. The uni-**  
7 **versity and the department shall design the requirements to ensure that any pesticide**  
8 **applicator applying or supervising the application of a pesticide is knowledgeable regarding**  
9 **alternatives to, the appropriateness of, and precautions for pesticide use that may be**  
10 **injurious to the health of bees and other pollinating insects. The department shall make the**  
11 **educational materials described in this section a part of the education required for taking**  
12 **the pesticide applicator licensing examination under ORS 634.122.**

13 **“SECTION 2. (1) The Task Force on Pollinator Health is established, consisting of 10**  
14 **members appointed as follows:**

15 **“(a) The President of the Senate, after consultation with the Speaker of the House of**  
16 **Representatives, shall appoint one nonvoting member from among members of the Senate.**

17 **“(b) The Speaker of the House of Representatives, after consultation with the President**  
18 **of the Senate, shall appoint one nonvoting member from among members of the House of**  
19 **Representatives who are from a different political party than the member appointed by the**  
20 **President of the Senate.**

21 **“(c) The Governor shall appoint eight voting members as follows:**

22 **“(A) One member who is a university faculty member specializing in the science of**  
23 **pollinator health.**

24 **“(B) One member representing an advocacy group for nurseries and greenhouse produc-**  
25 **ers.**

26 **“(C) One member representing an advocacy group for farmers.**

27 **“(D) One member representing an advocacy group dedicated to the protection of**  
28 **pollinators and invertebrates.**

29 **“(E) One member representing an advocacy group dedicated to environmental protection.**

30 **“(F) One member representing an advocacy group for retailers.**

31 **“(G) One member, who is certified as a master gardener under the Oregon State Uni-**  
32 **versity Master Gardener program, representing the public.**

33 **“(H) One member, who is a beekeeper, representing the public.**

34 **“(2) The task force shall undertake activities to examine issues relevant to pollinator**  
35 **health, including but not limited to:**

1       “(a) Studying proposed and enacted pesticide regulations from other states and countries  
2 that are more protective of pollinator health than the pesticide regulations of the United  
3 States Environmental Protection Agency.

4       “(b) Studying public education and outreach plans regarding pollinator health that have  
5 been successful in other states.

6       “(c) Evaluating the effectiveness of applicator licensing and other legal requirements, and  
7 of incentives, in matters affecting pollinator health.

8       “(d) Identifying possible funding streams for efforts to promote or protect pollinator  
9 health.

10       “(e) Investigating the means used by other states to gather data on populations of bees  
11 or other pollinating insects.

12       “(f) Evaluating existing best management practices for applying neonicotinoids in a  
13 manner that avoids harming pollinating insects.

14       “(3) The task force may take actions necessary and proper to carry out the work of the  
15 task force, including but not limited to scheduling hearings and taking testimony on matters  
16 related to pollinator health.

17       “(4) A majority of the voting members of the task force constitutes a quorum for the  
18 transaction of business.

19       “(5) Official action by the task force requires the approval of five or more voting mem-  
20 bers of the task force.

21       “(6) The task force shall elect one of its voting members to serve as chairperson.

22       “(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-  
23 ment to become immediately effective.

24       “(8) The task force shall meet at times and places specified by the call of the chairperson  
25 or of a majority of the voting members of the task force.

26       “(9) The task force may adopt rules necessary for the operation of the task force.

27       “(10) The task force shall submit a report in the manner provided by ORS 192.245, and  
28 may include recommendations for legislation, to an interim committee of the Legislative  
29 Assembly related to agriculture no later than October 1, 2014. The task force may provide  
30 progress reports to an interim committee related to agriculture prior to October 1, 2014.

31       “(11) The Legislative Administration Committee shall provide staff support to the task  
32 force.

33       “(12) Members of the task force who are not members of the Legislative Assembly are  
34 not entitled to compensation, but may be reimbursed for actual and necessary travel and  
35 other expenses incurred by them in the performance of their official duties in the manner  
36 and amounts provided for in ORS 292.495. Claims for expenses incurred in performing func-  
37 tions of the task force shall be paid out of funds appropriated to the committee for purposes  
38 of the task force.

39       “(13) All agencies of state government, as defined in ORS 174.111, are directed to assist  
40 the task force in the performance of its duties and, to the extent permitted by laws relating  
41 to confidentiality, to furnish such information and advice as the members of the task force  
42 consider necessary to perform their duties.

43       “SECTION 3. Section 2 of this 2014 Act is repealed on the date of the convening of the  
44 2015 regular session of the Legislative Assembly as specified in ORS 171.010.

45       “SECTION 4. This 2014 Act being necessary for the immediate preservation of the public

1 **peace, health and safety, an emergency is declared to exist, and this 2014 Act takes effect**  
2 **on its passage.”**
