

SENATE AMENDMENTS TO SENATE BILL 1514

By JOINT COMMITTEE ON WAYS AND MEANS

March 3

1 On page 1 of the printed bill, line 3, after the first semicolon delete the rest of the line and
2 delete line 4 and insert “amending ORS 390.134; limiting expenditures; and declaring an
3 emergency.”.

4 On page 2, after line 28, insert:

5 “(d) The counties may not use the moneys received under this subsection to supplant moneys
6 otherwise made available to the counties for the acquisition, development, maintenance, care and
7 use of county park and recreation sites.

8 “(e) On or before January 15 of each odd-numbered year regular session of the Legislative As-
9 sembly, the State Parks and Recreation Director and a representative of the directors of county
10 park and recreation sites shall submit a report to the Joint Committee on Ways and Means created
11 by ORS 171.555, or the Joint Interim Committee on Ways and Means, that describes the measurable
12 biennial and cumulative results of county activities and programs financed by moneys transferred
13 to the counties from the registration of travel trailers, campers and motor homes and from recre-
14 ational vehicle trip permits. Notwithstanding ORS 192.230 to 192.250, the report shall be made in a
15 manner as the committee may prescribe.”.

16 On page 4, after line 24, insert:

17 “(d) The counties may not use the moneys received under this subsection to supplant moneys
18 otherwise made available to the counties for the acquisition, development, maintenance, care and
19 use of county park and recreation sites.

20 “(e) On or before January 15 of each odd-numbered year regular session of the Legislative As-
21 sembly, the State Parks and Recreation Director and a representative of the directors of county
22 park and recreation sites shall submit a report to the Joint Committee on Ways and Means created
23 by ORS 171.555, or the Joint Interim Committee on Ways and Means, that describes the measurable
24 biennial and cumulative results of county activities and programs financed by moneys transferred
25 to the counties from the registration of travel trailers, campers and motor homes and from recre-
26 ational vehicle trip permits. Notwithstanding ORS 192.230 to 192.250, the report shall be made in a
27 manner as the committee may prescribe.”.

28 On page 5, delete lines 12 through 14 and insert:

29 “**SECTION 3. (1) Notwithstanding any other law limiting expenditures, the limitation on**
30 **expenditures established by section 2 (4), chapter 669, Oregon Laws 2013, for the biennium**
31 **beginning July 1, 2013, as the maximum limit for payment of expenses from fees, moneys or**
32 **other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal**
33 **funds, collected or received by the State Parks and Recreation Department, for direct ser-**
34 **vices is decreased by \$1,121,258 to offset increased distribution to counties for the acqui-**
35 **sition, development, maintenance, care and use of county park and recreation sites.**

1 **“(2) Notwithstanding any other law limiting expenditures, the limitation on expenditures**
2 **established by section 2 (5), chapter 669, Oregon Laws 2013, for the biennium beginning July**
3 **1, 2013, as the maximum limit for payment of expenses from fees, moneys or other revenues,**
4 **including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or**
5 **received by the State Parks and Recreation Department, for community support and grants**
6 **is increased by \$112,126 for increased distribution to counties for the acquisition, develop-**
7 **ment, maintenance, care and use of county park and recreation sites.**

8 **“(3) Notwithstanding any other law limiting expenditures, the limitation on expenditures**
9 **established by section 3 (4), chapter 669, Oregon Laws 2013, for the biennium beginning July**
10 **1, 2013, as the maximum limit for payment of expenses from lottery moneys allocated from**
11 **the Parks and Natural Resources Fund to the State Parks and Recreation Department, for**
12 **direct services is increased by \$1,121,258.”.**

13 In line 15, delete “5” and insert “4”.
