SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Clarifies statutes regarding maintaining and access to "record of the case" and "supplemental confidential file" in juvenile court proceedings.

Permits persons allowed by court to inspect and obtain copies of record and file **in juvenile court proceedings**. Becomes operative September 30, 2015.

Clarifies records, papers and files in court's record of adoption case that must be excluded from inspection and copying for adoption cases filed on or after January 1, 2014, and for adoption cases filed before January 1, 2014.

Declares emergency, effective on passage.

2 Relating to disclosure of certain court records in proceedings involving children; creating new pro-

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 419A.252 is amended to read:

7 419A.252. As used in this section and ORS 419A.253, 419A.255 and 419A.256:

8 (1) "Person" means an individual, a public body as defined in ORS 174.109 or a tribe that has
9 intervened in a juvenile court proceeding pursuant to the Indian Child Welfare Act (25 U.S.C. 1901
10 et seq.).

11 (2) "Prospective appellate attorney" means an attorney designated by the office of public defense
12 services established under ORS 151.216 to potentially represent a child, ward, youth, youth offender,
13 or a parent or guardian of a child, ward, youth or youth offender, in a juvenile case when the case
14 has been referred to the office of public defense services for appeal.

15 [(3) "Record of the case" or "record of each case":]

16 [(a) Includes but is not limited to:]

17 (3) "**Public defense provider**" means an attorney or a law firm designated by the office
18 of public defense services established under ORS 151.216 to potentially represent a child,
19 ward, youth, youth offender or the parent or guardian of a child, ward, youth or youth
20 offender in a juvenile court proceeding.

21 (4) "**Record of the case**" or "**record of each case,**" whether maintained in paper or elec-
22 tronic form, includes but is not limited to the following and includes records filed in juvenile
23 court proceedings commenced before January 1, 2014, when the records are substantially

19 (2)(a) Reports and other material relating to the child, ward, youth or youth offender's history
20 and prognosis in the **record of the case or the supplemental confidential file** [*or record of the*
21 *case*] are privileged and, except at the request of the child, ward, youth or youth offender, shall be
22 withheld from public inspection **except that inspection is permitted as set forth in subsection**
23 **(1)(b) of this section and paragraph (b) of this subsection. The offer or admission of reports**
24 **and other material in the record of the case or the supplemental confidential file as exhibits**
25 **in a hearing or trial does not waive or otherwise change the privileged status of the reports**
26 **and other material, except for purposes of the hearing or trial in which the reports and other**
27 **material are offered or admitted.** Once offered as an exhibit, reports and other material relating
28 to the child, ward, youth or youth offender's history and prognosis **that were maintained in the**
29 **supplemental confidential file** become part of the record of the case but are subject to paragraph
30 (e) of this subsection.

31 (b) A supplemental confidential file is open to inspection by the following:

29 (c) The supplemental confidential file in cases under ORS 419C.005 may be disclosed to the su-
30 perintendent of the school district in which the youth offender resides or the superintendent's
31 designee.

32 (d) The following are entitled to copies of material maintained in the supplemental confidential
33 file:

34 (A) The judge of the juvenile court and those acting under the judge's direction;

35 (B) Service providers in the case;

36 (C) School superintendents and their designees in cases under ORS 419C.005;

37 (D) Attorneys designated under subsection *[(1)(b)(L)]* **(2)(b)(J)** of this section;

38 (E) The district attorney or assistant attorney general representing a party in the case;

39 (F) The juvenile department;

40 (G) The Department of Human Services;

41 (H) The Oregon Youth Authority; and

42 (I) The court appointed special advocate, and a representative of a CASA Volunteer Program
43 as defined in ORS 458.580, when reasonably necessary for the appointment or supervision of court
44 appointed special advocates.

45 (e) A person that obtains copies of material in the supplemental confidential file pursuant to

1 paragraph (d) of this subsection is responsible for preserving the confidentiality of the material in
2 the supplemental confidential file. A service provider, school superintendent or superintendent's
3 designee who obtains copies of such material shall destroy the copies upon the conclusion of in-
4 volvement in the case.

5 (3) Except as otherwise provided in subsection (5) of this section, no information appearing in
6 the record of the case or in the supplemental confidential file may be disclosed to any person not
7 described in [subsection (2)] **subsections (1)(b) and (2)(b)** of this section, **respectively**, without the
8 consent of the court, except for purposes of evaluating the child, ward, youth or youth offender's
9 eligibility for special education as provided in ORS chapter 343, and no such information may be
10 used in evidence in any proceeding to establish criminal or civil liability against the child, ward,
11 youth or youth offender, whether such proceeding occurs after the child, ward, youth or youth
12 offender has reached 18 years of age or otherwise, except for the following purposes:

13 (a) In connection with a presentence investigation after guilt has been admitted or established
14 in a criminal court.

15 (b) In connection with a proceeding in another juvenile court concerning the child, ward, youth
16 or youth offender or an appeal from the juvenile court.

17 (4)(a) When a person described in subsection (1)(b)(M), (N), (O) or (P) of this section inspects or
18 obtains copies of reports, materials or documents under this subsection or under subsection (1) or
19 (2) of this section, the person may not use or disclose the reports, materials or documents, except:

20 (A) As provided in this subsection or under subsection (1) or (2) of this section;

21 (B) In the juvenile court proceeding for which the reports, materials or documents were sought
22 or disclosed;

23 (C) With the consent of the court; or

24 (D) As provided in ORS 419A.253.

25 (b) Nothing in this section prohibits the district attorney or assistant attorney general repre-
26 senting a party in a juvenile court proceeding, the juvenile department, the Department of Human
27 Services, the Oregon Youth Authority or other parties in the proceeding or their attorneys from
28 disclosing to each other reports, materials or documents described in subsections (1) and (2) of this
29 section if the disclosure is reasonably necessary to perform official duties related to the involvement
30 of the child, ward, youth or youth offender with the juvenile court or the juvenile department. A
31 person to whom reports, materials or documents are disclosed under this subsection is subject to
32 subsection (3) of this section.

33 (5)(a) Information contained in the supplemental confidential file that, in the professional judg-
34 ment of the juvenile counselor, caseworker, school superintendent or superintendent's designee,
35 teacher or detention worker to whom the information in the supplemental confidential file has been
36 provided, indicates a clear and immediate danger to another person or to society shall be disclosed
37 to the appropriate authority and the person who is in danger from the child, ward, youth or youth
38 offender.

39 (b) A person that discloses information under paragraph (a) of this subsection has immunity from
40 any liability, civil or criminal, that might otherwise be incurred or imposed for making the disclo-
41 sure.

42 (c) Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035, 419B.040
43 and 419B.045. The disclosure of information under this subsection does not make the information
44 admissible in any court or administrative proceeding if it is not otherwise admissible.

45 (6) Notwithstanding any other provision of law, and subject to subsection (8) of this section, the

1 following are not confidential and not exempt from disclosure:

2 (a) The name and [*date of birth*] **age** of the youth or youth offender;

3 (b) The basis for the juvenile court's jurisdiction over the youth or youth offender;

4 (c) The date, time and place of any juvenile court proceeding in which the youth or youth
5 offender is involved;

6 (d) The act alleged in the petition that if committed by an adult would constitute a crime if ju-
7 risdiction is based on ORS 419C.005;

8 (e) That portion of the juvenile court order providing for the legal disposition of the youth or
9 youth offender when jurisdiction is based on ORS 419C.005;

10 (f) The names and addresses of the youth or youth offender's parents or guardians; and

11 (g) The register described in ORS 7.020 when jurisdiction is based on ORS 419C.005.

12 (7) Notwithstanding any other provision of law, and subject to subsection (8) of this section,
13 when a youth has been taken into custody under ORS 419C.080, the following information shall be
14 disclosed unless, and only for so long as, there is a clear need to delay disclosure in the course of
15 a specific investigation, including the need to protect the complaining party or the victim:

16 (a) The youth's name and age and whether the youth is employed or in school;

17 (b) The youth offense for which the youth was taken into custody;

18 (c) The name and age of the adult complaining party and the adult victim, unless the disclosure
19 of such information is otherwise prohibited or restricted;

20 (d) The identity of the investigating and arresting agency; and

21 (e) The time and place that the youth was taken into custody and whether there was resistance,
22 pursuit or a weapon used in taking the youth into custody.

23 (8) Except as provided in ORS 419A.300 and 420.048, only the juvenile court and the county ju-
24 venile department may disclose the information under subsections (6) and (7) of this section if the
25 information is subject to disclosure, unless otherwise directed by the court.

26 (9) Nothing in this section limits access to any juvenile court records by an appellate court re-
27 viewing a juvenile court order or judgment. Appellate court rules may establish procedures for ap-
28 pellate court access to juvenile records.

29 **(10) In addition to any other provision in this section, the Judicial Department may per-**
30 **mit county or statewide access to juvenile court records or information by county juvenile**
31 **departments, the Department of Human Services, the Oregon Youth Authority, district at-**
32 **torney offices, the office of the Attorney General, the office of public defense services, pro-**
33 **spective appellate attorneys or public defense providers subject to the following restrictions:**

34 **(a) A prospective appellate attorney or public defense provider granted access under this**
35 **subsection must agree, pursuant to a written agreement with the Judicial Department, to**
36 **access:**

37 **(A) Party information only for purposes of conflicts screening procedures; and**

38 **(B) Other records or information about a client only as reasonably necessary for the**
39 **representation of that client in any juvenile case in which the client is a party, subject to**
40 **applicable state and federal confidentiality laws.**

41 **(b) Any other person or entity granted access under this subsection must agree, pursu-**
42 **ant to a written agreement with the department, to access records or information only as**
43 **authorized and allowed by this section, subject to applicable state and federal confidentiality**
44 **laws.**

45 **(c) The State Court Administrator shall prescribe standards and procedures to implement**

1 **the provisions of this subsection.**

2 **(d) Any person or entity granted access to juvenile court records or information under**
3 **this subsection must preserve the confidentiality of that information as required under this**
4 **section.**

5 [(10)] **(11)** A petition filed under ORS 419B.851 alleging that a child who is a foreign national
6 is within the jurisdiction of the court, or a motion requesting an implementation plan other than
7 return of a ward to the ward's parent, is subject to disclosure to the consulate for the child or
8 ward's country as provided under ORS 419B.851 (3).

9 [(11)] **(12)** Nothing in this section prohibits a guardian appointed under ORS 419B.365 or
10 419B.366 from disclosing or providing copies of letters of guardianship when so required to fulfill the
11 duties of a guardian.

12 [(12)] **(13)** The court shall cooperate in the sharing of information with a court in another state
13 to facilitate an interstate placement of a child or ward.

14 **(14) Nothing in this section prohibits the Chief Justice of the Supreme Court, the Chief**
15 **Judge of the Court of Appeals or a presiding judge from permitting access to juvenile court**
16 **records, including the record of the case and the supplemental confidential file in a juvenile**
17 **court proceeding, or audio or video recordings of a juvenile court proceeding, by researchers**
18 **or evaluators for the purposes of developing statistics and performing analyses or audits on**
19 **the effectiveness, cost and other areas of public interest regarding juvenile court programs**
20 **and activities in accordance with child welfare and juvenile justice state plans and programs**
21 **related to Title IV-B and IV-E of the Social Security Act and to the Child Abuse Prevention**
22 **and Treatment Act (42 U.S.C. 5101 et seq). The Chief Justice shall, by rule or order, establish**
23 **standards and guidelines for the release of juvenile court information for research and eval-**
24 **uation purposes to ensure confidentiality consistent with state and federal law and to pro-**
25 **mote consistent statewide application of this subsection. Statistics and analyses released by**
26 **researchers and evaluators under this subsection may not contain any information that**
27 **identifies any individual person involved in a juvenile court proceeding.**

44 (B) Service providers in the case;

45 (C) School superintendents and their designees in cases under ORS 419C.005;

1 (D) Attorneys designated under subsection [(1)(b)(L)] **(2)(b)(J)** of this section;

2 (E) The district attorney or assistant attorney general representing a party in the case;

3 (F) The juvenile department;

4 (G) The Department of Human Services;

5 (H) The Oregon Youth Authority;

6 (I) The court appointed special advocate, and a representative of a CASA Volunteer Program
7 as defined in ORS 458.580, when reasonably necessary for the appointment or supervision of court
8 appointed special advocates; and

9 (J) Any other person allowed by the court.

10 (e) A person that obtains copies of material in the supplemental confidential file pursuant to
11 paragraph (d) of this subsection is responsible for preserving the confidentiality of the material in
12 the supplemental confidential file. A service provider, school superintendent or superintendent's
13 designee who obtains copies of such material shall destroy the copies upon the conclusion of in-
14 volvement in the case.

15 (3) Except as otherwise provided in subsection (5) of this section, no information appearing in
16 the record of the case or in the supplemental confidential file may be disclosed to any person not
17 described in [subsection (2)] **subsections (1)(b) and (2)(b)** of this section, **respectively**, without the
18 consent of the court, except for purposes of evaluating the child, ward, youth or youth offender's
19 eligibility for special education as provided in ORS chapter 343, and no such information may be
20 used in evidence in any proceeding to establish criminal or civil liability against the child, ward,
21 youth or youth offender, whether such proceeding occurs after the child, ward, youth or youth
22 offender has reached 18 years of age or otherwise, except for the following purposes:

23 (a) In connection with a presentence investigation after guilt has been admitted or established
24 in a criminal court.

25 (b) In connection with a proceeding in another juvenile court concerning the child, ward, youth
26 or youth offender or an appeal from the juvenile court.

27 (4)(a) When a person described in subsection (1)(b)(M), (N), (O) or (P) of this section inspects or
28 obtains copies of reports, materials or documents under this subsection or under subsection (1) or
29 (2) of this section, the person may not use or disclose the reports, materials or documents, except:

30 (A) As provided in this subsection or under subsection (1) or (2) of this section;

31 (B) In the juvenile court proceeding for which the reports, materials or documents were sought
32 or disclosed;

33 (C) With the consent of the court; or

34 (D) As provided in ORS 419A.253.

35 (b) Nothing in this section prohibits the district attorney or assistant attorney general repre-
36 senting a party in a juvenile court proceeding, the juvenile department, the Department of Human
37 Services, the Oregon Youth Authority or other parties in the proceeding or their attorneys from
38 disclosing to each other reports, materials or documents described in subsections (1) and (2) of this
39 section if the disclosure is reasonably necessary to perform official duties related to the involvement
40 of the child, ward, youth or youth offender with the juvenile court or the juvenile department. A
41 person to whom reports, materials or documents are disclosed under this subsection is subject to
42 subsection (3) of this section.

43 (5)(a) Information contained in the supplemental confidential file that, in the professional judg-
44 ment of the juvenile counselor, caseworker, school superintendent or superintendent's designee,
45 teacher or detention worker to whom the information in the supplemental confidential file has been

1 provided, indicates a clear and immediate danger to another person or to society shall be disclosed
2 to the appropriate authority and the person who is in danger from the child, ward, youth or youth

4 (b) A person that discloses information under paragraph (a) of this subsection has immunity from

8 and 419B.045. The disclosure of information under this subsection does not make the information
9 admissible in any court or administrative proceeding if it is not otherwise admissible.

10 (6) Notwithstanding any other provision of law, and subject to subsection (8) of this section, the
11 following are not confidential and not exempt from disclosure:

12 (a) The name and [*date of birth*] **age** of the youth or youth offender;

13 (b) The basis for the juvenile court's jurisdiction over the youth or youth offender;

14 (c) The date, time and place of any juvenile court proceeding in which the youth or youth
15 offender is involved;

16 (d) The act alleged in the petition that if committed by an adult would constitute a crime if ju-
17 risdiction is based on ORS 419C.005;

18 (e) That portion of the juvenile court order providing for the legal disposition of the youth or
19 youth offender when jurisdiction is based on ORS 419C.005;

20 (f) The names and addresses of the youth or youth offender's parents or guardians; and

21 (g) The register described in ORS 7.020 when jurisdiction is based on ORS 419C.005.

22 (7) Notwithstanding any other provision of law, and subject to subsection (8) of this section,
23 when a youth has been taken into custody under ORS 419C.080, the following information shall be
24 disclosed unless, and only for so long as, there is a clear need to delay disclosure in the course of
25 a specific investigation, including the need to protect the complaining party or the victim:

26 (a) The youth's name and age and whether the youth is employed or in school;

27 (b) The youth offense for which the youth was taken into custody;

28 (c) The name and age of the adult complaining party and the adult victim, unless the disclosure
29 of such information is otherwise prohibited or restricted;

30 (d) The identity of the investigating and arresting agency; and

31 (e) The time and place that the youth was taken into custody and whether there was resistance,
32 pursuit or a weapon used in taking the youth into custody.

20 419B.366 from disclosing or providing copies of letters of guardianship when so required to fulfill the

22 [(12)] (13) The court shall cooperate in the sharing of information with a court in another state
23 to facilitate an interstate placement of a child or ward.

24 (14) Nothing in this section prohibits the Chief Justice of the Supreme Court, the Chief
25 Judge of the Court of Appeals or a presiding judge from permitting access to juvenile court
26 records, including the record of the case and the supplemental confidential file in a juvenile
27 court proceeding, or audio or video recordings of a juvenile court proceeding, by researchers
28 or evaluators for the purposes of developing statistics and performing analyses or audits on
29 the effectiveness, cost and other areas of public interest regarding juvenile court programs
30 and activities in accordance with child welfare and juvenile justice state plans and programs

31 **SECTION 6.** ORS 419A.200 is amended to read:

32 419A.200. (1) Except as provided in ORS 419A.190, any person or entity, including, but not lim-
 33 ited to, a party to a juvenile court proceeding under ORS 419B.875 (1) or 419C.285 (1), whose rights
 34 or duties are adversely affected by a judgment of the juvenile court may appeal therefrom. An ap-
 35 peal from a circuit court must be taken to the Court of Appeals, and an appeal from a county court
 36 must be taken to the circuit court.

37 (2) If the proceeding is in the circuit court and no record of the proceedings was kept, the court,
 38 on motion made not later than 15 days after the entry of the court's judgment, shall grant a re-

45 fying or providing copies of a judgment of adoption to the petitioner in an adoption proceeding, to

1 the petitioner's attorney of record or to the Department of Human Services.

2 (10) The provisions of this section do not apply to the disclosure of information under ORS
3 109.425 to 109.507.

4 (11) The court may impose and collect fees for copies and services provided under this section,
5 including but not limited to filing, inspection and research fees.

6 (12) Unless good cause is shown, when the court grants a motion to inspect, copy or otherwise
7 disclose records, papers and files in the court's record of an adoption case, the court shall order a
8 prohibition or limitation on redisclosure of the records, papers and files, or of information contained
9 in the records, papers and files.

10 (13) When inspection, copying or disclosure is allowed under this section, the court may require
11 appropriate and reasonable verification of the identity of the requesting person to the satisfaction
12 of the court.
