## Senate Bill 1579

Sponsored by Senator BATES (Presession filed.)

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Requires certain health plans with prescription drug benefits to cover refills of prescription drugs in accordance with plan for synchronizing refill dates of patient's prescription drugs. Applies to coverage of prescriptions and refills requested on and after January 1, 2015. Declares emergency, effective on passage.

## A BILL FOR AN ACT

- Relating to health insurance; creating new provisions; amending ORS 750.055 and 750.333; and declaring an emergency.
- 4 Be It Enacted by the People of the State of Oregon:
- 5 <u>SECTION 1.</u> Section 2 of this 2014 Act is added to and made a part of the Insurance Code. 6 SECTION 2. (1) As used in this section:
  - (a) "Refill restrictions" means any health plan term or condition that limits how frequently a prescription may be refilled or that imposes a minimum or a maximum number of doses that may be refilled at any one time.
  - (b) "Synchronization plan" means a plan developed by a patient with chronic health conditions, the patient's health practitioner and a pharmacist to align the refill dates for all of the patient's prescription drugs so that all of the drugs may be refilled on the same date.
  - (2) A health benefit plan, as defined in ORS 743.730, and a self-insured health plan, offered by the Public Employees' Benefit Board or the Oregon Educators Benefit Board, that provides coverage of prescription drugs shall reimburse the cost of a refill of any covered drug prescribed in accordance with a synchronization plan even if the refill does not comply with the refill restrictions specified in the health benefit plan or self-insured health plan.
