"(b) Within 45 days of receiving notification under this subsection from

- a university president, the State Board of Higher Education shall [decide whether or not to] take one of the following actions:
- "(A) Endorse the university's decision. If the board endorses the linear linear
- 6 "(B) Refuse to endorse the university's decision.
- "(C) Endorse the university's decision subject to conditions recom-7 mended by the board to the Governor and Legislative Assembly. 8 Subject to any legislation enacted by the Legislative Assembly, a uni-9 versity that is endorsed under this subparagraph will become a uni-10 versity with a governing board in the same manner and under the 11 same time frame, and will function in the same manner, as a univer-12 sity receiving an endorsement from the State Board of Higher Educa-13 tion under subparagraph (A) of this paragraph. 14
  - "(c) If the State Board of Higher Education refuses to endorse the university's decision under paragraph (b)(B) of this subsection, or if the board issues an endorsement with conditions under paragraph (b)(C) of this subsection, the Special Committee on University Governance and Operations established in section 166, chapter 768, Oregon Laws 2013, shall develop proposed legislation, for consideration during the 2015 regular session of the Legislative Assembly, based on the recommended conditions.
  - "[(c)] (d) Upon receiving notification that the State Board of Higher Education has endorsed a university's decision to become a university with a governing board under paragraph (b)(A) or (C) of this subsection, the Governor shall:
- "(A) Inform the President of the Senate, the Speaker of the House of Representatives and the Legislative Counsel that the university will become a university with a governing board; and
  - "(B) Not later than six months after receiving the notification, appoint

- "(3) Notwithstanding section 169, chapter 768, Oregon Laws 2013 [of this 3 2013 Act], if Eastern Oregon University, Oregon Institute of Technology, 4

- versity with a governing board under subsection (2) of this section, the 6
- president of that university shall take over administrative responsibilities for 7
