

**PROPOSED AMENDMENTS TO  
HOUSE BILL 4110**

1 On page 1 of the printed bill, delete lines 5 through 30.

2 On page 2, delete lines 1 through 7 and insert:

3 **“SECTION 2. (1) As used in this section, ‘health benefit plan’ has**  
4 **the meaning given that term in ORS 743.730.**

5 **“(2) Except as provided in subsection (4) of this section, an insurer**  
6 **offering a health benefit plan may not deny reimbursement for any**  
7 **service or supply covered by the plan or cancel the coverage of an in-**  
8 **sured under the plan on the basis that:**

9 **“(a) The insured is in the custody of a county sheriff’s office, if the**  
10 **insured is in custody pending the disposition of charges;**

11 **“(b) The insured receives publicly funded medical care while in the**  
12 **custody of a county sheriff’s office; or**

13 **“(c) The care was provided to the insured by an employee or con-**  
14 **tractor of a county who is qualified to receive reimbursement under**  
15 **the health benefit plan.**

16 **“(3) An insurer shall reimburse a county for the costs of covered**  
17 **services or supplies provided to an insured who is in the custody of the**  
18 **county sheriff’s office, pending the disposition of charges, in an**  
19 **amount that is no less than the amount paid under the insured’s**  
20 **health benefit plan to other out-of-network providers for the same**  
21 **services or supplies.**

22 **“(4) An insurer offering a health benefit plan may:**

1       **“(a) Exclude from any requirements for reporting quality outcomes**  
2 **or performance, any covered services provided to an insured in the**  
3 **custody of a county sheriff’s office;**

4       **“(b) Impose utilization controls under the health benefit plan that**  
5 **apply to services provided to insureds who are not in custody by out-**  
6 **of-network providers, including a requirement for prior authorization;**  
7 **and**

8       **“(c) Impose the requirements for billing and medical coding for**  
9 **covered services provided to an insured in the custody of a county**  
10 **sheriff’s office that the insurer imposes on other providers.**

11       **“(5) This section does not:**

12       **“(a) Impair any right of an employer to remove an employee from**  
13 **coverage under a health benefit plan;**

14       **“(b) Release carriers from the requirement to coordinate benefits**  
15 **for persons who are insured by more than one carrier; or**

16       **“(c) Limit an insurer’s right to rescind coverage in accordance with**  
17 **ORS 743.894.**

18       **“(6) A public body, as defined in ORS 174.109, may not pay health**  
19 **benefit plan premiums on behalf of a person who is in the custody of**  
20 **a county sheriff’s office.”.**
