## PROPOSED AMENDMENTS TO HOUSE BILL 4154

- On page 1 of the printed bill, line 2, after "ORS" insert "238.538, 243.135,

- **"SECTION 2.** ORS 243.135 is amended to read:
- 6 "243.135. (1) Notwithstanding any other benefit plan contracted for and
- 7 offered by the Public Employees' Benefit Board, the board shall contract for
- 8 a health benefit plan or plans best designed to meet the needs and provide
- 9 for the welfare of eligible employees, the state and the local governments.
- In considering whether to enter into a contract for a plan, the board shall
- 11 place emphasis on:
- "(a) Employee choice among high quality plans;
- "(b) A competitive marketplace;
- "(c) Plan performance and information;
- "(d) Employer flexibility in plan design and contracting;
- "(e) Quality customer service;
- "(f) Creativity and innovation;
- "(g) Plan benefits as part of total employee compensation; and
- "(h) The improvement of employee health.
- 20 "(2) The board may approve more than one carrier for each type of plan
- 21 contracted for and offered but the number of carriers shall be held to a
- 22 number consistent with adequate service to eligible employees and their

1 family members.

- "(3) Where appropriate for a contracted and offered health benefit plan, the board shall provide options under which an eligible employee may ararrange coverage for family members.
- "(4) Payroll deductions for costs that are not payable by the state or a local government may be made upon receipt of a signed authorization from the employee indicating an election to participate in the plan or plans selected and the deduction of a certain sum from the employee's pay.
  - "(5) In developing any health benefit plan, the board may provide an option of additional coverage for eligible employees and their family members at an additional cost or premium.
  - "(6) Transfer of enrollment from one plan to another shall be open to all eligible employees and their family members under rules adopted by the board. Because of the special problems that may arise in individual instances under comprehensive group practice plan coverage involving acceptable physician-patient relations between a particular panel of physicians and particular eligible employees and their family members, the board shall provide a procedure under which any eligible employee may apply at any time to substitute a health service benefit plan for participation in a comprehensive group practice benefit plan.
  - "(7) The board shall evaluate a benefit plan that serves a limited geographic region of this state according to the criteria described in subsection (1) of this section.
  - "(8) Notwithstanding ORS 741.310 (1), if a member of the Legislative Assembly elects to enroll in a health benefit plan offered by the board, the member must select a board-approved health benefit plan that is offered through the health insurance exchange administered by the Oregon Health Insurance Exchange Corporation under ORS 741.002.
  - "(9) If the Director of the Department of Consumer and Business Services, an administrator of any division of the department or an

- 2 scribed in ORS 240.212, elects to enroll in a health benefit plan offered
- 3 by the board, the director, administrator or manager must select a

- 7 "292.430. (1) In addition to the annual salaries established as provided in
- 8 ORS 292.907 to 292.930, the Oregon Department of Administrative Services
- 9 may 'pick-up,' assume and pay to the Public Employees Retirement Fund any
- 10 employee contributions, otherwise required by ORS 238.200, for the Governor,
- 11 Secretary of State, State Treasurer, Attorney General, Commissioner of the
- Bureau of Labor and Industries and members of the Legislative Assembly.
- "(2) The department may provide health, dental, life and long-term disa-
- bility insurance without cost to the officers referred to in subsection (1) of

- **"SECTION 8.** ORS 741.201 is amended to read:
- "741.201. (1) The Oregon Health Insurance Exchange Corporation is under the supervision of an executive director appointed by the corporation board of directors. The executive director serves at the pleasure of the board. The executive director shall be paid a salary as prescribed by the board.
- 20 "(2) Before assuming the duties of the office, the executive director shall:
  - "(a) Give to the state a fidelity bond, with one or more corporate sureties authorized to do business in this state, in a penal sum prescribed by the Director of the Oregon Department of Administrative Services, but not less than \$50,000. The premium for the bond shall be paid from an account established under ORS 741.101.
- "(b) Subscribe to an oath that the executive director faithfully and impartially will discharge the duties of the office and that the executive director will support the Constitution of the United States and the Constitution of the State of Oregon. The executive director shall file a copy of the signed oath with the Secretary of State.

- "(3) The executive director has such other powers as are necessary to carry out the duties of the corporation, subject to policy direction by the board.
- "(4) The executive director may employ, supervise and terminate the employment of such staff as the executive director deems necessary. The executive director shall prescribe their duties and fix their compensation, in accordance with the personnel policies adopted by the board. Employees of the corporation may not be individuals who are:

- "[(b) In order to facilitate the development of innovative health benefit plans, the board or the executive director may contract with one or more carin riers to offer to employees of the Oregon Health Insurance Exchange Corpo-
