

**PROPOSED AMENDMENTS TO
HOUSE BILL 4139**

1 On page 1 of the printed bill, delete lines 4 through 27 and delete page
2 2 and insert:

3 **“SECTION 1. Oregon State University, in consultation with the**
4 **State Department of Agriculture, shall develop educational materials**
5 **regarding the best practices for avoiding adverse effects from pesti-**
6 **cides on populations of bees and other pollinating insects. The educa-**
7 **tional materials must include, but need not be limited to, measures**
8 **that pesticide applicators and pesticide trainees can take to protect**
9 **honeybees and bumblebees. The university and the department shall**
10 **design the requirements to ensure that any pesticide applicator ap-**
11 **plying or supervising the application of a pesticide is knowledgeable**
12 **regarding alternatives to, the appropriateness of, and precautions for**
13 **pesticide use that may be injurious to the health of bees and other**
14 **pollinating insects. The department shall make the educational mate-**
15 **rials described in this section a part of the education required for**
16 **taking the pesticide applicator licensing examination under ORS**
17 **634.122.**

18 **“SECTION 2. (1) The Task Force on Pollinator Health is established,**
19 **consisting of 10 members appointed as follows:**

20 **“(a) The President of the Senate, after consultation with the**
21 **Speaker of the House of Representatives, shall appoint one nonvoting**
22 **member from among members of the Senate.**

1 **“(b) The Speaker of the House of Representatives, after consulta-**
2 **tion with the President of the Senate, shall appoint one nonvoting**
3 **member from among members of the House of Representatives who**
4 **are from a different political party than the member appointed by the**
5 **President of the Senate.**

6 **“(c) The Governor shall appoint eight voting members as follows:**

7 **“(A) One member who is a university faculty member specializing**
8 **in the science of pollinator health.**

9 **“(B) One member representing an advocacy group for nurseries and**
10 **greenhouse producers.**

11 **“(C) One member representing an advocacy group for farmers.**

12 **“(D) One member representing an advocacy group dedicated to the**
13 **protection of pollinators and invertebrates.**

14 **“(E) One member representing an advocacy group dedicated to en-**
15 **vironmental protection.**

16 **“(F) One member representing an advocacy group for retailers.**

17 **“(G) One member, who is certified as a master gardener under the**
18 **Oregon State University Master Gardener program, representing the**
19 **public.**

20 **“(H) One member, who is a beekeeper, representing the public.**

21 **“(2) The task force shall undertake activities to examine issues**
22 **relevant to pollinator health, including but not limited to:**

23 **“(a) Studying proposed and enacted pesticide regulations from other**
24 **states and countries that are more protective of pollinator health than**
25 **the pesticide regulations of the United States Environmental Pro-**
26 **tection Agency.**

27 **“(b) Studying public education and outreach plans regarding**
28 **pollinator health that have been successful in other states.**

29 **“(c) Evaluating the effectiveness of applicator licensing and other**
30 **legal requirements, and of incentives, in matters affecting pollinator**

1 **health.**

2 **“(d) Identifying possible funding streams for efforts to promote or**
3 **protect pollinator health.**

4 **“(e) Investigating the means used by other states to gather data on**
5 **populations of bees or other pollinating insects.**

6 **“(f) Evaluating existing best management practices for applying**
7 **neonicotinoids in a manner that avoids harming pollinating insects.**

8 **“(3) The task force may take actions necessary and proper to carry**
9 **out the work of the task force, including but not limited to scheduling**
10 **hearings and taking testimony on matters related to pollinator health.**

11 **“(4) A majority of the voting members of the task force constitutes**
12 **a quorum for the transaction of business.**

13 **“(5) Official action by the task force requires the approval of five**
14 **or more voting members of the task force.**

15 **“(6) The task force shall elect one of its voting members to serve**
16 **as chairperson.**

17 **“(7) If there is a vacancy for any cause, the appointing authority**
18 **shall make an appointment to become immediately effective.**

19 **“(8) The task force shall meet at times and places specified by the**
20 **call of the chairperson or of a majority of the voting members of the**
21 **task force.**

22 **“(9) The task force may adopt rules necessary for the operation of**
23 **the task force.**

24 **“(10) The task force shall submit a report in the manner provided**
25 **by ORS 192.245, and shall include recommendations for legislation, to**
26 **an interim committee of the Legislative Assembly related to agricul-**
27 **ture no later than October 1, 2014. The task force may provide progress**
28 **reports to an interim committee related to agriculture prior to Octo-**
29 **ber 1, 2014.**

30 **“(11) The Legislative Administration Committee shall provide staff**

1 support to the task force.

2 “(12) Members of the task force who are not members of the Leg-
3 islative Assembly are not entitled to compensation, but may be reim-
4 bursed for actual and necessary travel and other expenses incurred by
5 them in the performance of their official duties in the manner and
6 amounts provided for in ORS 292.495. Claims for expenses incurred in
7 performing functions of the task force shall be paid out of funds ap-
8 propriated to the committee for purposes of the task force.

9 “(13) All agencies of state government, as defined in ORS 174.111,
10 are directed to assist the task force in the performance of its duties
11 and, to the extent permitted by laws relating to confidentiality, to
12 furnish such information and advice as the members of the task force
13 consider necessary to perform their duties.

14 “SECTION 3. Section 2 of this 2014 Act is repealed on the date of
15 the convening of the 2015 regular session of the Legislative Assembly
16 as specified in ORS 171.010.

17 “SECTION 4. This 2014 Act being necessary for the immediate
18 preservation of the public peace, health and safety, an emergency is
19 declared to exist, and this 2014 Act takes effect on its passage.”.
