

**PROPOSED AMENDMENTS TO
HOUSE BILL 4015**

1 On page 1 of the printed bill, line 12, delete “Grant or loan” and insert
2 “Grant, loan or incentive”.

3 In line 17, after “charter” insert “, and includes any council of govern-
4 ments created under ORS chapter 190”.

5 After line 17, insert:

6 “(4) ‘Natural resource agency’ means the State Department of Agriculture,
7 the Water Resources Department, the State Department of Fish and Wildlife,
8 the State Forestry Department, the Department of State Lands, the State
9 Department of Geology and Mineral Industries and the State Marine
10 Board.”.

11 In line 18, delete “(4)” and insert “(5)”.

12 In line 21, delete “(5)” and insert “(6)”.

13 Delete lines 23 to 26 and insert:

14 **“SECTION 2.** (1) A state agency listed in section 3 (3) of this 2014 Act
15 will use regional priorities for community and economic development as de-
16 scribed in section 3 of this 2014 Act in considering and prioritizing which
17 projects to undertake in connection with a grant, loan or incentive program.

18 “(2) In making a decision to award moneys to fund projects undertaken
19 in connection with a grant, loan or incentive program for which a state
20 agency listed in section 3 (3) of this 2014 Act would be responsible, the state
21 agency shall consider and prioritize funding decisions based upon whether
22 the project will:

1 “(a) Comply with and not compromise or circumvent existing rules, regu-
2 lations and laws governing the grant, loan or incentive program.”.

3 In line 27, delete “(a)” and insert “(b)” and delete “are similar to and”.

4 In line 30, delete “(b)” and insert “(c)”.

5 On page 2, line 1, delete “(c)” and insert “(d)”.

6 In line 3, delete “(d)” and insert “(e)”.

7 In line 5, delete “(e)” and insert “(f)”.

8 In line 7, delete “(f)” and insert “(g)”.

9 In line 9, delete “(g)” and insert “(h)”.

10 In line 11, delete “grant or loan” and insert “grant, loan or incentive”.

11 After line 15, insert:

12 “(3) Natural resource agencies shall collaborate to develop and deliver a
13 plan to the Governor that describes how natural resource agencies shall
14 participate in regional solutions teams.”.

15 In line 22, delete “carry out” and insert “coordinate”.

16 In line 31, delete “center” and insert “team” and after “a” delete the rest
17 of the line.

18 In line 32, delete “of the”.

19 In line 40, after “committee” insert “to participate as necessary”.

20 On page 3, delete lines 1 through 3 and insert:

21 “(d) The directors and staff of the state agencies listed in paragraph (a)
22 of this subsection and natural resource agencies shall work with regional
23 solutions coordinators and regional solutions teams to fulfill regional prior-
24 ities, in coordination with the office of the Governor.”.
