

**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 4023**

1 On page 2 of the printed A-engrossed bill, delete lines 36 through 45 and
2 delete page 3 and insert:

3 **“SECTION 2. Section 3 of this 2014 Act is added to and made a part
4 of ORS chapter 461.**

5 **“SECTION 3. (1) The Oregon State Lottery Commission shall es-
6 tablish a lottery raffle game:**

7 **“(a) That has a veteran-oriented theme or indicates that the pro-
8 ceeds benefit veterans’ education and economic development related
9 to veterans; and**

10 **“(b) For which the limited sales period for tickets may include
11 Veterans Day.**

12 **“(2) The commission shall separately record and account for the
13 costs and net proceeds of the lottery raffle game described in this
14 section.**

15 **“(3) When transferring net proceeds from the Oregon State Lottery
16 Fund established in ORS 461.530 for deposit in the Administrative
17 Services Economic Development Fund established in ORS 461.540, the
18 commission shall certify to the Joint Committee on Ways and Means
19 established under ORS 171.555 the amount of the transfer that repres-
20 ents the net proceeds of the lottery raffle game described in this sec-
21 tion.**

22 **“(4) The Legislative Assembly shall allocate from the Administra-**

1 tive Services Economic Development Fund an amount equal to the net
2 proceeds of the lottery raffle game described in this section for trans-
3 fer to the Veterans' Lottery Fund established in section 4 of this 2014
4 Act to benefit veterans' education and economic development related
5 to veterans.

6 **"SECTION 4.** The Veterans' Lottery Fund is established in the State
7 Treasury, separate and distinct from the General Fund. Earnings on
8 moneys in the Veterans' Lottery Fund must be credited to the fund.
9 All moneys in the fund are continuously appropriated to the Depart-
10 ment of Community Colleges and Workforce Development for the
11 purposes described in section 5 of this 2014 Act.

12 **"SECTION 5.** The Department of Community Colleges and
13 Workforce Development by rule shall establish a program to provide
14 opportunities for, or facilitate, the education and training of veterans,
15 the creation of jobs for veterans and economic development opportu-
16 nities that benefit veterans.

17 **"SECTION 6.** The Oregon State Lottery Commission shall begin the
18 sale of tickets for the lottery raffle game described in section 3 of this
19 2014 Act on or before July 1, 2015.

20 **"SECTION 7.** (1) As used in this section, 'service' and 'uniformed
21 service' have the meanings given those terms in ORS 659A.082.

22 **"(2)** A private, nonpublic employer may give preference in the hir-
23 ing and promotion of employees to:

24 **"(a)** A person who is performing, or has performed, service in the
25 uniformed service;

26 **"(b)** If a person has performed service in the uniformed service and
27 has been determined by the United States Department of Veterans
28 Affairs to be permanently and totally disabled as the result of enemy
29 action or a service-related accident, the spouse of the person; and

30 **"(c)** The widow or widower of a person who performed service in the

1 **uniformed service.**

2 **“SECTION 8. This 2014 Act being necessary for the immediate**
3 **preservation of the public peace, health and safety, an emergency is**
4 **declared to exist, and this 2014 Act takes effect on its passage.”**
