

**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 1506**

1 On page 6 of the printed A-engrossed bill, line 42, delete “must” and insert
2 “may”.

3 On page 7, line 5, delete “State Council” and insert “Governor”.

4 In line 7, after the period insert “The individual appointed to this position
5 must be a member of the uniformed service. The Department of Education
6 of the State of Oregon shall assist the military family education liaison in
7 the performance of the duties of the position.”.

8 In line 10, after the period insert “The individual appointed to this posi-
9 tion must have experience in the education of military children.”.

10 In line 12, after “Council” insert a period and delete the rest of the line
11 and delete line 13.

12 Delete pages 16 and 17 and insert:

13 **“SECTION 2. (1) If the Interstate Commission levies an annual as-
14 sessment as described in Article XIV of the Interstate Compact on
15 Educational Opportunity for Military Children under section 1 of this
16 2014 Act, the Department of Education shall fund the annual assess-
17 ment.**

18 **“(2) For purposes of funding the annual assessment, the department
19 may accept contributions of funds and assistance from any source,
20 public or private, and agree to conditions placed on the funds not in-
21 consistent with the purposes of the Interstate Compact on Educational
22 Opportunity for Military Children under section 1 of this 2014 Act.**

1 **“ESTABLISHING STATE COUNCIL**

2 **“(Establishment; Qualification of Members)**

3
4 **“SECTION 3. There is established a State Council for Educational**
5 **Opportunity for Military Children, as described in Article VIII of the**
6 **Interstate Compact on Educational Opportunity for Military Children**
7 **under section 1 of this 2014 Act, consisting of the military family ed-**
8 **ucation liaison and the compact commissioner. The Governor may**
9 **appoint other individuals to the state council and shall make a good**
10 **faith effort to ensure that other individuals appointed are individuals**
11 **who are described in Article VIII of the Interstate Compact on Edu-**
12 **cational Opportunity for Military Children under section 1 of this 2014**
13 **Act and who are well informed on the principles of education of mili-**
14 **tary children.**

16 **“(Meetings)**

18 **“SECTION 4. The State Council for Educational Opportunity for**
19 **Military Children shall meet at least once every three months through**
20 **the use of telephone or other electronic means and in accordance with**
21 **ORS 192.610 to 192.690 and 192.672.**

23 **“(Administrative Support)**

25 **“SECTION 5. The Oregon Military Department shall provide ad-**
26 **ministrative support to the State Council for Educational Opportunity**
27 **for Military Children.**

29 **“(Authority to Adopt Policies)**

1 **“SECTION 6. The State Council for Educational Opportunity for**
2 **Military Children may adopt policies to carry out the duties assigned**
3 **to the state council.”.**

4 On page 18, line 3, delete “10” and insert “7”.

5 In line 6, delete “11” and insert “8”.
