

**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 1562**

1 In line 2 of the printed A-engrossed bill, after the semicolon delete the
2 rest of the line and insert “creating new provisions; amending ORS 743A.082;
3 and declaring an emergency.”.

4 After line 18, insert:

5 **“SECTION 2. (1) Each agency of this state shall provide to the**
6 **executive director of the Oregon Health Insurance Exchange Corpo-**
7 **ration, without undue delay, any reports or findings resulting from an**
8 **independent review, investigation or audit of the development, imple-**
9 **mentation or quality control of the health insurance exchange, con-**
10 **ducted on or after October 1, 2013, if the review, investigation or audit**
11 **is contracted for or paid for, in whole or in part, by an agency of this**
12 **state.**

13 **“(2) The Oregon Health Insurance Exchange Corporation board of**
14 **directors or the executive director shall make publicly available and**
15 **upon request to any person, without undue delay, any reports or**
16 **findings:**

17 **“(a) Provided to the executive director under subsection (1) of this**
18 **section.**

19 **“(b) Resulting from an independent review, investigation or audit**
20 **of the development, implementation or quality control of the health**
21 **insurance exchange, conducted on or after October 1, 2013, if the re-**
22 **view, investigation or audit is contracted for or paid for, in whole or**

1 in part, by the corporation.

2 **“SECTION 3.** The executive director of the Oregon Health Insur-
3 **ance Exchange Corporation shall appear before the Interim House**
4 **Committee on Health Care and the Interim Senate Committee on**
5 **Health Care and Human Services, at the first meeting of each com-**
6 **mittee following adjournment sine die of the 2014 regular session of the**
7 **Legislative Assembly, to present an updated business plan for the fu-**
8 **ture of the health insurance exchange. The updated business plan**
9 **must include, but is not limited to:**

10 **“(1) Demographic information about the individuals who have en-**
11 **rolled in qualified health plans through the exchange;**

12 **“(2) The number of individuals enrolled in qualified health plans**
13 **through the exchange who have paid premiums, both subsidized and**
14 **unsubsidized; and**

15 **“(3) Adjustments to the fees and charges described in ORS 741.105,**
16 **or other administrative changes, necessary for the corporation to be**
17 **self-sustaining.**

18 **“SECTION 4.** The amendments to ORS 743A.082 by section 1 of this
19 **2014 Act become operative January 1, 2015.**

20 **“SECTION 5.** Section 3 of this 2014 Act is repealed on the date of
21 **the convening of the 2015 regular session of the Legislative Assembly.**

22 **“SECTION 6.** This 2014 Act being necessary for the immediate
23 **preservation of the public peace, health and safety, an emergency is**
24 **declared to exist, and this 2014 Act takes effect on its passage.”.**
