

**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 1531**

1 On page 1 of the printed A-engrossed bill, delete lines 7 through 14 and
2 insert:

3 **“SECTION 2. (1) Notwithstanding ORS 633.738, the governing body**
4 **of a city or county may adopt ordinances that:**

5 **“(a) Prohibit the establishment of medical marijuana facilities in**
6 **the area subject to the jurisdiction of the city or county; or**

7 **“(b) Regulate or restrict the operation of medical marijuana facili-**
8 **ties that are registered or applying to be registered under ORS 475.314**
9 **in the area subject to the jurisdiction of the city or county.**

10 **“(2) A city or county that adopts an ordinance under this section**
11 **must provide the text and effective date of the ordinance to the**
12 **Oregon Health Authority in a manner prescribed by the authority.”.**

13 On page 2, delete line 11 and insert:

14 **“(b) May not be located at the same address as a marijuana grow site or**
15 **in an area in which a medical marijuana facility may not be located pursuant**
16 **to an ordinance of which the authority has been notified under section 2 of**
17 **this 2014 Act;”.**

18 On page 3, after line 6, insert:

19 **“(8)(a) A registered medical marijuana facility may not transfer any**
20 **tetrahydrocannabinol-infused product that is meant to be swallowed or**
21 **inhaled, unless the product:**

22 **“(A) Is packaged in child-resistant safety packaging that meets standards**

1 established by the authority by rule;

2 “(B) Is packaged in plastic that is four millimeters or greater in thick-
3 ness, is heat sealed and has no tab, dimple, corner or flap that makes opening
4 the package easier; or

5 “(C) If in liquid form, is bottled and sealed with a metal crown cork bottle
6 cap.

7 “(b) A registered medical marijuana facility may not transfer any
8 tetrahydrocannabinol-infused product that is manufactured or packaged in a
9 manner that is attractive to minors, as determined by the authority by
10 rule.”.

11 In line 7, delete “(8)” and insert “(9)”.

12 In line 13, delete “(9)(a)” and insert “(10)(a)”.

13 In line 22, delete “(10)” and insert “(11)”.

14 In line 26, delete “(11)” and insert “(12)(a)”.

15 In line 27, delete “(a)” and insert “(A)”.

16 In line 29, delete “(b)” and insert “(B)”.

17 After line 30, insert:

18 “(b) In adopting rules under subsection (8)(a)(A) of this section, the au-
19 thority shall consider standards established under and pursuant to the fed-
20 eral Poison Prevention Packaging Act.”.
