

**PROPOSED AMENDMENTS TO  
A-ENGROSSED HOUSE BILL 4135**

1 On page 1 of the printed A-engrossed bill, delete lines 5 through 19 and  
2 delete page 2 and insert:

3 **“SECTION 1. (1)(a) The State Chief Information Officer shall advise**  
4 **the executive staff members of state agencies, boards or commissions**  
5 **who have responsibility for developing, acquiring, maintaining or im-**  
6 **plementing information technology resources with respect to:**

7 **“(A) Emerging information technologies and emerging business**  
8 **trends;**

9 **“(B) Current and future information technology issues and oppor-**  
10 **tunities;**

11 **“(C) Strategies to maximize effective and efficient uses of enterprise**  
12 **and shared services technology efforts; and**

13 **“(D) Individual agency, board or commission information technol-**  
14 **ogy plans.**

15 **“(b) In addition to the advisory responsibilities described in para-**  
16 **graph (a) of this subsection, the State Chief Information Officer has**  
17 **the following powers, duties and responsibilities:**

18 **“(A) To identify information technology initiatives that involve**  
19 **participation from more than one state agency, board or commission**  
20 **or that involve all or a significant portion of one state agency’s,**  
21 **board’s or commission’s personnel or resources;**

22 **“(B) To form and lead governance structures and workgroups to**

1 **plan and implement initiatives identified under subparagraph (A) of**  
2 **this paragraph using shared services, and to oversee the implementa-**  
3 **tion of the initiatives;**

4 **“(C) To specify priorities for initiatives identified in subparagraph**  
5 **(A) of this paragraph and verify that the initiatives are implemented**  
6 **according to the specified priorities;**

7 **“(D) To review state agency, board and commission information**  
8 **technology budget proposals;**

9 **“(E) To ensure that individual state agency board and commission**  
10 **information technology plans align with and conform to the Enterprise**  
11 **Information Resources Management Strategy and other state govern-**  
12 **ment information technology strategic plans;**

13 **“(F) To support and maintain this state’s shared services and in-**  
14 **formation technology portfolio; and**

15 **“(G) To evaluate and recommend any necessary adjustments to**  
16 **state agency, board or commission information technology plans, pol-**  
17 **icies or budgets.**

18 **“(c) In undertaking the duties and responsibilities described in**  
19 **paragraph (b) of this subsection, the State Chief Information Officer**  
20 **and executive staff members of state agencies, boards and commis-**  
21 **sions who have responsibility for developing, acquiring, maintaining**  
22 **or implementing information technology resources shall work to pro-**  
23 **vide or assist in providing services that:**

24 **“(A) Enable the executive staff members to gain an informed anal-**  
25 **ysis and understanding of state agency, board or commission business**  
26 **processes that require information technology solutions;**

27 **“(B) Implement cost-effective and efficient acquisition and deploy-**  
28 **ment of products and services; and**

29 **“(C) Rigorously govern, manage and oversee information technol-**  
30 **ogy initiatives.**

1       **“(2) On or before each date on which the Legislative Assembly**  
2 **convenes in regular session, the State Chief Information Officer shall**  
3 **deliver to the Joint Legislative Committee on Information Manage-**  
4 **ment and Technology a report that describes the progress the State**  
5 **Chief Information Officer has made in undertaking the duties and re-**  
6 **sponsibilities specified in this section, the challenges the State Chief**  
7 **Information Officer has faced and the statutory changes or resource**  
8 **allocations that are necessary to support continued or better imple-**  
9 **mentation.”.**

10       On page 3, delete lines 1 through 16.

11       On page 7, line 13, delete “December 31, 2016” and insert “June 30,  
12 2015”.
