PROPOSED AMENDMENTS TO HOUSE BILL 4144

- On page 1 of the printed bill, line 5, after "293.708," insert "293.711,".

- "(9)(a) The department, with the approval of the council, shall adopt a
- 5 budget for the department on a biennial basis using classifications of ex-

- 8 odd-numbered year, the department shall submit the budget to the Legislative

- 18 posed budget to the President of the Senate, the Speaker of the House of
- 19 Representatives and the cochairs of the Joint Committee on Ways and Means
- 20 during the period when the Legislative Assembly is in session, or to the
- 21 cochairs of the Joint Interim Committee on Ways and Means during the in-
- 22 terim period between sessions.

- "(c) The department shall follow generally accepted accounting principles and keep financial and statistical information as necessary to completely and accurately disclose the financial condition and financial operations of the department.
- "(d) The department shall prepare, or cause to be prepared, an annual fi-5 nancial statement of department revenues and expenses and shall make the 6 statement available for public review. The statement must include the annual 7 costs incurred by the department and the council for the management of the 8 investment funds and any other moneys the department is charged by law 9 with investing. The department shall provide a copy of the statement to the 10 council, the Governor and the Legislative Assembly not later than the 180th 11 day after the end of the state fiscal year.". 12

- In line 34, after the period insert "Before appointing a member under this subsection, the Governor shall consult with the State Treasurer regarding the proposed appointee.".

- cost savings for the State of Oregon and the effect of this 2014 Act on
- 2 the performance of the investment funds investment program of the
- 3 department.".
