- Nine members appointed to four-year terms:
  - Three members are residential contractors who primarily work on residential structures or small commercial structures, one of which is engaged in the business of remodeling (**KITCHIN, PATRICK, WARREN**)
  - Two are public members (**LINDSAY, STEWARD**)
  - One is an elected representative of local government (**JONES JR.**)
  - Two are commercial general contractors who primarily work on large commercial structures (**OLSON, BOLSER**)
  - One is a commercial specialty contractor who primarily works on large commercial structures or a residential limited contractor (**WOOD**)
  - One contractor member may be certified as a home inspector
- The six contractor members must be licensed contractors
- Members serve at the pleasure of the Governor and are eligible for reappointment

**DUTIES AND AUTHORITY:**    **ORS 701.215 through 701.295**

- Elect officers
- Rulemaking to carry out the provisions of ORS chapter 701; impose civil penalties
- License construction contractors
- Investigate persons engaged in building/construction industry to determine compliance with ORS Chapter 701; order work stoppages in certain circumstances
- Administer oaths, issue subpoenas, compel attendance of witnesses and the production of evidence, hold hearings and perform other acts to carry out ORS Chapter 701
- Create and maintain a list of contractors and subcontractors who have been determined not to be qualified to hold or participate in a public contract for a public improvement
- Provide reports on the status of contractors to consumers
- Appoint members (including one public or the elected official) as appeal committees
