APPOINTMENT/CONFIRMATION AUTHORITY: ORS 342.930

TERM: Four-year term; July 1, 2016 – June 30, 2020

ECONOMIC INTEREST FILING (ORS 244.050): Not required.

STATUTORY QUALIFICATIONS: ORS 342.930

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Twenty-four members appointed by the Governor; serving at the pleasure of the Governor:
 - Six administrators in common or union high school districts (GUTIERREZ, LAHLEY, MCKAY, PERRY, Vacancy, Vacancy)
 - Six contract teachers (COLEMAN, HUMPHRIES, SCHUFF, SCONCE, STRATTON, Vacancy)
 - Six school board members in common or union high school districts at time of appointment (BLAHM, COSGROVE, GALLINAT, MARBLE, MILLER, NELSON, PURVINE)
 - Six persons not affiliated with common or union high school districts (CROW, JOHNSON, KHAN, MILLS, PENLAND, ROSS, TERDAL)
- One member from each category may be retired prior to appointment if member had been previously employed as administrator or contract teacher in Oregon.
- At least one member from each category above shall be a resident of a district under 1,500 students:
 - JOHNSON- non-affiliated; LAHLEY – administrator; MILLER– school board member; STRATTON – elementary teacher; ROSS – non-affiliated
- One from each category above shall be a resident of a district with 1,500 - 4,500 students:
 - NELSON– school board member; PURVINE– school board member; PERRY – administrator; CROW– non-affiliated; HUMPHRIES – teacher
- One from each category above shall be a resident of a district over 4,500 students:
 - GUTIERREZ – administrator; COLEMAN – teacher; MCKAY – administrator; MARBLE – school board member, MILLS – non-affiliated; PENLAND – non-affiliated; SCHUFF – teacher; SCHULTZ – administrator; TERDAL - non-affiliated; SCONCE – teacher
- Members may serve beyond expired term for purposes specified in ORS 342.930(3)(a)

DUTIES AND AUTHORITY: ORS 342.905, 342.930

- Elect chair and vice-chair
- Adopt rules
- Hear appeals from teachers dismissed by employing school district, to be heard by panel of three members appointed by the Superintendent of Public Instruction
- Conduct contested case hearings in accordance with ORS 183.310 to 183.550; issue subpoenas
