- Eight members appointed to four-year terms:
 - Five members shall be licensed to practice veterinary medicine, surgery, and dentistry in this state (**DAVIS, DEBESS, MAYFIELD, McGEORGE, ROBERTSON**)
 - Two public members (**LARSEN, YATES**)
 - One member shall be a certified veterinary technician (**GOLUB**)
- The Governor may select from a list of five names for each appointment suggested by the Oregon Veterinary Medical Association

DUTIES AND AUTHORITY: **ORS 686.210, 686.240, 686.255, and 686.360 to 686.420, and 686.510**

- Elect board chair
- May appoint executive director
- Adopt rules
- Employ investigator or other employees
- Impose fees
- Investigate complaints
- General supervision of practice of veterinary medicine
- Licensing of animal technicians
- Impose continuing education requirements
- May establish a certified Euthanasia Task Force and may assess application and certification fees against certified euthanasia technicians and their employers
