**DUTIES AND AUTHORITY:** ORS 687.475

- Elect a chairperson
- Develop practice standards
- Consult with the Health Licensing Office to:
  - Determine whether applicants meet the qualifications under ORS 687.405 to 687.495
  - Conduct examinations and grant licenses to qualified applicants
  - Take any act necessary or proper to effect and carry out the duties required of the office by ORS 687.405 to 687.495
  - Adopt rules
  - Accept and expend donations, contributions and grant funds
