#### **Public Hearing**

HB 2975

Specifies that new or increased fees adopted by state agency do not become effective unless approved by Legislative Assembly by law.

HB 3061 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Task Force on Family-Friendly Public Contracting and prescribes membership for task force.

HB 3099 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Transfers duties, functions, powers and responsibilities related to information technology, information resources, information systems, geographic information systems, geographic data, telecommunications and related services from Oregon Department of Administrative Services to State Chief Information Officer.

HB 3262

Requires Oregon transparency website to contain biennial budget of each state agency for advertising purposes and annual expenditures by agency for advertising purposes.

HB 3267

Establishes Federal Funds Commission.

HB 3273

Imposes one-year moratorium on adoption, amendment or repeal of any administrative rule that has fiscal impact on public of \$50,000 or more.

HB 3305

Prohibits utility or service provider that bills residential tenant directly for utility or service to dwelling unit from billing amounts not paid by former tenant to landlord or to subsequent tenant in dwelling unit.

HB 3315

Requires State Department of Fish and Wildlife to recoup costs incurred in providing services to executive department agencies.

SB 358

Modifies time within which state agency that adopts rule must submit copy of adopted rule to Legislative Counsel for review.
