Public Hearing

- SB 358
CARRIED OVER FROM THE 3/31/2015 AGENDA: Modifies time within which state agency that adopts rule must submit copy of adopted rule to Legislative Counsel for review.
- HB 3262
CARRIED OVER FROM THE 3/31/2015 AGENDA: Requires Oregon transparency website to contain biennial budget of each state agency for advertising purposes and annual expenditures by agency for advertising purposes.
- HB 3267
CARRIED OVER FROM THE 3/31/2015 AGENDA: Establishes Federal Funds Commission.
- HB 3273
CARRIED OVER FROM THE 3/31/2015 AGENDA: Imposes one-year moratorium on adoption, amendment or repeal of any administrative rule that has fiscal impact on public of \$50,000 or more.
- HB 2664
Subjects university with governing board, or not-for-profit organization or other entity that university with governing board controls, to certain provisions of Public Contracting Code.
- HB 2987
Removes requirement for contracting agency to hold in account or otherwise reserve moneys for including green energy technology in constructing, reconstructing or performing major renovation on public building if contracting agency determines that including green energy technology is not appropriate.
- HB 3099 **
**Subsequent Referral(s) to Ways and Means
Transfers duties, functions, powers and responsibilities related to information technology, information resources, information systems, geographic information systems, geographic data, telecommunications and related services from Oregon Department of Administrative Services to State Chief Information Officer.

Work Session

- HB 2250
Authorizes Oregon Department of Administrative Services to adopt rules related to electronic fingerprint capture services.
