HB 2198

For the purpose of possible referral to the House Committee On Rules:

Directs Housing and Community Services Department to submit report to interim legislative committees, no later than July 1, 2016, regarding delivery of housing services.

HB 3535

CARRIED OVER FROM THE 4/17/2015 AGENDA: Modifies temporary assistance for needy families program to promote employment and financial stability for families at risk of qualifying for or who qualify for temporary assistance for needy families or who become ineligible for temporary assistance to needy families aid due to employment.

HB 2201 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/17/2015 AGENDA: Establishes task force to study gambling in Oregon and to make recommendation for legislation on regulation of gambling in this state.

HB 2959 **

**Subsequent Referral(s) to Ways and Means

Requires Housing and Community Services Department to dedicate and use portion of moneys deposited in certain housing accounts from County Assessment and Taxation Fund for benefit of county from which fees deposited into fund were charged and collected.

HB 3143

Requires Department of Consumer and Business Services to develop and post on department's website model sign that provides information about help for victims of human trafficking.

HB 3187

Extends terms of office of members of Commission for the Blind.

HB 3292

Requires Oregon Health Authority to identify duties that tourist facility landlord may contractually delegate to tenant renting or leasing tourist facility for certain purposes.

HB 3323

Authorizes type B area agency that serves population of 650,000 or more persons to bring civil action against person who engages in abuse of vulnerable person.

HB 3391 **

**Subsequent Referral(s) to Judiciary

CARRIED OVER FROM THE 4/17/2015 AGENDA: Requires Attorney General to file action on behalf of

Department of Human Services employee for stalking citation or stalking protective order upon request and upon substantiation of facts and evidence of repeated and unwanted contact causing alarm or coercion to employee.

HB 3420 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/17/2015 AGENDA: Directs Housing and Community Services Department, with
advice of State Housing Council and in collaboration with Community Action Partnership of Oregon and
Department of Human Services, to develop, implement and administer Housing First Program for purpose of
providing housing assistance, case management and support services to individuals and families experiencing
homelessness by utilizing continuum of care.

HB 3494

Prohibits landlord from requiring applicant or tenant to declaw or devocalize animal otherwise allowed on premises or to advertise in manner that discourages application from potential applicant with otherwise allowed animal that has not been declawed or devocalized.

HB 3524

CARRIED OVER FROM THE 4/17/2015 AGENDA: Requires state, when selling or disposing of real property, to grant right of first refusal to developers of affordable housing.
